

MEMORANDUM OF UNDERSTANDING BETWEEN DEPARTMENT OF DEFENSE AND DEPARTMENT OF JUSTICE ON OPERATIONS OTHER THAN WAR AND LAW ENFORCEMENT

L General

A. This Memorandum of Understanding (MOU) sets forth an agreement between the Department of Defense (DoD) and Department of Justice (DOJ) to conduct a program to enhance DoD Operations Other Than War (OOTW) and DOJ and other Law Enforcement (LE) operations through a sharing and joint development, to the extent permitted by law, of technology and systems applicable to both.

It is a well-known and prolifically documented fact that such electro-magnetic weaponry exists and has been operational for decades, used by the military and intelligence agencies (including but not limited to FBI, CIA, NSA, DIA DARPA) against persons deemed "dissidents," whistleblowers, journalists and expositors of vital information...
