MASSACHUSETTS

RE: Masks, Distancing, "Vaccine Passports," Denying Service in this Jurisdiction

MASKS, VACCINES, VACCINE PASSPORTS:

- 1. You are under **no lawful authority** to require your employees or your patrons to wear a mask.
- 2. There is **no statutory law** that requires you, your employees or your patrons to wear a mask.
- 3. These are **GUIDELINES** of the State Dept of Public Health, **CONSIDERATIONS** of the CDC.
- 4. The US FDA recognizes Masks as a "Medical Device" and states they are Voluntary.
- 5. NO Public Health body can require nor does require the wearing of masks. "ORDERS" issued by any public figure are being issued in ignorance: Orders to wear masks are unlawful and must be challenged. ALSO: Exemptions to orders or regulations on Masks are protected by <u>Disability Laws</u>.
- 6. Vaccines are Medical Interventions which are not and cannot be mandated because of individual health risks. Vaccine Passports therefore will always be unlawful, fraudulent, and invalid. No business can lawfully demand hazardous medical interventions because of individual health risks.

PREVENTING OR RESTRICTING ENTRY, DENYING SERVICE, DEMANDING 6 FEET OF SEPARATION:

Preventing entry to your establishment (which is open to the public) and denying service to someone not wearing a mask violates these State and Federal laws on discrimination, free movement of an individual and false imprisonment:

- 1. Massachusetts Constitution (<u>https://malegislature.gov/Laws/Constitution</u>)
- 2. US Constitution (<u>1st and 4th Amendments</u>)
- 3. Federal Civil Rights Law (Title 11, Section 2000, <u>42 U.S.C. §2000a, Civil Rights Act of 1964</u>)
- 4. Americans with Disabilities Act (Title III)
- 5. Massachusetts Civil Rights Public Accommodation Law (<u>General Law Part IV, Title I, Chapter 272,</u> Section 92A)

Demanding 6 feet separation and "only 3 people in the lobby" is also **unlawful** since it restricts the movement of individuals and may be construed as false imprisonment.

PUBLIC ACCOMMODATION VERSUS "STORE POLICY"

Declaring this as your "store policy" does not absolve you from your violation of the law.

NO REGULATIONS are "on the books" that require masks, face shields, 6-feet-distancing, plexiglass dividers, restricting the number of people in the lobby, "vaccine passports" and other protocols.

REGULATIONS are the laws created through an administrative law-making procedure to fulfill and carry out STATUTORY law & are part of Massachusetts Code.

Violating the above-mentioned laws while concealing your identity with a face-covering may elevate the criminal charges against you for denying entry to any person in this jurisdiction.
