Dear Delegate:

In the summer of 1988, the International Committee began to study the development of electromagnetic weapons by the United States of America. The term “offensive microwave weapons” comes from a report published in 1982 by the Congressional Clearing House on the Future titled, “Future Agenda”. It presented offensive microwave weapons as a growing threat which would certainly be a hot issue 10 years in the future. In fact, it is now 18 years later and the term offensive microwave weapons is still a mystery to most people.

The young chairman (in 1982) of the obscure Congressional Clearing House was Albert Gore, Jr. So, offensive microwave weapons as a concept should be familiar to most Americans. They are not because Albert Gore, Jr. arrived at the pinnacle of power just in time to suppress discussion of them and grossly expand the number of American citizens under sentence of death in classified medical and scientific research.

Because the International Committee is the only public source of information on obscure, electromagnetic weapons systems, we are frequently approached by persons subjected to classified medical and scientific research who are seeking to validate their own sanity in the face of official ridicule and contempt. Unfortunately in some cases (perhaps 20%) we cannot do that, but we find that most of the people who seek us out are quite credible.

Simply put, physicians and scientists working for the United States Government have succeeded in decoding the system the human body uses to communicate with the brain, and the brain uses to communicate with the neuromusculoskeletal system of the body. In fact, this decoding proved to be remarkably simple once large amounts of money became available to solve the problem under the Central Intelligence Agency’s infamous MKULTRA program and its successor, MKSEARCH.

The decoding problem was an objective of MKULTRA sub-project 119, and biological process control weapons had been tested and evaluated and were operational by 1980. So much for those who say Washington is a sieve and there are no secrets! What was lacking, however, was a system of containment to prevent the escape of unwilling victims of the arbitrary executions and protracted extra-judicial killings which ensued. This problem was solved in 1983 by the theft by the Department of Justice of the PROMIS software developed by INSLAW, Inc., a Washington firm providing electronic data services to the Department. <sup>1</sup>

Essentially, the PROMIS software made it possible to confine the victims of government “experimentation” by tracking the location and value of all of their assets, and the whereabouts of all of their neighbors, family, friends and business/professional associates. In other words, the price of escaping government

“experimentation” became abandoning all of one’s material wealth and abandoning all human relationships established prior to one’s incarceration in the electronic concentration camp system. Suicide is now the only escape from persecution by the United States Government.

The United States Government’s electronic concentration camp system now embraces 500 to 1,000 human beings<sup>2</sup>. Most of them are American citizens or residents, but the United States has not been reluctant to share its biological process control weapons with the English-speaking countries with whose intelligence services it has traditionally exchanged information. Cases of incarceration have come to our attention in the United Kingdom, Canada, Australia and New Zealand. Also, cases of incarceration have come to our attention in countries where American troops are stationed, namely Germany and Japan. Interestingly enough, several cases have also come to our attention in India where cult networks have been turned into drug distribution channels by the Central Intelligence Agency.

Persons incarcerated in the **electronic concentration camp system** are also put to more prosaic uses. The United States has a large and prosperous computer industry. Developing better human-computer interfaces was a problem. **The electronic concentration camp system is the ultimate interface, enabling the imprisonment of a human being in his/her own body.** Next the work shifted to a focus on computers whose output is natural speech. Conversation has always been encouraged, with the victim sitting at home talking out loud to the four walls around him/her, and his handlers replying via the electronic process called synthetic telepathy. Now, of course, these same victims are expressing their fears and hopes to the walls and being answered by a computer programmed to be just as evasive and insulting as their former, human handlers. Presently the emphasis on human “experimentation” within the electronic concentration camp system has shifted to a Manhattan-type project to unlock the secrets of the human mind. The objective is to build a model of the human mind in a computer.<sup>3</sup>

Ultimately, of course, the objective of the electronic concentration camp system is to place the handful of people who shape public opinion under the control of the Central Intelligence Agency, starting with our own Congress and media personalities, then the governments of our allies, and then the governments of our enemies. And it seems to me that the first enemy the United States intends to control is France<sup>4</sup>. Paris is now as completely transparent to American street surveillance as are Washington, D.C. and New York City.

What does this all have to do with the establishment of the International Criminal Court? Precisely this. In the field, arbitrary executions and protracted extrajudicial killings are the work of the military, especially the Air Intelligence Agency at Wright-Patterson AFB. The United States isn’t concerned about American troops on peace-keeping missions; it’s concerned about American troops engaged in activities associated with the electronic concentration camp system. Consequently, U.S. military personnel must be exempt from prosecution by the

<sup>2</sup>These numbers are our own judgment, based on the number of telephone calls and letters received, the frequency at which they are arriving, and the cities they are coming from. The use of these electromagnetic weapons is both widespread and systematic.

<sup>3</sup>We are not certain that a generic model of the human mind can be built. If a specific mind can be modeled, what would be the purpose? The idea is clear enough; to preserve forever the thought processes of the best psychopathic minds available to it so that the Agency can consult them down through the ages.

<sup>4</sup>At the end of World War II, the United States inherited the remnants of Britain’s empire in the Middle East (Palestine, Egypt, Turkey and Greece) and also Britain’s insularity. The French are an unreliable ally and therefore somewhat worse than a certain enemy. Witness the eternal struggle to fully engage Britain in the European Union.

International Criminal Court.

Make no mistake about it as you consider the Elements of Crimes. In the absence of real enemies, the full force of American military strength has been turned against the American people and free people everywhere. The triumph of fascism is nearly complete. There never again will be widespread dissent in America to the wars of the United States Government.

We have estimated elsewhere that 100,000 persons have already died in the United States Government's social cleansing program. However, let us assume that only 10,000 persons have been killed so far. This is far more than all the dead for which President Milosevic and his generals have been indicted by the International Criminal Tribunal at The Hague.

The direction of the United States Government's policies has not only been lethal to tens of thousands of Americans, it may prove to be fatal to the human race itself. Please temper your enthusiasm for reaching a consensus on the Elements of Crimes and the Rules of Evidence with the knowledge that the United States Government is attempting to have you write them in such a way that none of its officials will ever be tried for the crimes against humanity which they are committing, and will continue to commit.

Lastly, we would like to call to your attention a book published since the last Prep Com: "Earth Rising: The Revolution" by Nick Begich and James Roderick, Earthpulse Press, Anchorage, AK. The title is somewhat misleading because 80% of the book is concerned with the technologies enabling the electronic concentration camp system. It is extensively footnoted and will be the last word on the technologies until the United States Government chooses to disclose the crimes it is committing with them.
