Dear All,

Thank you so much Kevin and Prem for arranging "Resolving Insolvency - Reports Launch" at the House of Lords on the 14th of September 2021.

We have provided you with nine reports (attached) which are very simple which show through the Insolvency Practitioners named in the reports, that they have stolen just under £7 billion, we would like you to set a precedent by investigating the Insolvency Practitioners named in these reports to find out where money and assets have gone at their hands..

This has now become a matter of national security as, unless insolvency fraud is stopped across this country, the entrepreneurs and businesspeople will not invest in new business and the British economy will collapse as Insolvency Fraud takes hold and carries on unabated at a major scale across this country. It is, therefore, a matter of great urgency that action is taken to investigate the nine cases below which we have prepared from simple evidence provided by those affected.

Points which can be proven -

1. There are no judgements or debts recorded against those named in the reports;
2. The bankruptcy court documents in all nine cases are all false instruments, hence why there are no judgements or debts recorded against these highly solvent people in these reports; We are also able to provide simple exhibits in support of the reports.

We would, therefore, seek an urgent meeting with yourself and everyone copied into this email.

As stated above, this is now a matter of national security which affects everyone in this country, regardless of class or social standing, but especially the taxpayer. It affects the economic wellbeing of the United Kingdom also. In view of this, we seek a meeting with you by no later than Friday 29 October 2021. Can you please all confirm your time schedules and availability.

The psychological effect this insolvency scam has had on individuals and their families needs to be addressed by these nine cases.

It should be noted that Article 3, European Convention on Human Rights ("the Convention") and Schedule 1, Human Rights Act 1998 ("the Act") forbid torture, degrading and dehumanising treatment.

Section 6(1) of the Act states:-

"it is unlawful for a public authority to act in a way which is incompatible with a person's Convention rights."

BEIS, the Insolvency Service, H M Courts and Tribunals Service are all public authorities and are subject to compliance with the Convention and the Act.

By Section 6(3)(a) of the Act a court or other legally-convened tribunal is a public authority for the purposes of the Act. This means the courts are subject to the Convention and Act also, including the judges which sit in them.
