# Directive for Immediate Cease and Desist of the release of all chemical aerosols by way of cloud seeding and other atmospheric activities.

**Statement of facts:** On, this day of the 8<sup>th</sup> of August 2022, the American State Nationals of The Connecticut Assembly Land and Soil Jurisdiction, issue the following Directive, to immediately Cease and Desist, said actions, having violated the health and well-being of all the people of Connecticut, since 1940's:

- Trespass on the people with unlawful and high levels of aluminum, barium, lithium, sulfuric acid, strontium, manganese, nano scale elements such as graphene oxide and other contaminants including but not limited to NBCs (Nuclear Biological and Chemicals) as well as electromagnetic physical agents;
- Assault the people of Connecticut with these harmful levels of aluminum, barium, lithium, sulfuric acid, strontium, manganese, nano scale elements such as graphene oxide, and other contaminants including but not limited to NBCs (Nuclear Biological and Chemicals) as well as xenobiotic (foreign to life) electromagnetic physical agents; Exhibit A-Rain Water Test
- 3. Abuse with continuous actions;
- 4. Gross violation of the public trust as well as a flagrant breach of the social contract; *Exhibit B Public Trust/Public Employers Directive*
- 5. As well as agencies but not limited to partnering with UN (United Nations), WMO (World Meteorological Organization), Federal Weather Enterprises, GAW(Global Atmosphere Watch), ITU (International Telecommunications Union), NOAA (National Oceanic and Atmospheric Administration), US Department Commerce, National Science Foundation, Governors, CIA, FCC, NATO, American Meteorological Society, NASA, National Science Foundation, and Evergreen, Inc., and their agents and other subcontractors and/or representatives either are releasing as listed in item 1 and other metal incendiary salts on us, our land and our waters; Exhibit D Funding

**You are in violation of all 3 Constitutions.** The Constitutions do not enumerate the power to change and contaminate the air, water, weather and/or land and soil;

**United States Constitution: Amendment X:** "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.";

**Connecticut State Constitution ARTICLE FIRST, SEC. 3**. "The exercise and enjoyment of religious profession and worship, without discrimination, shall forever be free to all persons

in the state; provided, that the right hereby declared and established, shall not be so construed as to excuse acts of licentiousness, or to justify practices inconsistent with the peace and safety of the state";

**Connecticut State Constitution Article First, SEC 16.** "The military shall, in all cases, and at all times, be in strict subordination to the civil power.";

You must come under Public Law, as Public Servants, including but not limited to Federal, State, or Local corporate government(s): We accept your oath of office, Federal statute in 10 U.S.C. § 502, and CT Constitution Sec. 1-25, as your firm and binding contract between you and us, We the People, whereby you have promised to serve, protect, and defend us, guarantee all of our unalienable rights, and defend the Constitution for the united States of America;

In particular, Governor Lamont, as key decision maker according to the 1965 National Science Foundation Weather and Climate Modification, page 12, clearly states the role of the Governor "whether conducted by the Foundation or by other Government agencies or departments, . . . through contracts with, or grants to, private or public institutions or agencies, including but not limited to cooperative programs with any State through such instrumentalities as may be designated by the Governor of such State." (emphasis added) As the Governor of Connecticut, you have a duty to protect the people of Connecticut; Exhibit E, National Science Foundation Weather and Climate Modification

No one — no government, no corporation, no business, no individual or other entity under the sun — has the right to poison us or put toxins in our food, water, medicines, clothing, homes, automobiles, etc. Likewise, no one has the right to injure or harm us through the enforcement of any governmental law or statute, rule or regulation. Neither does any corporate process or procedure, which harms or defrauds, have any legitimacy in law;

Whereas: Scientific evidence shows this assault causes diseases such as asthma, diabetes, chronic illness, respiratory diseases, and more demonstrating violations of the rights of The People; Exhibit F Toxicology of Cloud Seeding

Whereas: Maryland, West Virginia and Pennsylvania banned weather modification including cloud seeding in the 1960s and fined for every occurrence; this clearly demonstrates states autonomy; *Exhibit G, Maryland Ban* 

Whereas; Wireless Telecommunications Facilities, being extremely vulnerable to hacking are simultaneously weaponry, potentially utilized by enemies both foreign and domestic for purposes other than communications (surveillance in violation of the 4th Amendment, weather modification);

Whereas; Wireless Telecommunications Facilities create significant vulnerability to failure of Connecticut's electric grid, and have the potential to cause significant harm to life and property as well as harm to the economy of Connecticut;

Whereas; all Wireless Telecommunications Facilities must meet local safety requirements and the permittee must be insured with a policy from an "A" rated company without a pollution exclusion for environmental contamination such as RF/MW Radiation;

Whereas: This is against international law and against your own treaties, including the ENMOD Treaty. We are not a domestic population with respect to either the British Territorial or Municipal Governments. You are in violation of the ENMOD Treaty and are "testing" your weather weapons-- not against "domestic targets" but against the civilian population of the United States of America, Unincorporated;

Whereas: According to 50 USC 1520 (a) would classify these proceedings as prohibited activities and would require advance consent to the testing. The Secretary of Defense may not conduct (directly or by contract)—

- (1) any test or experiment involving the use of a chemical agent or biological agent on a civilian population; or
- (2) any other testing of a chemical agent or biological agent on human subjects. The Secretary of Defense may conduct a test or experiment described in subsection (b) only if informed consent to the testing was obtained from each human subject in advance of the testing on that subject; as of this writing no one in Connecticut has been given informed consent;

Whereas: These activities may have initially been "classified" as testing however the long term program since the 1940's proves to be operational and consistently if not daily around the globe as standard operations vs testing, making it a violation of 50 SC 1520 (a) and violation of State Constitutions;

#### Provenance and Land and Soil Jurisdiction

Whereas: After 1860, all land interests were entered into Territorial Statehood according to The Northwest Ordinance; <a href="https://www.archives.gov/milestone-documents/northwest-ordinance">https://www.archives.gov/milestone-documents/northwest-ordinance</a> Article 6

Whereas: As of September 2020, all those Territorial States were enrolled officially as States of the Union by those State Assemblies established prior to 1860 entering their unanimous Roll Call Votes upon the Public Record. All now 50 (fifty) States are indeed actual States of the Union, owning all land within their borders and free of any Territorial custodial interest. The Corporations, including incorporated Corporations, which have been established in our names ever since 1860, are all interrelated to associations and charters granted by the Kings and Queens and Popes operating in our names via fraudulent assumption of powers never granted to them, and now all those parent corporations are bankrupt and in receivership to us, their Priority Creditors. Every single one. Any idea that these corporations are free to run rampant is completely wrong-headed. The charter-interest has simply reverted to the actual owners and these corporations, both Territorial and Municipal, are now standing under Public

Law, not private law. If they fail to operate lawfully --- a far higher standard than to merely operate legally -- the corporations will be dissolved, and their officers will be arrested. We hope that everyone is in agreement that living men and women should not be endangered in any way by lifeless, faceless, unaccountable business organizations and entities, which have no right to exist apart from public tolerance;

Whereas: The only lawful and standing government is The United States of America, our Federation of 50 States of the Union that are lawfully Assembled; <a href="https://tasa.americanstatenationals.org/">https://tasa.americanstatenationals.org/</a>

Whereas: All Medical Officers and all General Staff and Reserve and Retired elements of the American Armed Forces, U.S. Armed Forces, UNITED STATES ARMED FORCES, US ARNED FORCES, Hospital Corps, MEDICAL UNITES, Veterans Administration, United States Department of Defense, UN Peacekeepers, DOD Officers, NATO Officers on shore, all elected, appointed, or promoted personnel and there dependents, are required to cease and desist the release of all chemical aerosols by way of cloud seeding and other atmospheric activities being promoted by the Territorial and Municipal United States Governments in Breach of Trust and under False Presumptions of War. Whereas: Each State Assembly is composed of men and women who have properly declared their status as American State Nationals and American State Citizens. We are peaceful, private Americans whose Public Duty is to keep the Peace and Uphold the Public Law; This can be verified through the Public Records: <a href="https://exercity.americanstatenationals.us/">https://exercity.americanstatenationals.us/</a>;

Whereas: The Connecticut Assembly is in session and has accepted The Connecticut State Trust. Connecticut is a State of the Union and a member of The Federation of States operating as The United States of America Unincorporated. It is our Public Duty to uphold the Public Law.

Therefore, each of you have now been lawfully notified and directed to cease and desist by <u>August 20th 2022</u> the release of all toxic chemicals also known as atmospheric aerosol injections. Rebuttal must be in the form of a sworn affidavit under penalty of perjury, addressing point by point, each claim herein.

You must rebut within 10 days of receiving this notice. Failure to rebut indicates your acquiescence to the above claims. Our Fee Schedule, line 21, starts at \$1,000,000,000.00 and will increase based on the timeline of your non-actions. After such time The Connecticut Assembly, will invoice the STATE OF CONNECTICUT, INC and all parties listed above individually, for the assault knowingly being afflicted on the People;

Please note <u>that anyone other</u> than the current or acting individuals listed above that respond to this Directive, is giving their power of attorney and permission to personally lien them as well through the U. S. Treasury per 18 USC 1701 (Obstruction of Mail), 18

USC 1702 (Obstruction of Correspondence), 18 USC 1703 (Delay or Destruction of Mail), and 18 USC 1708 (Theft of Receipt of Stolen Mail). These are also federal offenses punishable by multiple years in prison per code.

This Directive is given by the Assembled Members of The Connecticut Assembly where each county is populated by American State Nationals and American State Citizens.
