**Re: Equity Lawyer Edward William Ellis fraudulently detained in HMP Pentonville**

Mr Edward William Ellis (date of birth 17 September 1952) is the Equity Lawyer who has been managing the Corruption Remedy Process through the Royal Commission and the Coronation Oath Enforcement Authority as has Your Majesty's mother the late Queen Elizabeth II.

The most terrible irony is that Mr Ellis now finds himself detained at "*His Majesty's Pleasure*" in HMP Pentonville. Mr Ellis has been selflessly servicing the Royal Commission and Coronation Oath Enforcement Authority at his own expense and

without remuneration since 2004. He has been wrongly imprisoned because he has presented the corrupt judges with the choice of delivering remedies to corruption victims or committing more frauds and the judges have chosen the latter.

A further irony is that I am writing this on the eve of the day when Your Majesty takes the Coronation Oath to govern according to the statutes of God and Natural Justice and not the statutes of global corporations, greed and narcissism as is currently the case.

Since those committed to prison are detained at the The Monarch's Pleasure then surely The Monarch is at liberty to express "displeasure" if the detention is unwarranted and fraudulent, which it is in the case of Mr Ellis. Therefore the Monarch should make an Order to overturn the wrongful detention.

Moreover Mr Ellis has informed all of us who have offered use of our corruption cases for the Royal Commission that we are all entitled to "Crown Protection". So where is Mr Ellis' Crown Protection please ?

Mr Ellis has serious medical conditions (end stage chronic renal failure) which if not given proper care and attention will rapidly lead to death. Therefore many of Mr Ellis' supporters are regarding his imprisonment as a death sentence and capital punishment was abolished in Your Majesty's Realm many decades ago.
