## Re Edward William Ellis DOB: 17 09/1952. Prisoner Number A4923EY

Equity Lawyer Mr Ellis continues to inform me that his medical needs in respect of **Chronic End Stage Renal Failure** are not being adequately met and that he himself recognises this as your method of murdering him. Those who know Mr Ellis are extremely concerned that the fraudulent custodial sentence is intended to be a death sentence by denying medical treatment for a life-threatening illness.

I am also a victim of a Murder Conspiracy between the GOsC, Bedfordshire Police, MP Nadine Dorries, GP John Lockley and the Law Courts. In my case murder is effected by destroying my livelihood and reputation to force me onto state benefits that fall far short of the cost of living.

I am unable to pay my utility bills nor purchase heating oil because the amount I receive in state benefits nowhere near covers my essential living expenses. I receive less than £600 per month and my utility bill alone is more than £400. I am no longer able to meet these costs and was unable to pay even half of the utility bill for last month. Since April 2013 my utility provider is Utility Warehouse (Account number 7335961) with whom I have my electricity, telephone and internet service. Moreover I have no money for the 2000 litres of heating oil for the winter, home insurance and central heating boiler service. I am also having to spend a lot of money on printing and postage to write to the Home Office etc to get Mr Ellis released from prison.

I am in this situation because in 2006 the General Osteopathic Council (GOsC) decided I am "mentally ill" and unfit to practice because I acted to save someone's life. My phone was blocked in 2006 and 2012 to prevent incoming calls to my osteopathic practice. Mr Ellis traces it back to 1996-7 when I was employed by the pharmaceutical company Pfizer where I included Severe Visual Side-effects of the drug sildenafil (Viagra) in a clinical trial report to be included in the submission dossier for an application to the Medicines Control Agency for a marketing license. Pfizer wanted the side effects left out of the report and I refused to tell lies by omission that would result in harm to millions of men around the world. I was subjected to abuse. Pfizer and I came into conflict which resulted in a forced resignation. Mr Ellis avers that Pfizer considered me to be a Corruption Exposure Risk and wanted me "neutralised". I never had any intention of ever publicizing the side effects. I wanted to close the door on an unpleasant situation and get on with my life but I cannot because I am being constantly sabotaged. One osteopath colleague wrote to the osteopathic press saying that [Julia Spivack] has been "hounded beyond all reason". Another colleague wrote a report to the government about the GOsC regulation being dysfunctional and cited my case as an extreme example. I am being hounded to death when I have done nothing wrong.

Another drug company Merck was discovered to have waged an assault against doctors who criticise their drugs - an internal email had a list of doctors to be "*neutralised*" and the comment "*we will destroy them in their homes*". It is documented that in the USA over 100 osteopaths, chiropractors and holistic doctors have been murdered by staged suicide or mysteriously disappeared.

On 14/01/2006 I was physically assaulted by people sent to my practice to falsely pose as patients and this has caused permanent spinal injury. I have been denied Criminal Injuries Compensation or Disability Benefit. Moreover I have been fraudulently discredited by false criminal records and false mental health diagnoses. For example GP Dr John Lockley entered a diagnosis of Paranoid Psychosis in my NHS medical record but I am not receiving the additional state benefits which accrue to someone given that diagnosis.

I am one of the victims of Ruin Frauds perpetrated by the GOsC against Osteopaths perceived to be a threat to pharmaceutical business. Originally Osteopathy comprises Surgery, Obstetrics and General Practice for all disease. The government have stolen the title Osteopath, given it fraudulent "legal protection", applied it to a limited scope manual therapy that bears no resemblance to the genuine osteopathy and appointed the GOsC as the enforcer.

Mr Ellis and I independently gathered proof of corruption in the GOsC and other profession authorities. I have exhausted all normal avenues of redress but Mr Ellis has expertise of the suppressed Equity Monarchy Trusts which is a Corruption Control Mechanism that Queen Elizabeth II revived and serviced and taught to her son Charles.

The Judgement made by Mr Justice Kerr in respect of *HMs Solicitor General v Ellis* is wholly without substance. Mr Ellis has committed no offence that merits a custodial sentence according to the Home Office website. Mr Ellis is using the Equity Monarchy Trusts to get remedies for victims of state corruption. This same High Court Judge is protecting barrister David Simpson who caused death and harm to osteopaths and patients when he was Head of Legal Affairs at the GOsC.

I gathered proof of harm to patients by the GOsC and took it to Bedfordshire Police. Detective Sergeant 793 Terry Davies investigated and validated my findings. He was satisfied that serious crimes had been committed by the GOsC. When DS Terry Davies sought to proceed to making arrests of staff at the GOsC the investigation was quashed by three Inspectors. I was forcibly dragged out of my home in handcuffs and detained in the secure psychiatric ward at Bedford Hospital. DS Terry Davies was demoted and is no longer with the Force. Mr Kerr is in contempt of his own office which invalidates his jurisdiction.

# I give you seven days from the date of this letter to:

- 1) Release Mr Ellis from prison and financially compensate him for False Arrest and False Imprisonment.
- 2) Payment to myself Julia Spivack, payment to Equity Lawyer Mr Ellis and payment to All Corruption Victims who have offered Use of their Case for the Royal Commission the sum of Two Million British Pounds Sterling (£2million) <u>Interim Damages</u> until such time as Full Damages are settled.

Else I will take this matter to the International Criminal Court (ICC) forthwith.

I will spare none of the lurid details of the origins of the modern pharmaceutical industry in the Nazi death camps funded by the IG Farben cartel, the clear parallels between the treatment of Jews in 1930s Germany and the treatment of Natural Medicine Practitioners in the UK in current times and Rishi Sunak's personal financial interests in the pharmaceutical industry. By the time I have finished you will not be able to show your face in public let alone hold office. You are not fit to be human beings let alone hold positions of authority.

## The Crimes include (to mention a few):

- 1. Use of <u>Secret Death Penalty Without Trial</u> in the UK where the death penalty is illegal.
- 2. Brutal Unilateral war against Innocent Defenceless Citizens by the Pharmaceutical Industry fully aided and abetted by the United Kingdom Prime Minister and High Court Judges.
- 3. Use of Torture for Extremely Prolonged Periods Psychological Torture and Poverty Torture and Physical Torture.
