I am a victim of ongoing UK State Terrorism whilst grieving the murder of another victim of State Terrorism, my late sister, Sadhana Dolly Chaudhari, who froze to death from Breast Cancer on 6th Dec 2018, as a result of agents of British Gas, Richburns, stealing her Gas meter from 450 New North Road Hainault Essex IG6 3EB in 2013, see video links below.

On 19 October 2022, the parent company of British Gas and Centrica, namely Lloyds Banking Group,

raided and robbed the home of my late sister at 450 New North Road Hainault Essex IG6 3EB, whilst it was sub judice in Probate courts, which she intended as a Memorial home for victims of NHS murders, including her late baby (1). I was falsely arrested and made homeless, causing my near death in police custody, with police escort to Accident and Emergency hospital.

The Executor on the Will, Edward Ellis, was given an Extra-Judicial "death sentence", kidnapped from Civil courts at Royal Courts of Justice building by Lord Justice Coulson

and Lord Justice Lewison, on 3rd May 2023 on behalf of Ex Solicitor General Michael Ellis and Ex Attorney General Geoffrey Cox, on behalf of Lloyds banking group. He is in Pentonville prison, Prisoner A4923EY being denied end stage kidney dialysis to end his life.

You are mandated under

international Law Crime (International Cooperation) Act 2003
(Anti-Terrorism Law)

to dissolve the above Fraudulent Trading including various energy companies for Mass Murder, State Terrorism, Money Laundering, HUMAN TRAFFICKING & FRAUDULENT TRADING

in contempt of [2020] EWCA Crim 369,

see attached,

which deemed the UK Government and its banks as dissolved, unfit for purpose during the investigation period 2007 to 2017 against Lloyd Banking Group, Halifax Bank of Scotland, related to Centrica & British Gas, see attached Statements from Crime Commissioner, Anthony Stansfeld, FCA, Criminal Appeals Court judgement [2020] EWCA Crim 369 and Report 206 to investigate suspicious deaths of Indians abroad.

In 2013, my late sister's home was raided by agents of British Gas, who forcibly removed her Gas meter, aided and abetted by Metropolitan Police, whilst she was severely disabled, causing her to develop breast cancer, and her death in December 2018.

The lender, Halifax, committed mortgage Deed Frauds, from 17 Dec 2003 to date and ongoing, took possession of the address 450 New North Road IG6 3EB on 19 October 2022, fraudulently trading as Halifax Bank of Scotland, in contempt of its own criminal prosecutions in 2007-2017, see attached.

I hereby dissolve UK banks, UK Government and UK corporations in my claim on behalf of humanity, for Fraudulent Trading, Induced Poverty and Slavery, Extortion, Mass Murders and Treason

with seizures of all assets of British banks, corporations and Energy companies since 17 Dec 2003 to date and ongoing,

To be transferred into the Estate of Late Sadhana Dolly Chaudhari, which is under the jurisdiction of 18th Law Commission of India Report 206, attached,

together with the death investigation into her late baby, Sunaina Chaudhari, gang raped under a protection order and arrest warrant.

GDPR – Right of Access Request (*also known as Subject Access Request/DSAR*)

Thank you for your email requesting a Subject Access Request.

What we require from you to proceed:

We are required to use all reasonable measures to verify the identity of anyone requesting access to their data. This helps us keep your data safe from unauthorised access. In order to verify your identity against the information held against your account we require from you:

- A document from Column A from the identification verification document attached.

The information you send to us is deleted once we have validated your identity and is only used for this purpose. Until we can confirm your identity, we are unable to act on your request.

Useful information to provide to us to enable the most accurate and fastest response:

- For us to use our file transfer service we require a mobile telephone number so that when we have completed the request, we can send a password with a code in order to access the link that we send to you – from this link you can download your data.
- To ensure we can locate all of your data, please provide us with a full list of all addresses where you have held products and services.
- If you could specify if there is specific data that you are looking for; i.e. Hive or Debt Collection Agency data.
- If there are any other named parties on the account/s and you require the information that is held against them then we will also need their ID documents in order to proceed.
- It would be very helpful for us to understand the reason that you are making this request so that we can continue to look for ways to improve our company's processes and help to make being a customer of ours a better experience.

Next steps:

Our verification step is required by us to ensure that we verify the identity of those making the request before responding and to ensure that we do not unlawfully disclose any personal or sensitive data.

On receipt of the identification documentation, we will respond to you acknowledging receipt of the request and confirm when you can expect to receive a response from us.

We hope this clarifies our position and we look forward to hearing from you shortly.
