I am enclosing the letter mailed yesterday to Dr. Subha Thiagarajan at her Littleton address which may have changed to the Acton address above, and am as well re-sending this letter (enclosed) for purposes of informing all named here, in your professional capacity, of the matters described herein.

I am a Writer and Journalist who has been falsely characterized as mentally ill with a number of false psychiatric labels placed on me over a period of 10 years, from December 2013 to the present date, with a sudden series of very serious actions of physical kidnapping, physical abuse, trafficking, Psychward-incarceration, and forced medication taken against me over the past couple years, 2022 and 2023, by misled physicians and psychiatrists as well as numerous others including Emergency Medical staff, ambulance staff, local police, and family members, all in actions of harm aimed at extreme defamation and slander, physical neuro-bio subjugation, removal of human rights, and disappearance of voice in thwarting, obstructing, and delaying my critically important national security work in investigative science and technology journalism exposing national military, intelligence, and law enforcement crimes using electromagnetic directed-energy-weaponry testing and development operations against the citizenry in the whole of the United States of America and world--which I first came to know of when I was first unlawfully targeted myself with these operations in late October/early November 2013, which I reported first to my family, then, much against my will, under duress and family coercion to psychiatrist Dr. Subha Thiagarajan, as described herein.

In addition to extensive documentary journalism in print and video on the subject, interviewing both reporting victims and NSA, CIA, FBI, DOD whistleblowers, I have written numerous letters to government officials including the Commonwealth of Massachusetts Governor Charlie Baker, the Mayor of the City of Quincy Thomas Koch, the Secretary of the Commonwealth of Massachusetts Francis Galvin, the Attorney-General William Barr, then Massachusetts Attorney-General Maura Healey, Acting Attorney-General Bessie Dewar, the Special Agent-in-Charge at the Boston FBI Joseph Bonavolonta, the head of the Commonwealth of Massachusetts Fusion Center Lt. Col. Christopher Mason, and, with others, twice to the President of the United States, Donald Trump, exposing these crimes. Last November I also wrote to various parties involved in the actions against me with letters of claim and requests to remove all false psychiatric labels placed against my name, in efforts to correct the medical records maintained in my name which are clearly projecting a false representation of both my health history and my name as a Writer, Journalist, mother, and wife.

Further: As a consequence of these false psychiatric labels I am being denied actual physical medical care and being treated as an imminently-psychotic-at-any-time mental patient--in continuation of the crimes against me, within family, home, neighborhood, and the larger social milieu, while the defamatory actions of harm from these false labels aka "diagnoses" continue to inform all physicians falsely as to who I am and what I am doing. My human rights have been removed by physicians and psychiatrists, my voice has been disappeared by this false edifice of Psychiatric Medicine, all starting, it appears with the first "diagnosis" handed out in ignorance and denial of the facts of electromagnetic technology assault by Dr. Subha Thiagarajan.

I ask you all therefore to apprise yourself of the facts, to peruse previous coverage at my website and elsewhere online, and to follow the ongoing coverage--with declassified documents--of the very real and very unlawful military directed energy weapons testing and development operations as well as "Public Safety" EMF technology operations ongoing on Americans in Massachusetts and the whole of the USA which have been long conducted and which need to be stopped.
