:NOTIFICATION-OF-FALSE-CLAIM-AND-FALSELY-AUTHORIZING-BENEFITS;-REQUEST-FOR-RECORDS

Dear Managers:

I am in receipt of a letter from you wrongfully back-dated April 15, 2022 but mailed to me and arriving at my home on a Saturday, May 14 or 21, 2022, a month afterward (no time stamp on envelope), and in fact sent the week I had called in and spoke to a woman at your offices explaining that the medical claim made to your company by Steward Carney Hospital, Dorchester, Boston for the time period April 14 to April 19, 2022 in the name of “Ramola Dharmaraj” was based on a wrongful and unlawful Section 12 Involuntary Hospitalization run by Quincy Police Department on my living being, succeeding a false-claim by a neighbor—which police did not bother to verify—and that I was providing this information both as a courtesy to your company and a request from me not to pay that wrongful claim from Carney Hospital. Your letter indicates not merely that my words on the telephone that day—which I was told by your employee (“Cassandra”) were being recorded—were not heeded, but that your company has gone ahead and paid that claim, in fact “authorizing benefit coverage” under a “behavioral health benefit plan” and wrongfully named that time period of my unlawful kidnap and

captivity in a psychiatric ward for 6 days, in harmful and grievous conditions (of extreme cold, no edible food, no free access to drinking water, no exercise, no sunshine, no nutrition, no cellphone communications, among others) as "0124 MH Inpatient Adult" and a "benefit."

I must also remind you that no supervisor, manager or director called me back after my conversation with your employee "Cassandra" as she promised. What transpired later that week was the appearance of this fraudulently back-dated and false-claiming letter (with the number 2022105-BH004AB-00343-04 in print header) in my mailbox, with no date stamp on the outside of the envelope.

I am at a loss to understand why you would not heed my request and why you would in fact go to the extreme lengths of miscasting this profound act of political persecution of a journalist as a "health benefit." I am also concerned that you have—as Steward Carney Hospital has—now included this fraudulent labeling on my medical health record, miscasting not just this entire sordid episode which has included Personage and Barratry, Kidnapping and Trafficking, but my entire health record as carrying "behavioral health" deficits.

Carney Hospital as also the Quincy Police Department have violated my rights under American common law, public law, natural law, international law—as well as US law--in numerous ways, and I am pursuing to the fullest extent the redressal of this profound violation.

It appears I must also now include in this redressal your company, and will be sending you my claim for all damages shortly.

In addition, I must also inform you that Steward Carney Hospital rejected my request to see whatever medical records they had generated in the name of the legal personage "RAMOLA DHARMARAJ" for which I am the sole attorney and authorized agent, thereby denying me the opportunity to examine what exactly their doctors and psychiatrists had put down regarding my forced stay under duress, without consent, in harmful and grievous conditions for an unlawful 6 days on their premises. I am requesting therefore that you send this information to me immediately, since I believe I have a right—protected in public law and statutory law both—to examine my own records, wrongfully attributed as they may be to a Legal Person Name, but one which I am the sole authorized agent and attorney of, as a living soul and state national standing on the land and soil jurisdiction of the united States of America. Please be advised I am not a federal citizen, US citizen, legal fiction, strawman, or false corporation writing this letter, I am a flesh-and-blood woman who had established my status prior to being wrongfully and unlawfully kidnapped and abducted into a psychiatric ward by Quincy Police Department.

Finally I must also remind you that although it is my husband [REDACTED] who is the direct

holder of health insurance with your company, he is not my mouthpiece nor agent nor attorney, and is in fact in process of being divorced. I have enjoined him not to participate in this completely unlawful attack on my name and life through permitting this wrongful “behavioral benefits coverage” and he has refused. I have requested that he drop me from his health insurance plan with your company and he has refused. This is an untenable situation and I will be presenting my fee schedule and claims to all who are acting against me in this matter.

In this regard I will also clarify a key component of this unlawful Kidnap and Captivity incident, which involves my science-and-technology reportage of military Spectrum Weapons, Microwave Weapons, Electromagnetic Weapons, Electronic Weapons, also known as Non Lethal Weapons, Crowd Control Technologies and which are being used by Law Enforcement as well as by the NSA, CIA, DIA, FBI and US Airforce, US Navy, US Army, US Marine Corps in numerous euphemistic, unlawful, unethical, and inhumane “deterrence,” “countering terrorism,” “countering violent extremism,” “community policing,” “weapons-testing,” “intelligence, surveillance, reconnaissance, tracking operations,” “behavioral modification,” “behavioral enforcement,” “peace enforcement” operations all over the USA and, with 5-Eyes security and intelligence contracts, all over the world as well. My journalistic coverage over the past 8 years since 2014 has definitively established the publicly-undisclosed, pernicious, and unlawful use of microwave weapons (and other Spectrum weaponry) on the American and world population, in tandem with the reportage of several prominent writers, journalists, and Government whistleblowers—coverage well-known worldwide in police and intelligence circles (and the reason for this unlawful, retaliatory, persecutory Section 12 assault on my being) but less well-known locally thanks to mainstream media disinformation, and lack of coverage by infiltrated human rights groups who should be reporting publicly on this matter. A primary consequence of such harmful microwave-weapon use on people is the need to shield from such attack: this is often misperceived as a “behavioral health issue” by uninformed, oblivious, denialist parties such as my husband – who as noted above has also gotten on the Behavioral Health train instead of paying attention to the Smart Grid replete with drones, helicopters, continuous LRAD-hits (long range acoustic device), measured EMF pulses, EMF emitters, antennas and portable devices being built around him, and indeed around all cities and neighborhoods—and of course instead of paying attention to the brilliant reportage of his journalist and writer wife of 30 years, as well as the obvious physical damage she has suffered from microwave and millimeter wave technology abuse, which is exactly why he is being divorced.

All this by way of saying **my husband's word does not take precedence over mine in this matter**—if indeed it is his word your company is relying on.

Please be aware the correct thing for your insurance company to do is to deny Steward Carney

Hospital any coverage of their criminal 6-day Kidnap and Persecution operation on my living being as a “health benefit” and “benefit coverage” instead of colluding unlawfully with this hospital to fraudulently support this crime. **Persecution is not Health Care. Steward Carney Hospital, the Quincy Police Department, Brewster Ambulance Services, the City of Quincy, and the Department of Mental Health, Commonwealth of Massachusetts should correctly be footing the entire bill for this 6-day cluster of crimes—not myself, not my husband, not PriceWaterhouseCoopers, not United Health.** Kindly let me know in writing that you have done so within the next three weeks, as I prepare my claims and affidavits to be served on all involved, to be sent to United Health as well if not, as paying participant in this criminal operation of persecution against a professional journalist lawfully exposing extremely inhumane and unethical high-tech crimes against humanity.

I also await receipt of the fraudulent medical records made in the legal person name of “Ramola Dharmaraj” by Steward Carney Hospital—which need to be removed from any association with the name “Ramola Dharmaraj”.

It is never too late to set right a serious wrong. Kindly do the right thing here.
