Dear Health Information Management Director:

I am writing because I have just received and read, on Nov 1, 2022, from Sharecare an email copy of the medical records made in the name of "Ramola Dharmaraj" for physician visits at Atrius Health and notice there are many false claims, falsehoods, fabrications, lies, and false "diagnoses" recorded in these notes & need to inform you immediately of this fact.

- 1) I have previously written in to Atrius Health with information for correction regarding a recent visit to an Atrius Health physician, Dr. Leslie-Ann Alexander, with instructions to include my letter in the medical record associated with my name. However, I do not see my letter of correction included in the medical records I have just received from Sharecare—my letter of correction to Atrius Health Management should be included in my Atrius and Sharecare medical records.
- 2) I notice that the notes made by Ourania Madias, MD on 12/31/2013 are filled with massive fabrications and lies, in addition to false-diagnoses and falsehoods. I will be sending a letter immediately to Atrius Health to address these lies and falsehoods.
- 3) I am just perusing the records in detail and intend to address every ounce of disinformation, misinformation, and false information penned therein by clearly corrupt physicians.
- 4) I am sending you this notification of false claims, falsehoods, false diagnoses, and medical malpractice to immediately record the fact that I have only just looked at the records and am sending immediate notice to your offices. Despite the fact that these notes were made in 2013—with extenuating circumstances preventing my ability to obtain or address

these notations made in 2013—it is imperative that I correct the record at once, with the facts. Any medical record associated with the name "Ramola Dharmaraj" needs to carry the correct information—not a mass of made-up fabrications and false-assessments made by corrupt physicians like Leslie-Ann Alexander and Ourania Madias.

- 5) I will be following this notification with a detailed letter to Atrius Health to address the falsehoods notated by **Dr. Ourania Madias**, and as with my letter regarding **Dr. Leslie-Ann Alexander**, ask once again that both letters be included in the medical record associated with the name "Ramola Dharmaraj" copyrighted to me and for which I am the sole authorized agent and attorney.
- 6) Any electronic-record-keeping and digitizing of records using the name "Ramola Dharmaraj" needs to contain in full the record of corrections sent in to Atrius Health to correct the false-notations made by Dr. Leslie-Ann Alexander and Dr. Ourania Madias. It is the responsibility of Atrius Health to fully make these corrections based on the accurate information I have provided already in Dr. Leslie Alexander's case and will further provide in Dr. Ourania Madias's case.
- 7) Atrius Health is hereby notified that Atrius Health and Sharecare are maintaining false and misleading medical records—which extends to defamation, slander, and libel--in the name of "Ramola Dharmaraj". Atrius Health needs to correct these false medical records immediately and apprise me immediately of the fact. Atrius Health—which is already liable for maintaining falsehoods in the records regarding Dr. Ourania Madias and Dr. Leslie-Ann Alexander--will become further liable if my corrections of these false medical records being attributed to "Ramola Dharmaraj"--and which have been maintained falsely by Atrius Health--are not made.
