Dear Arthur H. Tobin, Clerk-Magistrate, Quincy District Court:

As the Freedom of Information act requires, please provide all information, court records, court orders if any related to the hearing I was told was held on December 20th, 2022 at the Quincy District Court involving the name "Ramola Dharmaraj" or any form thereof including "RAMOLA DHARMARA" while I was being held there under duress, without cause, without consent, in a jail cell on the premises of Quincy District Court, shackled as if I were a criminal, divested of my personal belongings, after being abruptly and forcibly kidnapped out of my home that morning by Quincy Police—when I was physically sick with a sinus infection and radiation illness--without cause, under no criminal warrant, no reason whatsoever, no information provided, unlawfully dragged out of the peaceful privacy of my home in Land and Soil jurisdiction, thence held captive at Quincy District Court, later forcibly kidnapped again—with no reason given--by Brewster Ambulance staff in the presence of various black-clad and other men I presumed were Quincy Police, in the presence also of a van marked Norfolk County Sheriff and a uniformed man with a possible connection to that office, transported unlawfully, with no information provided at the Court, to a place unknown I was told inside the ambulance was South Shore Hospital, driven interminably in the dark, in rain, on unknown highways, with what looked like an unmarked Massachusetts State Police SUV following, deposited at an Emergency Room where I was not listened to but subjected over numerous hours to much further unlawful physical abuse on body and brain, including manhandling by Security staff, forced-drugging, a forced-EKG, a forced "psychiatric evaluation," subsequently forcibly kidnapped once again by uniformed men and transported once more under duress, without cause, without consent, with no information provided, to another hospital, Bournewood, where I was held under duress, with much inexplicable and unlawful continuation of incarceration, involving inexplicable numbers of psychiatrists, social workers, "expressive therapists", registered nurses until December 29, 2022.

As one consequence of this abusive train of crimes performed on my living self—there have been many—I have been unlawfully subject to over eight months of forced medication in my home with covert psychiatric drugging and unconsented-to stealth "treatment" with "innovative" "health technologies" and "Public Safety technologies"--essentially abusive and intrusive remote-access electromagnetic pulse and vibrational microwave weaponry and neuroweaponry, of the kind I have been investigating and exposing as in undisclosed use by Military, Intelligence and Law Enforcement factions and their contractors as a science and technology journalist for the past ten years—while at the same time I have been subject to much other abusive

electromagnetic and acoustic technology assault in my own home and neighborhood, all riding it seems on the false psychiatric labels handed out by complicit physicians and psychiatrists at these two hospitals (as others, in previous unlawful actions by Emergency Medicine, Law Enforcement, and Psychiatry parties I have reported publicly as a journalist).


I have been treated throughout this ordeal, from December 20-29, 2022—by all ambulance and hospital staff--and thereafter, upto today, as a Mentally Ill, Mentally Unstable, Mentally Incompetent, Brainless Non-Human-Being with no human rights, unable to get Physical Healthcare, and apparently unlawfully enrolled by my own Health Insurance provider into “Care Coordination”--seemingly a Communist conglomerate of “Healthcare” and “Public Safety” and “Behavioral Health” networks acting together in Massachusetts to ensure continued and inhumane remote-access-technology-assault, intensive and continuous social and neighborhood harassment, intentionally provocative noise harassment, obvious street theater actions engaging multiple parties, wireless-technology-enabled bio-hacking and neuro-hacking, extreme and extremely frustrating cyberhacking, extreme and vile defamation, all enacting social and psychological torture under guise of “community care” and “community monitoring”, all ensuring bio-degrading and neuro-degrading of body and brain, and profound destruction of personal and family life. Since that day, there has also been much abusive and racist discrimination in daily life, with, I suspect, much behind-the-scenes entrenched defamation—since this criminality hasn't stopped—and all apparently to disappear my critical work and name as a humanity and human-rights-focused investigative science and technology journalist.

This is therefore a matter of political persecution which I am working to find out more about. Having received no reply to my two emails sent earlier (August 7 and August 29, 2023), and because I cannot be certain this was not due to local cyberhacking, please know this is no frivolous query but one intent on finding the truth. Clearly I need to address this matter further in the right forums as I continue my quest for Truth and Justice as a living American woman, attorney in fact on the land and soil jurisdiction of the United States of America—and a Writer and Journalist massively wronged, for no reason whatsoever.
