Dear Kate/Manager, Optum, Privacy Administrator:

Please send me in PDF and CD form the full PHI (protected health information) for the name "Ramola Dharmaraj" (as spelled in any form) informing Optum's BH ("behavioral health") record and Member Claims History for this name, and please send me the full Member Claims History and BH ("behavioral health") record maintained by Optum from time of origin of these records to the present date, August 30, 2023.

Please note the print package of information sent to me unsigned from Optum dated July 20, 2023 is grossly inaccurate, falsely-representing, and obviously wrong, as well as invalid—given the fact (as noted earlier) that there is and has never been any "mental health/behavioral health/psychiatry" issue here in the first place; it is also incomplete and does not show the falsely-representing, misrepresenting, impersonating family member, Quincy Police, Quincy District Court, Brewster Ambulance, Norfolk County Sheriff, South Shore Hospital/"Aspire Health Alliance" aspects (several false "complaints" "warrants" "Section 12" and "Section 10" "Application for Involuntary Temporary Hospitalization" and "Application for Care and Treatment on a Conditional Voluntary Basis"s in there) of the 12/20/2022-12/29/2022 debacle of unlawful capture (forcibly kidnapped while I was actually physically sick and resting in the privacy of my own home) and transport and hold under duress for 9 days for no reason whatsoever, information on which time period was requested originally.
