Dear Lieutenant Terence McDonnell,

Thank you very much for the response from Quincy Police Department to my Freedom of Information Act and public records request of October 16, 2023. Please copy my response to the Chief of Police, Mark Kennedy, whose email address I cannot find on the City of Quincy website, and to whom I had addressed my FOIA request online via that website.

Given the gravity of this matter, the original FOIA request (re-attached), and the nature of the notations made in the CAD Incident Report provided, kindly provide the "Section 12" form referred to in "Description" on the CAD Incident Report you have enclosed, along with the "Court Order" if any, noted as "504 CT/ORD" in "Incident Type," if used by the two police officers, J. ODonnell and M. Millane, named in that CAD Incident report, to break into my home on December 20, 2022, and kidnap me physically off my couch in my living-room, for no given reason whatsoever, and no information provided to me, then or later.

Not merely was I not provided any notification of reason by Quincy Police for kidnap at time that I was kidnapped that day or later, I was not provided any "Section 12" or other form to peruse, while one of the officers said, inexplicably, "You asked for a warrant, here it is" and "I found your state id online" while not letting me read the paper he was waving about and assure him I was in no way interested in accepting any offer of his services; I was forcibly detained, incarcerated, later transported to two hospitals, all without any information provided and much other abuse attendant in clear efforts to force "psychiatric evaluations" on me and thence further false psychiatric labels, of apparently advancing kind; on this subject, it must be known I have previously addressed in full the previous wrongful actions of Quincy Police in attempting to attribute to me "mental illness" and working to force through a first "psychiatric evaluation" to attempt to prove same, in April 2022, when four police officers burst into my home on April 14, 2022 and kidnapped me for no reason, no forms/warrants/information of any kind for me to peruse, no notification whatsoever.

To add, I have provided notice of my established privacy status to Chief Paul Keenan (in my Notification of False Claim sent on May 2, 2022 to QPD/Chief Paul Keenan, re-enclosed), as also to the Commonwealth of Massachusetts Secretary of State, Frances Galvin, and to the US Secretary of State, Antony Blinken, among others, to whom I also later sent a notice of my status as an international protected person; there is no reason I can follow therefore for Quincy Police to step out of jurisdiction at any time to in any way invade my privacy, well-being, health, or life.

If indeed there was a "Section 12" form or "Court Order" behind that bursting in to my home on December 20, 2022 to kidnap, capture, transport, incarcerate, and traffick me into so-called hospitals (over Christmas 2022, until December 29, 2022) using force and defamatory intent along with ambulances, state police SUVs, and Sheriff vans/presence, I would like to see it so I can further address this matter correctly, to clear my name, to set the record straight, to establish definitively I certainly have no mental illness whatsoever, to ensure that Quincy Police and Brewster Ambulance staff never burst onto my premises ever again aiming to secure "Section 12" "psychiatric evaluations" or anything else, and to secure my rights as a private, peaceful, living on the Land, American writer and journalist.
