Good morning sir or Ma'am, this morning, Friday, 2 February 2024, the Office of Primary Responsibility (OPR), contacted me asking for an extension to 16 February 2024 to legal review and a few other things. Please know that the deadline of 29 February 2024 will not be met. After I receive the FOIA Package from the OPR, I will then have to forward the package up to the 502 Air Base Wing for review, approval and signature on the Final Reply Letter from the Vice-Commander. The process takes around 3-4 weeks since each office (legal again and the Commander's) require 10 working days to work the FOIA Package. I will keep you updated at all times.
