Dear Steven Treat:

In light of the Freedom of Information Act, I am writing to ask for all public records made or/and held by the Massachusetts Department of Children and Families in the name of Ramola Dharmaraj or Ramola G Dharmaraj or Ramola Grace Dharmaraj or Ramola D from the time period of June 2011 when I first came up to Massachusetts up to the present date, March 3, 2024, and for all records made or/and held in the name of my

child Sophie Marguerite Nerine or Sophie Nerine from the same time period of June 2011 up to the present date, March 3, 2024.

As a science and technology journalist investigating directed-energy and neuro technologies used by various military, intelligence, and police parties on the people of America and worldwide—reported at my website The Everyday Concerned Citizen, my video channels at Ramola D Reports, and other media, I have been unlawfully targeted by various factions in Quincy and have previously written to the Commissioner of DCF after our family was unlawfully “investigated” succeeding a conversation I had and Public Safety report I made about such energy technology usage on school premises, as a journalist and mother, at my daughter's middle school, Central Middle School, in March 2018. The Commissioner closed that investigation after much public uproar and contact from media colleagues and supporters of my much-needed journalistic work.

I would like however to see all information unearthed by that so-called investigation and all reportage held by the DCF around this matter then or later, in PDF and print form if possible, all copies of letters, communications, correspondence, as well as any other further entries made in my name and in the name of my child, since I have been unlawfully targeted once again, in April 2022 and December 2022 by Quincy Police and the Massachusetts Department of Mental Health, matters which I am addressing comprehensively in order to fully and absolutely clear my name of any further false claims of “child neglect,” and “mental illness,” and my daughter's name as well, since she is most definitely not “mentally ill,” nor does her mother have any form of “mental illness” whatsoever. My daughter needs to know that her mother, throughout her career, was and is an upstanding and dedicated writer, teacher, and journalist working hard to publish the Truth of current-day reality, and not a Mentally Ill woman whose sad handicaps are going to be passed on to her by some form of absurd osmosis at some future date—which is the Narrative inflicted on this family by the unlawful treatment we have received from the DCF, QPD, and DMH; it is a False Narrative which needs to be corrected in the Public Record.
