Dear Commissioner of Public Health Marli Casilli:

This is a Health request. I am a reporter who has come under targeted attack from various parties for the clarity of my journalism and the vital subject matter it addresses. As a consequence it appears I am under targeted 5G attack in addition to electromagnetic and electrical attack from very close by in my neighborhood in Wollaston, Quincy. Over the last 7-10 days my cat has been seriously targeted and attacked with intense energy weapon hits as well and has succumbed to intense and focused 5G attack over the last few days; he died early on March 14 of chronic respiratory distress, a suddenly enlarged heart, and a sudden filling of fluid in the lungs as well as 5G-inflicted inability to breathe.

Over these past ten days I too have been attacked rather seriously with both microwave pulse technologies (of the kind the DOJ has gifted police departments and state police contractors--as reported recently at my website The Everyday Concerned Citizen, please see the recent Police Technologies and NIJ Documents articles) and with intense 5G emissions, aimed at the nose and mouth and attacking one's ability to breathe; as an MBA, MFA, Physics graduate and a Science and Technology reporter and news analyst, examining the issue, and noting the long period of recorded EMF and sound assault from my neighborhood, I believe I am being pulse-hit from very close in, specifically from neighboring houses on the block on Pine Street where I live--the houses involved may be many but the three closest to me, 150 Pine, 156 Pine, and 153/151 Pine and one across at 147 Norfolk are who I suspect are engaged in directing malevolent targeted 5G attacks into my home at 154 Pine Street, and have been involved in the concerted and unlawful 5G attack on my cat over the last couple weeks. Meters I have used record pulse hits from these directions. These houses also appear to have 5g emitter/antennas on their roofs. Meanwhile, right on Elmwood, 3 houses down, two houses down from the intersection with Pine, is a 5G cellular transmitter on a wooden pole.

I am not sure how many other 5G antennas, masts, and celltowers are located nearby—(1) Can you please send me a list or direct me to where on the Quincy website I can find this information?

I am writing because this is very much a Public Health issue. 5G is known to produce all the symptoms of microwave radiation sickness, with headaches, dehydration, nose constriction and nosebleeds, inability to breathe, and phlegm creation, which, if not immediately tended to, can cause heart and brain failure and death. I am sure as a MPH and MS you are aware of this matter. There are others, and I will be glad to send you further information to examine. The harms of 5G on living beings have been clearly established. In addition to (1) above, (2), can you kindly shut off the 5G on Pine Street, and on Elmwood Street? My cat has died thanks to the use of 5G as a weapons system by unscrupulous CIA-run neighbors and I am in danger of dying myself, I am constantly having to take care of my health with shielding from 4G and 5G both, as well as from actual RF weapons being used
