Dear Chair Jessica Rosenworcel, Commissioner Brendan Carr, Commissioner Geoffrey Starks,  
Commissioner Nathan Simington, Commissioner Anna Gomez:

I am writing to inform you of a serious situation of tragic use of 5G in my neighborhood, which, along with the much-recorded, closely-observed use, unlawful and harmful, of electromagnetic, radar and acoustic neuroweaponry in my neighborhood in Quincy, Massachusetts has resulted, over two weeks, in the persecutory torture and death of my family cat, Zippy, a healthy, happy seven-year-old, an innocent living being subjected to focused, targeted harassment-unto-death by absolute criminals living under cover and practising serial hacking (bio neuro cyber) in houses adjacent to and opposite mine.

Please know that as an investigative science and technology journalist I have been reporting on this matter of unlawful use of electromagnetic and sound energy neuroweaponry on the populace since 2013; my reports and interviews can be found at *The Everyday Concerned Citizen* (print) and at *Ramola D Reports* (video) on various video platforms including Bitchute and Odyssey, and excluding Youtube, which sadly crashed my informative journalistic channel in March 2021.

I would like you to take a look at recent reportage at my website (everydayconcerned.net) on anti-personnel electromagnetic weapons developed and tested by the military, tech-transferred to the DOJ, and now, without the Informed Consent of the American people, being used and operated, harmfully, and hubristically, on the people, as per documents from the US Air Force, US Army, US Navy, Marine Corps, National Institute of Justice, Department of Defense, and various disclosures from Military, FBI, CIA, DARPA, and other whistleblowers and scientists show. These are Anti-Personnel weapons, which have been “tested” on humans, as declassified documents obtained from the US Air Force reveal. [Please see my article [Declassified Documents](#) here.] Now the same weapons have been fine-tuned for use by police parties via contracts with fusion centers (state police in Massachusetts) under the aegis of “Public Safety” and are being used indiscriminately on the citizenry. This is obviously a matter for national and international human rights law, since these operations of testing, approval, and “fielding” in-community have been executed in contravention of all Constitutional, US, State, and International laws and protections of privacy, bodily integrity, human health and national security. As a Writer and Journalist addressing this subject for 10 years now, I continue to work to report on these weapons, their wrongful usage on civilians, veterans, military, all citizens inside the United States of America, and the need for the application of human rights law to address this major problem.

I am sure, as Commissioners with Law degrees and with children (as your Bios online share, thank you), you are as concerned as I am about the health of our children and our babies, our companion animals and ourselves, as mothers, and fathers, aunts and uncles, grandparents and cousins, relatives and friends.

I am not so sure (no scientists on your team, surprisingly) you have acquainted yourselves with the harms of 5G, which include all symptoms of microwave radiation sickness, and all symptoms of what certain co-opted agencies rolled out in 2020 and cling to shamelessly as COVID-19, shown to be a hoax in every way by educated scientists: shortness of breath, inability to breathe, nosebleeds, blood clotting, respiratory distress, organ failure, death. Numerous prominent scientists have been educating and informing us the world over on the harms of 5G, including Professors Neil Cherry, Dr. Magda Havas, Dr. Martin Pall, Arthur Firstenberg, Dr. Zory Glaser, Barrie Trower, so many others. [Their work can be found all over the Internet.]

I want you to know that literally over a matter of days, with the clear switching-on of 5G in our neighborhood on numerous people's 5G antenna systems, on a prominent cell mast on a cross-street closeby, and the concomitant use—which surely the FCC needs to address—of the Electromagnetic Spectrum in portable, wall- and vehicle-mounted microwave and millimeter RF HPM devices, Pulse and Continuous Wave, our cat was subjected to extreme 5G emissions aimed at face, throat, nose, lungs, heart, causing in a few days complete loss of appetite, impaired motion, an enlarged heart, and pleurisy build-up of fluid in his lungs. Attempts to save his life with Reiki, hydration, attempted liquid nutrition, and TLC failed in the face of continued, cruel and sinister assaults with electromagnetic/5G and neuro weaponry from very close-by. I too was hit during this time—as I continue to be hit—with intense 5G assault aimed at my face, nose, throat, and pulsed microwaves directed at my head and heart. These assaults—which I have been reporting closely lately at Reporter's Notes at my website, see 23 and 22 especially—have persisted. As I write to you, I am being attacked again in this fashion and can breathe only because I am using a humidifier next to me, aromatherapy oils of eucalyptus and Bulgarian rose, frequent movement away from my desk, and sheer willpower. My health has declined dramatically since the paid mercenaries living next to me moved in, and I struggle every single day to preserve and restore my previous, vibrant health (I am a vegan and a tennis player, runner and hiker, have always lived an outdoors, athletic life, and would go to the gym everyday currently if I could; I cannot, for numerous reasons, including massively debilitated health thanks to 5G and AP-DEW/Neurotech operated against me): massive migraines, left-arm pain, shoulder pain, right arm pain, knee pain, heart congestion, inability to breathe, left leg pain, left hip pain and near hip breakage are what these mercenaries have gifted me, over the past year in particular.

Please know I am making Crime Reports of this absolute crime to requisite parties both within and without the United States, and internationally. I am informing all I write to of these crimes against myself and against the people and animals of the USA and the world. Locally, the wrongful usage of these AP-DEWs/Neuroweapons has been facilitated and permitted by so-called Law Enforcement, matters I am reporting on as a science journalist. That makes this a particularly vital Human Rights issue to address; over the past two and a half years I have come under increased attack as a reporter, with two separate incidents of unlawful Forced-Psychiatric-Evaluations to procure false psychiatric labels (apparently a new Commonwealth-KGB police pastime) conducted against me, an Author, Publisher, Writer, Journalist, former college faculty, children's creativity workshop teacher, living American, Attorney-in-Fact, Human/Eco Rights Activist, and Mother, by disrespecting and racist local Quincy Police—matters I am reporting and addressing, both at my website, and with all participant miscreants.

The Federal Communications Commission is surely involved and responsible in some way for the

unlawful use of the Electromagnetic Spectrum in operating weaponry of harm against the people of the United States of America. I am keen to explore these laws, and ask for your guidance in this matter. (1) Can you kindly direct me to the correct Human Rights, Communications, or Military laws governing the use of the Spectrum on civilians, veterans, military inside CONUS, which surely aim to protect the life, health and happiness of the People?

Further, the Federal Communications Commission is surely responsible for the Safety of any kind of Spectrum use inside America, and that would include 5G, which has been permitted to be rolled out all across North America, South America, Europe, India, China, Australia, Africa and various other countries rather fully, and no doubt others in some form, as Verizon maps of usage currently indicate. Eight documented effects of pulsed electromagnetic emissions studied by Dr. Martin Pall, Professor of Biochemistry and Medicine at Washington State University have been found to include cellular DNA damage, lowered fertility, sperm and ova damage, brain degradation, cell death, cell damage, oxidative stress, endocrine system breakdown, elevated intracellular calcium as precursor to disease, and various kinds of cancers.
