Dear Brenda G Fernandez,

In light of the Freedom of Information Act, I would like to request the following records:

- 1) **The contract/s and licensing agreement/s, relevant in 2022 and current, which the City of Quincy or the Office of the City Clerk has had and has currently with Brewster Ambulance** for ambulance or inter- and intra-city transport services of living human bodies, and any additional information regarding whether they need to be knocked unconscious first before being manhandled and strapped into ambulances, and if so with what drugs, precisely, and what methods of delivery of such drugs, precisely--since this was regrettably done to me on 12-20-2022 by Brewster Ambulance personnel (when I was physically sick and needed to leave the premises of the Quincy District Court where I--a journalist, writer, mother, community caregiver--had been unlawfully held, probably under gassing or force-medicated duress, while shackled--which certainly was duress--and locked into a "Courtroom

Lock-up" also unlawfully, for no reason whatsoever, for several hours on 12-20-2022, without reprieve).

- 2) **The contract and licensing agreement which the City of Quincy or the Office of the City Clerk has with Quincy District Court** permitting them to call in to South Shore Hospital and "refer" my kidnap-and-trafficking sale to them as an involuntary Section 12;
- 3) **The Section 12 form/other authorizing form therefore used by Brewster Ambulance or Quincy District Court if any, and any other material used by QDC if any**--in fact, by a certain Chelsea Lloyd, LSW, notated on health insurance records as making the call for QDC to South Shore Hospital, "referring" me as an Involuntary Section 12 from QDC which is notated as the Referring Facility, the actual Form therefore used by QDC, Chelsea Lloyd, or/and Brewster Ambulance in forcing through a first involuntary knocking-unconscious, manhandling and attack by Brewster Ambulance men, strapping, capture, trafficking and sale of my physical living body from Quincy District Court premises to South Shore Hospital on 12-20-2022-- a horrific site where I was further unlawfully held, further knocked unconscious, attacked by Security men, force-tied-down, force-injected, force-medicated, force-EKG'd, force-COVID-swabbed, force-vaccinated possibly, force-device-implanted, multiply, and prominently in my left upper arm with extremely painful devices--still causing daily pain--and on my chest with criminal electronic RFID sensor tags at my heart--which permit external remote-access stalking of my body and my heart--which is indeed happening now, painfully-- force-held for hours then re-grabbed, re-kidnapped, re-trafficked to another Massachusetts hospital, this time a Maximum Security Psych Prison at Bournemouth where I was held unlawfully for 8 days, all with much lie-writing, psych labeling, and fabrication attendant, not to mention undisclosed force-medication for months afterward, almost a year, destroying my life, health, name, reputation, and status in society extensively, matters I am still addressing to ameliorate.

This is a Media request and a personal request both, obviously, since I am the wronged party here, and am the journalist reporting on Medical and Police crimes, among others-- Military crimes, certainly, with special attention to the Anti-Personnel Directed Energy Weapons and Technologies unlawfully tested on the American populace which have been kept hidden from journalism by miscreant police, military and CIA, and for which reason apparently this Writer and Journalist has been unlawfully set upon several times by unlawfully acting police, courts, EMS, and medical parties in a little known underworld in

the Commonwealth of Massachusetts whose actions must indeed be published to one and all--for the edification of all future administrations and generations, at the very least. Our children-- and the people of Quincy--surely deserve better. All documents will be made publicly available therefore, in the interests of public awareness and positive governmental change.
