Subject: Electro Magnetic Harassment, Covert Harassment, Organized Stalking in the Boston Area

Dear Sarah Butler, Senator Markey,

I am writing to you today to add my voice to Letitia Aby's. I met Letitia recently through the organization Freedom from Covert Harassment and Surveillance as I strove to research the constant electromagnetic harassment/organized stalking scenario I suddenly found unfolding around me (I live in the Boston area, in Quincy) .

I also write to you in your capacity as a people's representative and Senator in Massachusetts to inform you of this situation which constitutes an extreme violation of my civic rights, human rights, and citizenship rights to free speech and expression, and to ask how I can seek redressal and justice in this situation.

Very briefly, I have come to understand that I have recently become the object of supreme covert electronic/electromagnetic harassment, aerial stalking, and gangstalking 24/7 by a criminal agency, whether it is the NSA, the military, or a corporate criminal agency I do not know. For the past 2 months, since the first week of December, I have been tracked, followed, and daily and nightly been the recipient of pulsating Directed Energy at my home, and while outside the home.

In trying to understand what has happened to me and why, I can trace a few expressions of free speech I have engaged in recently. One, I had recently requested kid-friendly materials from the Amnesty International Dec 2-17 Write 4 Rights campaign for possible use in my children's workshops. A month ago, I also had written letters to my senators (both you and Senator Elizabeth Warren), House representatives, and Quincy city councillors and local media, asking about the dangers of chem trails, which had recently come to my attention.

Directly following these actions, odd things began to happen. I have come to understand that I have suddenly become the target of criminal covert and overt harassment by the NSA or other secret-ops agency. My computer has been hacked, my phone I suspect illegally wiretapped, and gangs of thugs in SUVs have been zooming through my neighborhood targeting my house, my family, and myself with directed energy, chemical toxins (gassy exhaust and stink bombs), noise pollution, aerial stalking, and 24/7 surveillance, tracking, and directed energy attacks all through the night--aimed at sleep-deprivation--through brain-printing and tracking. This is continuing everyday and every night, up to the present moment. Cars with tracking devices cross my house often, putting tracking sounds on my walls, and eventually beams of energy on my person, which I have come to understand are beams of microwave pulses. I am literally being tortured every day and every night in my own house.

This has forced me to research the subjects of directed energy weapons, covert harassment, and Targeted Individuals, as well as EMF shielding--all of which I have recently therefore learned a great deal about.

I am an American citizen, a peace-loving activist on occasion for clean air, water, food, and a safe and healthy planet for all, in addition to my work as a writer and writing/arts instructor--I write letters, sign petitions, and write stories and poems. I believe I am protected by the Constitution and the Bill of Rights. This is a horrific, outrageous, and completely untenable human rights violation of my most basic civil rights to be let alone, to speak freely, and to command integrity over my own mind and my own body.

I understand from my reading that this is an issue impacting thousands of Americans and possibly hundreds of your constituents--it is absolutely Horrifying, and as I see it, the ultimate Invasion and Violation of human rights in this time and age--if we do not have absolute sovereignty over our minds and brains and bodies, how do we exist as sovereign individuals?

As a writer, I wish to do everything in my power to help expose this abuse and bring the perpetrators to justice, and offer my help to any effort you may be currently contemplating or spearheading. I urge you to take up this cause if you have not done so already, and I want you to know you may contact me anytime for my participation.

(Just fyi too, I did send a note to your offices via a website earlier detailing this scenario but I am not sure it went through. In joining forces with Letitia I am hoping we can work together to bring this horror to light and put an end to it.)

Thanks very much for your attention, Senator, and I await your reply.
