Dear First Secretary Ambassador Abhimanyu Gahlaut, Second Secretary Ambassador Sunil Kumar, First Secretary Press Information and Culture Neha Singh, Second Secretary Press Information and Culture Ravish Kumar, Second Secretary Amit Kumar Srivastava, Ambassador from India to the United States:

Please see the three enclosed letters sent recently by this writer and journalist to the President of the United States, Joe Biden, the Vice-President of the United States, Kamala Harris, the Members and Chair and Vice-Chair of the Senate Intelligence Committee, the Members and Chair and Ranking Member of the Senate Judiciary Committee, FCC Chair and Commissioners Jessica Rosenworcel, Brendan Carr, Anna Gomez, Nathan Simington, Geoffrey Starks, and the Commissioner of Public Health, Quincy in efforts to alert all regarding the persecution, torture, disabling, diseasing, chronic illness, injury, and death being meted out to all in the USA and indeed worldwide using the unlawful mechanisms of Anti-Personnel Directed Energy Weapons, 5G, and Artificial Intelligence and Neuroexperimentation testing, operation, and fielding in addition to overt racism and social and psychological harassment, isolation, discrimination as well as KGB-style forced abductions, trafficking, and sale into mental asylum or psych ward captivity for False Psychiatric Labeling and Profiling being practiced by covens of EMS, physicians, police, and psychiatrists in efforts to silence, disappear, torture, and persecute people--as recently aimed also at my family and myself as described therein.

As a writer of Indian origin, long-term faculty at George Washington University's Department of English, and a trained journalist who has returned to journalism out of necessity, being so targeted myself, overtly since 2013 in the Boston area, and retrospectively also in the Washington DC area for years, most especially after the birth of my daughter in 2004, while I was teaching at GW and also at The Writer's Center,


Bethesda--where then Ambassador Lalit Mansingh's wife Indira Mansingh also took a class with me (please give her my best), I have striven to alert the nation of ongoing military, police, and medical crimes and continue to work as a journalist in this area. I continue to be persecuted and am doing my best to notify all regarding the great danger to my life and my family currently. I am reaching out to the Embassy to request that each of you kindly do everything in your power to save my life, the life of my family, and the lives of all Americans and Indian-Americans also so unlawfully targeted and under attack with Electronic Warfare Weaponry being hidden now as "Public Safety" "Public Health" and "medical/health technologies." I would suggest a primary way to begin doing that is to notify the Boston FBI, the Commonwealth Fusion Center, Massachusetts State Police, the local City of Quincy government that I am most certainly not a terrorist, criminal, or lawbreaker who ever needed to be wrongfully watchlisted, named a Known or Suspected Terrorist, and then disappeared by sale and trafficking into "classified" or Black Operations run by such as the CIA, DARPA, US Space Force, US Air Force, US Navy, US Marine Corps, US Coast Guard or other Special Forces, where people are then sold to sub-operations involving academic and research institutions and private corporations being engaged in massively unlawful, no-holds-barred, out-of-all-control Medical Device experimentation, Artificial Intelligence, Robotics and Cybernetics experimentation, Neural Network Mapping, and MK Ultra-style social and psychological deprivation, harassment, persecution and torture experiments; and that I need to be removed from all such experiments, scrutiny, surveillance, and watchlisting immediately, as also my family. Over the past 11 years, I have researched, investigated, interviewed, written, and spoken widely on these matters; my interviews and podcasts and articles can be viewed at my media website and magazine The Everyday Concerned Citizen.

As a writer whose work may be of interest to all Indian-Americans, my second collection of short fiction *For the Sake of the Boy* ([Paycock Press, 2022](#)) was published in May 2022 and may be ordered online there. I hope to send on a few copies to the Embassy via Paycock Press shortly.

The matters I write about in the enclosed letters may come as a surprise to many, as indeed to all in the nation and worldwide. Please read with care, please pass this information on to the Ambassador and the Indian Government, and please know I intend to continue writing and speaking widely on this subject as I can, in the days to come.

Dear President Joe Biden, Vice-President Kamala Harris, Speaker Mike Johnson, Senate Intelligence Committee Members and Chair Senator Mark Warner, Vice-Chair Marco Rubio, Senate Judiciary Committee Members and Chair Senator Dick Durbin, Ranking Member Lindsey Graham:

I am writing to request that you put an immediate stop to all Anti-Personnel Directed Energy Weapons/Counter High Power Microwave Weapons Testing operations in The United States of America and the world, as well as all JPSG, DARPA, DOD-CIA Artificial Intelligence, Brain, Robotics, Cybernetics, and National Institute of Justice Non Lethal, Less Lethal, Less Than Lethal Weapons or Technologies Experimentation and operation in the USA and elsewhere, as per your purview as public officials entrusted with the care of the American people's health, safety, and security.

In addition I am writing to request that you put an immediate stop to all classified, covered experimentation and operations being conducted by the CIA, DIA, NSA, DARPA, DOD, Air Force, Navy, Army, FBI and other covered agencies involving the use of human and animal subjects.

For the last 10 years I have been investigating, researching and reporting the unconsented-to, inhumane, and unethical use of Counter Personnel Directed-Energy Technologies on Americans and people worldwide. For the last 10 years as well, I have been brutally attacked, in my home, on the street, in my neighborhood, on trains, planes, buses, in my own car, in cities across the USA and in airports in Europe, in cities abroad—in India—with dangerous remote-access electromagnetic weapons, most usually RF HPM—Radio Frequency High Powered Microwave weapons, Pulse-wave and Continuous-wave—but also with heat-inducing millimeter-wave weapons, ultrasonic bone conductance weapons, infrasonic nausea and vomit-inducing weapons, scalp-grazing Neuro Strike weapons, extreme high frequencies inducing migraines and over-stimulation of the nervous and motor systems, neural weapons attacking nerves, electrical weapons inducing electroshock, neuroweapons inducing sudden sleep, slowing of the brain, neurodegradation, sudden removal of memory, vocabulary, syntax, grasp of language, reading comprehension, ability to read, ability to write, ability to think, sudden freezing of the muscles and movement, Acoustic Neurotechnologies used with military Circle Ops Psy Ops to induce high suggestibility, deceive, influence, alter behavior, and induce absurd beliefs, thoughts, and actions, as well as other dangerous

neuroweaponry neuro-hacking the brain in DARPA-Narrative-Disruption ways to insert externally-originating thoughts and images, experienced as external. In addition I have been subjected to other sound weaponry use of various kinds including LRADs (long range acoustic devices) making sharp hit-sounds on radiators and walls, Holosonic projection of sounds into rooms and 24/7 pulsed Directed-Energy-Weaponry use on my body with massive hard-hit focus on heart, left arm, right arm, left leg, left hip, face, head, neck, all limbs, private parts, hands: extreme pain, persecution, torture unremitting is what I have experienced and what I am reporting.

Heat-weapons, thermal-effect-inducing weapons have and continue to be continually laid at my spine, my neck, even in bed, while striving to sleep or rest, inducing subdural heat of intense persecutory nature, along with sprayed nanotechnology, impossible to shield from. Vibration technologies laid at spine and directed at chest have caused intense high-frequency fibrillation of the heart, vibration of the entire body in intense, painful shudders as I sit, read, try to write, rest, a continuous pulsing of energy of my entire body, biofield, chakras, shaking all ability to think, feel, be, while working it seems at a high cellular level to adversely alter cell health and DNA.

In addition I have endured several massive death-hits aimed at taking me out with massive hits to the heart; as a journalist subjected to assassination attempts I have reported on these nonstop at my website, in linked-tweet and -thread reports on Twitter, in video interviews with many; they have not stopped, and I am still compiling, recording, and reporting the incredible hits on myself.

Note, please, that I am a writer and journalist—past long-term faculty in English and Creative Writing at rather well-known Universities of high acclaim in the Washington, DC area, particularly George Washington University—who has interviewed and presented the testimonial of numerous other Americans, Europeans, British, Australians, as well as of FBI, CIA, NSA whistleblowers testifying to the tremendously persecutory ongoing assault on people with AP-DEW/Neurotech weaponry I am myself reporting.

Massively retaliated against for my reportage, I have been made the target of extreme online slander and defamation as well as focused, baseless persecution by local and state police, EMS, and their malleable affiliates in Boston-area hospitals for false psychiatric profiling and farcical KGB-like actions in attempting to label the journalist a schizophrenic with no credibility, clearly, in pathetic attempts by the desperate, the frenetic, the ill-educated to disappear the vital and needed National Security reportage

essential to ensuring true Homeland Security for one and all being provided by this Writer.

An Indian-American woman with Brown skin, I have been subjected to extremely harassive social discrimination, essentially racist, on a daily basis since late 2013, to my knowledge, in Quincy, Braintree, Weymouth, all over Boston and the South Shore area, in Massachusetts, in northeastern states, in DC, across the USA and on travels abroad, with massive noise harassment—vehicular, Power-appliance-run, voice-run, drone-and-plane-run—on sight outside on my street and in public, with absolute strangers issuing aggressively harassive signals of social “monitoring” (such as positioning themselves directly opposite me in narrow aisles in grocery stores, garden stores, clothes stores, pointing cell phones at me and full-on staring without speaking), intimations of social slurs, smear campaigns and innuendo, as well as harassive physical portable-device-run attacks on my body on sight by obviously educated “professionals,” usually men, but also women, in stores, at swimming-pools, community centers, YMCAs, expensive hotels, on the street (in Vermont, Connecticut, Rhode Island, Massachusetts, where my daughter participated in regional swimming meets) in clearly organized, city-wide, state-wide, and interstate campaigns of intentioned malice.

In Quincy, although an author who has won national recognition in awards and publication, I have been discriminated against even by the local library, the Thomas Crane Public Library, treated not as an author or writer whose warm emails and notices of book publication and offers to read at the library might warrant the courtesy of a reply email—at the very least—but apparently as a Quincy-marked “Known or Suspected Terrorist”, a label offered, I imagine, by the crooked Boston FBI after unlawful targeting on fabricated grounds by several local non-heroes and non-heroines who have crossed my path, in particular one Sinead Walsh of Adams Montessori School Board Treasurer fame, one Alexander Steffan, President, School Board, and Senior Counsel then at a Defense contractor, Haemoneutics Corporation, one Rosine Afshar, Principal of said school, my daughter's elementary school, and one Ashley Crittenden, a banker's daughter and mother of my daughter's friend, confidante and friend to Sinead Walsh, and their “friends in high places” inclusive no doubt of a decrepit Mayor installed in Quincy like a broken light fixture over 7 terms of persecution of the entire population of Quincy, a Thomas Koch, quite likely Nazi in antecedent, and his cronies, who might include the local network of Freemasons holding Quincy-ites by the throat here (Please see my [Communism Claiming Crisis](#) article) and no doubt other State players, virtuous in public and mercenary in private, all of whom together targeted myself and my biracial

family for an apparent sacrificial takedown through selection for persecutory Spectrum Neuro Bio weapons-testing, Brain and AI experimentation, Psych terror, life-takedown, and daily harassment, mockery, monitoring, racist exclusion, isolation, and discrimination for years both at the school and in Quincy—which has occurred.

[Quincy, the whole city, has definitely been targeted since 2013 for some major persecution, judging by the Air Force, Navy, and Army weapons-testing being carried out here, the removal of the lone bookstore, a Barnes & Noble, the removal of the lone hospital and ER, Quincy Medical Center, nonstop offensively loud construction, constant tearing up of streets, Mafiosi street and ghetto action cars and motorbikes ripping up and down streets even late at night by clearly commissioned rif-raf, and inordinate and aggressive Police street, drone, and helicopter activity.]

I have elsewhere relayed the account of the incidents leading up to the unlawful, wrongful targeting of myself and my family by the miscreants named above and the false, unlawful watchlisting and trafficking into “covered experimentation ops” indulged in by a decrepit and corrupt FBI, aided by their affiliates in a sinister and corrupt CIA. (Interviews, reports, letters, journals, logs, Medium, Steemit, and Substack notes.)

In recent times I have been relaying notice of the intense assaults I and my family have suffered to various officials including the FCC Chair and Commissioners, the Commissioner of Public Health in Quincy, the Secretary of Defense, the Director of the CIA, the ODNI, the Inspector-General of the CIA, and others. I have written in the past to various so-called officials at city, state, and federal government levels both to report these crimes and to demand that they be stopped. These include two Memoranda sent earlier to President Trump, one with hundreds of others, a letter to Attorney General William Barr, and a letter to the Governor of Massachusetts Charlie Baker, Boston FBI Special Agent in Charge Joseph Bonavolonta, Head of the Commonwealth of Massachusetts Fusion Center Lieutenant Christopher Mason, Mayor of Quincy Thomas Koch, and Inspector General of the Department of Justice, Michael Horowitz.

Massive assaults—akin to Blunt Force Impact Munitions Assault—on my left arm for the past nine months, exacerbated to point of disabling, prompted frantic, immediate letters to the CIA and the DOD; about 2 weeks ago, the extreme and suddenly intensified assaults with neuroweaponry, 5G, and directed-energy weapons from three houses right next door causing the tortured persecution and death of our family cat and the sudden injuring, debilitating, physical persecution with incapacitation of breathing of myself were

reported to the FCC Commissioners and the Commissioner of Public Health in Quincy. These letters are enclosed.

The avid torture (there is no other word) and persecution I and my family have endured due to the use of these weapons on us, and the overt racism and social discrimination and harassment attendant have been exacerbated in recent years with two unlawful Quincy Police abductions of my physical living self to dysfunctional and corrupt ERs in Boston, Steward Carney Hospital, Dorchester, and South Shore Hospital, Weymouth, where collusive and clearly-complicit physicians conspired to deprive me of all human rights in desperate actions to affix false psychiatric labels to my name and health record. Criminal actions on my body at these places, in particular the second, in December 2022, South Shore Hospital, Weymouth, included the unlawful, unconsented-to knocking-unconscious and strapping-down of my physical body (while physically sick with microwave radiation illness, something none of the ER docs or nurses noticed), implanting of a painful medical device in my left arm, implanting of putative nano or micro devices elsewhere on my back, spine, skull, a forced EKG with electronic/RFID sensor tags left implanted subdurally on my chest and by my heart, and subsequent extreme-attack remote-access by EMF signal on these unlawfully implanted devices and sensor tags, causing physical pain and obvious trauma. [Obviously, medical, diagnostic imaging and Radiology will detect the extant presence of these devices: I am not exaggerating; however the gift of False Psych Labels pinned to my name, starting with that first ER at Steward Carney Hospital in April 2022 ensures that I cannot now receive such care in any medical facility in America, as indeed was proved in December 2022 at South Shore Hospital in Weymouth, Massachusetts, at which ER I was treated openly and insultingly as a mentally ill depraved retarded Brown-skinned illiterate woman with no rights—whose speaking by the way, and notice of being a journalist proffered at the ER as well as a later request, post forced-EKG, for Radiology was not acknowledged, listened to or heeded.]

At both places, ER physicians got their way—by simply ignoring anything I said and steamrolling their way through to pre-planned physical capture for trafficking into their Maximum Security Psychiatric Wards: in the case of Steward Carney Hospital in April 2022, in actuality a floor titled 4 Southeast, a Substance Abuse wing, where I was held needlessly for 4 days post 2 days and nights in their Maximum Security ER, needing to jump through hoops trying to escape from (repeated conversations with so-called medical professionals there apparently failing to persuade them I was perfectly sane, a journalist, reporting police and military crimes, and having no need of their sinister

“Services”--Please see my Living Testimony [published here...](#)); in the case of South Shore Hospital in December 2022, their South Shore Mental Health ER wing (oddly named “Aspire” in the false medical records sent me later), and thence, post a second terrorizing Capture, Abduction and Trafficking from there by a Commonwealth/State Police-contracted Ambulance company to a separate, second, unknown external facility I learned later was Bournewood Hospital in Brookline, the Emerson I Building, where I was kept incarcerated for 8 days, again needing to maneuver excessively to get out of there alive, with obviously educated Psychiatric Nurses, Psychiatrists, Expressive Art and Occupational Therapists, Licensed Social Workers, and various planted inmate Surveillance Role Players—with all of whom I had fairly erudite conversations--failing to recognize I was perfectly sane, normal, with a home, family, and life I needed to return to, and a voice with which I could speak for myself as I asked continuously to leave and was denied: deprivation of human rights in other words, and refusal to honor any kind of patient rights either.

Insane in the extreme, these physical attacks have been compounded since, after I returned home on December 29, 2022, post those Police and Hospital attacks, with psychological persecution of an extraordinary nature in an obvious CIA Psych-Terror Escapade run through my spouse's workspot, Price Waterhouse, under what I have found to be an “Employee Assistance Program” with United Healthcare, the health insurance company which is now maintaining false medical records in my name, refusing to correct these despite request, Noticed recently therefore at my website ([Notice of False Medical records...](#), [Notice of False Section 12s, 10s...](#)). This program of psychological persecution—accompanied by much continued yet transformed physical attack with newer Vibrational, Electromagnetic, Neuro, and Acoustic weaponry—has included life-events surreal and incredible which I have begun to fully understand only across time, over this past year since December 2022: the undisclosed removal of my spouse from my home, along with my daughter—at an unknown time, and their replacements in serial wise, across months, the male intruders occupying the separate remodeled rooms upstairs—fashioned into a partial home-office daytime, with different impersonators playing him, with his distinctive voice, all in camouflage beards and mustaches and some of them obvious exact copies of him in many ways, in other words, what I came to suspect may be voice-cloned body-morphs or identical stem-cell clones, while the succession of young women and girls playing my 18-year-old child—whose age seeming to fluctuate thus I could not at all comprehend, imagining them all 18 and mine at first, only slowly beginning to comprehend they were all of different ages while

again all of them identical in some ways to my child, prompting my considered conclusion, across months, some were body-morphs voice-cloned in some way and some most definitely identical, if younger, stem-cell-clones of my child.

For several months it is now clear, I was kept in a state of unknown forced-medication, putatively by the spouse-impersonators or neighbor-takeover of the HVAC system; false “prescriptions” have now been found, which I suspect have been made by apparent next-door CIA sentient-warfare simulation warmongers, on the false PHI found (after I found my confiscated UHC health insurance card) to be maintained in my name by United Healthcare, naming the dangerous drugs Haldol and Lorazepam; note that when I was finally able to escape Bournewood in Brookline after being supposedly “discharged” by the CIA-troop of Psychiatrists and Nurses there, Dr. Richard Spiro, Dr. Raphael Weinstein, Christopher Neapolitano, RN, Michelle Prophet, RN, Samantha Bayuk, LSW, Madison Allred, LSW. who inexplicably admitted and held me there despite my immediate and continued notification to them of being there under duress, mistaken identity, and needing to return home immediately, there was no prescription, and no follow-up care or “care co-ordination” as I ascertained on the phone with Chris N. and Madison A. at and after departure. It is my conclusion, examining the events then and since that a CIA-run sentient-warfare simulation team is holed out in the Mazzeo house next door, 150 Pine, and making up one horrible situation after another to thrust me into: there has been a revolving number of Khazarian/Ukrainian/Belarussian/Israeli-seeming parties in there playing Joseph Mazzeo with a straggly red beard, glasses, and varying shortness in height, some with dark hair, some blond, some grey and white.

So much has happened since Bournewood, that is December 2022—and earlier, all of Fall 2022—that it is clear I was thrown deeper into occulted, classified, kept-undercover Psychological and Physical Terror operations involving I suspect DARPA, US Space Command, the US Air Force, the CIA, the US Army, DIA, and various Military Medicine and Research Labs, in addition to, I suspect, MIT, numerous Boston-based medical device, brain chip/BCI manufacturers, Artificial Intelligence and Robotics experimenters, graduate school programs and researchers, all after I was unlawfully gifted with false and progressively acredible labels of Acute Delusional Disorder, Bipolar, Unspecified Psychosis, Mania, Suicide, Harm to self, and more—all on the basis of nothing whatsoever (Please see my [Living Testimony](#) for the Carney labeling; my Account of events since Carney is still being written, I have almost been killed in the writing of it, CIA attempts clearly to stop it from being completed—but I Will complete it). The whole of that winter, late 2022 to 2023, with the revolving-entry into my home of strangers and

cloned children, we were all subjected to extremely loud LRAD sounds, poltergeist-style sounds at night, and during the day, furnace breakdowns and extreme cold, continuous sound hits on shielding I kept around me at night, plus projected sounds into my room, with Circle Ops Psy Ops scenarios being played out using both audio bugs in the walls and acoustic neurotechnologies such as neuro-AI—achieved via implanted techno-spy tech at ears at South Shore Hospital I suspect; I feared for the children's safety and well-being and sought continually to reassure each who visited. There were several occasions of intense vibration death-hits I suffered, intense nonstop hovering of planes overhead, exotic technology laid at my spine, my chakras, my head. I began to keep logs and journals, all of which have been stolen, putatively by the very spouse-impersonators who broke into my room when I was out on walks or drives.

Last March 2023, my car keys were stolen—keys to a new car bought in 2022 by (whom I thought was) my spouse after my car had a failed-brake incident and was taken in to the shop by him and not returned. Since then I have not driven anywhere. Throughout the time past December 2022, while I was being kept in my own home drugged and Haldol'd, unable to expose these crimes earlier, forced off the air on my video shows, my journalism and my writing at a standstill, my car keys stolen and withheld from me thus by one of the cycling-through spouse impersonators, assaulted tremendously with AP-DEWs and neurotech, massively cyberhacked, I was also subjected to alternately absolute silence and incomprehensible verbal abuse from the spouse-players, who actively worked to keep their accompanying child from speaking to or spending time with me, while the children were apparently trained to throw emotional tantrums out of nowhere for no reason, apparently both their intent to harass, provoke, gaslight, and induce accusations of child abuse or neglect, a Parallel Construction ploy of earlier DCF (akin to CPS) and police criminals, being played out now in what I can only deduce is a CIA-DHS-IDF-Police production—since the image of a continuing household with a replacement spouse and child—actually, multiple numbers of them, one pair at a time--was being supposedly maintained by this troop. False families, with false players, playing out pre-scripted abuse so I could be provoked into “acting out” against them—while DCF and Police moving in next door could witness the abuse and “justify” their false-claims of “child neglect” leveled against me by the CIA-QPS duo at Central Middle School in 2018, and DCF and Quincy Police could pretend they had saved the world from a raving schizophrenic with their earnest efforts to get me “medical treatment” via repeated trauma, terror, and trafficking, so that the use of microwave weapons, millimeter wave weapons, ELF (extremely low frequency) weapons, 5G weapon systems

and acoustic neurotechnologies on the local Quincy and larger US populace, and the secretive DARPA-CIA Cyborging, Robotics, and Machine Intelligence experiments on brains, bodies, lives, psyches, personalities, careers to break human bodies, burn, torture, mutilate, disable, attack incessantly for maximum pain and disability creation—a supposed need for “trauma-based mind control”, resident myth at the Hidden Hand whistleblower-racket pipeline to terrorize, silence, and deceive all non-consensual experimentee “targeted individuals” being controlled by false support groups--more likely merely to remove intelligent and dynamic people from society, involve them incessantly in their own pain management and desperate, failing attempts at healthcare, while making 24/7 victimized, living sacrifices of them and marking them as “unable to consent” in ever more deadly experiments on their brains, bodies, psyches to fully take over their brains and bodies remotely, replace their BNNs (biological neural networks) with ANNs (artificial neural networks): diabolical, insane, yet clearly approved by top intelligence and military agencies, kept secret by them—which I as a resolute Writer and Journalist, helping report since 2013, slated now for Grand Finale Paranoid Schizophrenia Takeout disappearance and victimhood myself, thereby silenced, could not stop being kept forever secret.

Now since last summer (the summer of 2023), fighting through the Haldol, while I have understood much of what has been done here, and striven to wrest back control of my home and life, I have understood rather conclusively that stem-cell cloning has been accomplished in the USA and apparently before 1965, the year of my (Anglo-American) husband's birth in Vicksburg, Michigan. I have also witnessed enough to privately conclude or speculate that genetic modification has been effected, putatively, experimentally on some of the stem-cell embryos; these are forbidden by law, yet have occurred. (Massachusetts Code for instance appears to forbid human reproductive cloning while permitting genetic modification in research of cloning.

Further, I have witnessed what I can only conclude is attempted overlay of BNN (biological neural networks) with ANN (artificial neural networks)--as indeed I too have experienced, in attempt, as I strove to recover my writing abilities succeeding obvious neurodamage—an outcome of experimental neural network mapping and EEG-cloning, matters surfaced by a few military neuroscientists including James Giordano and Robert Duncan—the latter whom I have interviewed and who has presented his work and views in a conference at my broadcast channel, Ramola D Reports. ([Existential Threat to Humanity](#), [MK Ultra on Steroids](#)....).

I am notifying you therefore of these matters and asking that you act immediately as well to shut down all genetic modification experiments conducted on humans, and both publicly acknowledge and terminate the stem-cell-cloning of children. The newly-understood theft of my child's stem-cells, through theft of my placenta, afterbirth, and child's umbilical cord post a home-birth in 2004 in my home in Arlington County, Virginia was reported recently to the Birthcare and Women's Health Center in Alexandria, Virginia, whose midwives assisted at my child's birth-event, but has not been acknowledged by them yet. The children created by this means—separate but almost identical, obviously need to be introduced to each other so no harm can accrue from their similarity of appearance and plausible use against each other or families by dark forces. As mother of all of them I can only regard each and every one of these children with the greatest love and care for their well-being. As witness to what I can only conclude is evidence of my husband also having been cloned, decades ago, on American soil, I must consider that such occurrences have taken place under cover and are being surfaced today by those behind the scenes awakening to a more inclusive future; there too I must see each of these clones of my spouse, many younger, as his brothers and my brothers-in-law, found family, to be aware of, to include, to care for. As one made aware as well, over the past year, via graduation brochures, of numerous high school graduation scholarships at North Quincy High School handed out inexplicably to single names—as also my daughter's—in what appears to be STEM-school NQHS impersonation fraud, I must conclude I am not the only mother becoming witness to and experiencing this awareness of a child having been stem-cell-cloned; this matter needs to be published worldwide.

This is not however the only CIA-Psych intrusion into my life over this past year and a half of sci-fi strangeness; when I returned home after that second bout of enforced captivity at a Boston asylum—no doubt set up for me to cast my credibility on this subject of cloning as well into doubt, while intended to be revealed to me shortly after—I was left not merely with no note of departure from my spouse and child, and no phone numbers to contact his family, my own family address books and phone had been removed, leaving me no way to contact my own family. My phone numbers seemed to have changed, my phone although seeming the same had been stripped of What's App contacts with family, and I was compelled to spend days attempting to find numbers from old emails, old address books, and relatives I could reach. Later an overlay of supposed cousin and family groups appeared on the phone, unreal and faked; I spoke twice to cousins whom I understood, through the conversation, to be not my cousins but voice

clones of the same. Family when I did manage to contact them—father, brother, sister-in-law—seemed to have been given a storyline of my supposedly having acquired “dementia” in addition to “delusion” who had “in a mood” asked my husband and child to leave (a clone storyline?) and needed “treatment to come to (my) senses.”

Neighborhood plants for the CIA, DIA, Army, DARPA, and weapon-wielders contracting with the Commonwealth Fusion Center to use NLWs—non lethal weapons—which the Police are working hard to pass off as “normative” Police technologies—they're nothing of the sort, they are tools of torture, oppression, and slavery being bio and neuro hacking and causative of immense bodily harm—have gone all out to reduce my bones, muscles, and nerves to a pulp, my brain to a morass of barely moving sludge, my eyes to being overnight-injured, and much else. I am being daily subjected to intense harm from the direction of all their houses in addition to being accessed and assaulted by numerous vehicular visitors to the street, inclusive of trash trucks and UPS trucks. I am speaking of remote-access remote assault. Satellites, drones, light planes, military planes, commercial planes, helicopters have also been used in the assaults against me.

Currently I am virtually in a state of house arrest, unable to drive anywhere thanks to my car keys being taken, unable to walk anywhere because the neighbors have been breaking in to steal things—including logs and diaries I have kept—mess with the HVAC system and furnace, tear up clothes, and steal marmalade, socks, earrings. [This is all CIA petty theft under Gaslighting Intent.]

I am reporting therefore to you that I and my family have experienced Physical and Psychological Torture in the USA, on American soil, in the 21st century.

I will be making my Reports of Torture, my Affidavits of Harm, and my examination of extant human rights laws, international, US Code, and Massachusetts Code, much more prominent in the days to come.

The witnessed gruesome persecution and cruel sadistic treatment of my gentle family cat by the immediate neighbors—the family occupying the 150 Pine, Joseph and Samantha Mazzeo residence, the 156 Pine, Chen Le Ming and wife residence, the 153-151 Pine, suspected QPD/QDC or/and DCF tenants of Brianne Higson Starsiak and Stanley Starsiak—and the experience of persecution I too was put through as he was daily tortured, deprived of breath and heart-health, incapacitated at muscle and joint, pushed continuously off the couch where he sat, dehydrated and nose-hit so he couldn't breathe—as I couldn't breathe—while we were both being hit by 5G as well, will never be forgotten.

I ask you all to step up and do the needful. Pull up all the records of secret, undisclosed watchlisting the FBI has made for the last 30-60 years, publish all lists of supposed suspected terrorists—people like me—sold into DARPA-CIA-Air Force-Navy-Army Death-Dealing experiments, toss out the entire lot of FBI and DHS skunk brigade who have created these false watchlists, and rout out every Classified-to-Conceal-Crime program run by the CIA, DOD, Navy, Air Force, Army using “human subjects” and “animal subjects.” End the programs of Cloning, Genetic Modification of Humans, AP-DEW Remote-Access-Assault and Brain-AI-Robotics-Next Gen Human Experimentation.
