Dear Commissioner Brooke Doyle, Misael Garcia, DMH RAO:

I am writing in response to a letter dated July 17, 2024 received from Misael Garcia, DMH RAO at my home on July 19, 2024, reproduced below:



It appears that this letter has been written in response to my (emailed and mailed) letter of June 21, 2024 to the Commissioner (on this thread, below), and that the date of receipt mentioned in Misael Garcia's letter, July 9, 2024, which on first read misleadingly suggests date of request, inaccurately referenced and needlessly obfuscatory, does not mention the date of my June 21, 2024 letter.

(Inaccurate dates have been noted by me twice before in correspondence from the DMH; I refer you to that previous correspondence and to the two earlier DMH Public Records requests made at Muckrock which occasioned that correspondence in 2022 post DMH-Quincy conspiracies and crimes against me in April 2022--the imminent surfacing of which may have been responsible for Muckrock's sudden freezing out of my account last year and placing it "under embargo," a curious action I certainly do not understand.) The spelling of the name there also is not correct; my family name is "Dharmaraj" not "Dhamaraj." ["Dharma" by the way is a word used in Sanskrit and many other Indian languages to denote Right Action, or the Right Way, or Service, or Sense of Duty, and "Raj" translates to "King"--a most fitting name for my father, a former Indian Air Force pilot, Retired Field Geologist and Almost-

Director of the Geological Survey of India, and a social philanthropist, guide and counselor to many, I might add.)

This letter from the "DMH RAO" is faintly mystifying but you are always welcome to clarify further. As I read it, in conjunction with the previous mystifying (and circular) letter on October 5, 2022 from Manza Arthur, Supervisor of Records, Public Records Division, Secretary of the Commonwealth, Commonwealth of Massachusetts, citing a Public Records Request from myself on "information on DMH and police procedures relevant to Section 12 Involuntary Hospitalization of living women on land and soil of Massachusetts State," one thing at least is clear: **DMH and the Commonwealth of Massachusetts have no information of this kind, meaning there are no DMH and police procedures relevant to Section 12 forcibly abducting living women into hospital-incarceration on land and soil of Massachusetts State, and there are no medical records held by DMH as in your "possession, custody, or control" for any such living woman--as I have certainly established I am.**

I appreciate therefore that the Department of Mental Health has finally realized I am alive, a living American woman, not bound to an all-caps name, not franchised, not a corporation, not an "individual" in the Corporate sense of that word, fully in control of all my senses and mental faculties, perfectly competent, fully private, on the land and soil, and that no one in Massachusetts or adjacent States has any right to approach me involuntarily in any way shape or form with intent to capture, abduct, kidnap, traffick, or transport me at any time anywhere including from my private home where I continue to live privately and non-criminally, as all of us indeed should and most of us do.

May I also remind you I am an author, a writer, a long-term college and children's instructor, former faculty at several Universities in Washington, DC, including George Washington University and American University, founder and leader of creativity workshops both in the DC area and here in Boston for several years, with several books yet unpublished, including children's books, nationally recognized for my work, a journalist from India who has returned currently to journalism succeeding the incredible assault on my life and family in Massachusetts since 2013? Which is what has led to my exploration of history, colonialism, privacy, and jurisdiction in the United States of America and persuaded me to establish myself as a living American woman, from India, standing with the native peoples of America in particular the Massachusett Tribe of Massachusetts on the land and soil of Massachusetts in the United States of America in addition to standing with the indigenous and migrant all over the world, the people of India and all nations, the First Nations, the United Tribes, the Crown of the Mauri Nation (the tribes of New Zealand, the Purple Thumb Community) as a living woman, mother, daughter of the land and surely co-guardian of all the bounties in flora and fauna of Nature we are surrounded by. I am a writer and journalist--keen to return to publishing and teaching in addition to journalism--living privately and working privately. I am not any one of the false psychiatric labels affixed wrongfully to my name--all in fraud--by so-called medical professionals

acting criminally. I take exception to such maligning and I appreciate that you, DMH, have now finally understood I am Private.

However it appears that the rest of Massachusetts including various persistently criminal offices in Massachusetts and the City of Quincy haven't quite gotten this message since I am daily being harassed, yelled at, falsely accused, threatened, intimidated, and bullied right where I live as well as subjected to dangerous and criminal actions from planted mercenaries right next door inclusive of unlawful nanotech-spraying and toxic-gassing--pretty much each time I step out of my private home (while silent, or quietly conversing with plants and birds (my prerogative) or on the phone) onto my front porch or yard or drive; frequent helicopter, light plane, military plane, and drone flights directly overhead including late at night; and continued assault along with numerous occasions of near-death-hits with unlawful, undisclosed, undiscoursed, unapproved, undismissed DARPA-NIJ/MilIntel radar/5G and sound technologies--which I have extensively investigated, researched, and written about--engaging in remote-access, through-wall, Fourth-Amendment-abusive, profoundly privacy-invasive and sickeningly intrusive assault, battery, violation, and near-assassination of my private body and brain.

Further, this DMH letter obviously does not address the factuality of the over 10-year-long physical assault with such electromagnetic and sound technologies I have meticulously detailed and reported, nor the actions of harm taken against me by various parties affiliated with and licensed by the Department of Mental Health which have included false records being placed and maintained against my name. These are still records being affiliated and attached and associated wrongfully with my living self by the entire body of actors playing Health, Healthcare, Medicine, EMS, Hospital, and Health Insurance, which need to be publicly--and especially to all these parties--expunged, struck out, terminated, as I have explained now in two letters both below in this thread, one to Commissioner Brooke Doyle and one to Jonathan Fox at DMH. I am not a ping-pong ball to be tossed about by every "Mental Health Professional" or unlawfully-acting contractor associated with the City of Quincy Police Department or the Massachusetts State Police who engages in false-accusation, false-allegation and convoluted attempts at framing as a matter of rote, planting themselves in my neighborhood and rushing out to enact skits, absurd self-abusive and child-abusive dramas, loud harassive assault of all in the neighborhood, sudden "calling the police" mania and attempts to further grab, arrest, detain, kidnap, transport and traffick my living self: this appears to be an ongoing and daily practice here and I am still working on reporting and recording every such occurrence: it is obviously **criminal**. In conjunction, I am subjected to extreme and racist harassment by every vendor and service-provider I encounter in person or the phone; this is obviously an Intelligence-intercepted-and-designed composite act of social-terrorism in the style of the Phoenix Operations in Vietnam aimed against me; conversations with pretty much anyone on the phone are made deliberately harassive and provoking and intended to try one's patience and then succeeded by on-the-street harassment by planted mercenary neighbors, as well as newly, since December 20, 2022, assaultive vibratory technology

attack **effecting Brain Damage and Bodily Assault** apparently playing "Public Safety" or "Behavioral Health": criminal political persecution of a practicing indian-American science and technology journalist, writer, and mother. All this issues and proceeds from the false "medical records" being maintained as if my health record against my name, starting with the very first DMH assault on my name in 2013 by Dr. Shubha Thiagarajan and her famously-5-minute-pronounced non-diagnosis of "Delusional Disorder" right after she heard the words "electromagnetic weaponry" and probably "crazed unlawful targeted surveillance" both over-10-year long subjects of my journalism now-- confirmed by the Department of Defense, the Department of Justice, numerous other investigative science and technology journalists, and numerous whistleblowers, and currently being further exposed and published in my journalistic review of declassified Air Force documents exposing the actual human experiments using electromagnetic weaponry unlawfully to disable, degrade, and destroy human bodies and brains. **It is not "Delusional Disorder" to report the facts.**

Or is the Department of Mental Health pretending the Department of Defense does not exist--or have both forged a careful collusion just kept from *The New York Times and The Washington Post---and The Boston Globe, The Boston Herald, The Patriot Ledger, The Quincy Sun?*

Although I am fully and absolutely private, standing on the Land and Soil jurisdiction of the United States of America and have informed everyone in Quincy and Massachusetts and the world of this fact, publishing as much on my website, I am continually attacked by planted mercenary Defense/Intelligence/Health/Justice human-experimenters and harassers as if "public"--meaning enslaved, locked inside the birth-certificate system, held dead underwater in Maritime Jurisdiction-- and as if I can be tossed back into this watery grave just as soon as I respond on the phone at any time to certain keywords related to it, such as "Social Security Number" or "Last Name" and can then apparently become a candidate for false-arrest and false-accusation all over again day after day; it is lunacy that the Department of Mental Health and the Police parties in Massachusetts continue to operate like unaware steamrollers under this delusion. It has become absolutely life-threatening at this point: I exist daily in fear for my life, given the huge amounts of military DEW/5G/Neuro technology aimed and used daily against me, which I am striving on every front daily with every party involved, to have stopped. The FBI, CIA, DOJ, DOD, DHS, NSA, State and Local Police, EMS, and City of Quincy are responsible for these crimes against me and against millions of others: the Department of Mental Health has no business capturing those unlawfully targeted and attacked by these agencies and naming them mentally ill in order to facilitate further physical attack, torture, life-erasure, human rights removal, and life-victimizing for lifetime brain experimentation and bio-behavioral research with Directed Energy & Neuro weaponry. I have publicly and privately reported these crimes worldwide as a Journalist and will continue to do so until they are completely and absolutely Stopped for all of us.

The Part the DMH Plays in Slamming People's Names

While it is becoming increasingly clear to me the CIA, DOD, FBI, QPD, City of Quincy, DHS/MSP, the Massachusetts Department of Mental Health, Price Waterhouse-CIA, Brewster-CIA, United Health and other health insurance providers are jointly responsible for the massive Lying Cover Up of DEW/Neurotech assault on myself and on all in the USA, I remind the DMH that you are primarily responsible because 1) you authorize "Mental Health" grabs in Massachusetts with your forms, codes, protocols, by means of which "mental health records" are fabricated--thereby 2), affecting the general and cumulative One Health Record-- of everyone 3), who is unlawfully and falsely pronounced mentally ill by any and every deluded psychiatrist in Massachusetts all of whom are obviously recognized as practicing psychiatrists and mental healthcare providers by you, Mass DMH; 4), you create, authorize or license every so-called "Mental Health Professional" -- that is, Police officer--set up unlawfully to work with city and state police to grab people and kids, and 5), you engage in questionable interaction, false authorizing and procurement of lies and confabulation from every unlawfully-knighted "informant/Behavioral Health observer" planted in neighborhoods, schools, colleges, workspots, public areas, doctors' offices, hospitals, on paid mercenary contracts or other kinds of affiliations; further, 6), you have established yourself as a Guerrilla Police Organization not a Healthcare Organization by way of these unlawful armed-police grabbing and incarceration practices which you encourage police, physicians, "informants," hospitals, ERs, drug-forcing psychiatrists, and drug-selling pharmaceutical company CEOs to rely on, and 7), you work with the CIA--the CIA! the unlawfully-acting, execrably military-mercenary-human-experimenting CIA!--to systemically lock people down into criminal, Psych-Terror-inflicted, incarcerative enslavement permissive of complete life-destruction and erasure of their names and lives. Finally, 8), you are unlawfully soliciting, procuring, encouraging, permitting, facilitating, and executing Brain Damage with deadly psych drugs and deadly vibrational technologies parading as "Public Safety" and "Behavioral Health" to "calm" and "pacify" millions of living, vibrant, vital, thinking and brilliant people including children handed false psychiatric labels alleging "diagnosis" and "psychosis" by "psychiatrists" AKA paid mercenary dehumanizers, assaulters, and degraders of human brains and lives. All this in addition to the fact that if you were not operating in such ardent execution of crime falsely affixing Death-Hit Labels to people's heads--and medical records--the entire coven of criminals in the Department of Defense--that's Air Force, Navy, Army, Marine Corps et al and Department of Justice--that's all the Police we have at State and City and County level, and apparently Sheriffs too--and CIA, and DHS and all the many other agencies practicing Crime on Human Bodies would not be facilitated nor permitted to run deadly human experimentation with DEW/Neurotech weaponry on people calling them "mentally ill" and "unable to consent" to these deathly, killing technologies which really are so good for them. [If this is not you, kindly let me know. I will also be making my own enquiries.]

As I have stated earlier: All "medical records" held by the DMH--or any of its affiliates, associates, agencies such as United Health, Optum, Aspire, or any hospital connected to DMH--using any form of my name and alleging "diagnosis" and assessment of any kind from any time are criminal defamations

and acts of intellectual aggression--accruing from, permitting, and encouraging actual physical aggression and exacerbated defamatory aggression against me; they need to be fully sent to me and fully invalidated, expunged, retracted, and terminated at the DMH and with all hospitals, EMS, institutions, agencies, insurance companies, police, fusion centers, people, persons, individuals, corporations, cities, states, commonwealths, militaries, universities with which they have been shared, by the DMH. The DMH, it is clear, is not engaged in the business of "medical" healthcare but active defamation, slander, physical aggression, confabulation, criminal procurement--and criminal repeat procurement--of police and EMS kidnapping and trafficking armed-mercenary and unlawful-drugging bully services, and I will not tolerate nor permit its continued actions of harm against me.

The DMH is not permitted to retain, hold, procure, disseminate, or confabulate any record or verbiage denouncing and defaming me as in any way mentally ill, in any way shape or form whatsoever; the DMH must correct the extant record held by all health-record consolidators such as One Health, police databases, hospital databases, and health insurance records.

I await further confirmation therefore from the Commissioner on this matter with verification of removal and invalidation of every single " mental health diagnosis" and allegation made against my name and being falsely maintained, by the health insurance provider, United Health, and other past health insurance providers, as well as by a slew of criminally-acting hospitals and MDs, police and fusion centers, as part of my supposed health record; as you have been previously apprised, they are all completely and absolutely false.

I also await further confirmation that my name has been removed from any and all "Public Safety" "Behavioral Health" "Mental Health" "Substance Use Disorder" "Collaborative Care" "Community Care" or similarly named and intending watchlists, notifications, databases with any and all parties including the Commonwealth Fusion Center and Boston Regional Intelligence Center, so my Life can be returned to me and I am not treated here and worldwide as a pariah, casually named mentally ill, dangerous, psychotic, manic, bipolar, schizophrenic, unstable, a terrorist, a troublemaker, an outlaw, a fightercock, a pedo, a psycho and so on--absolutely casual labels being picked up from the gutter of just about anyone's minds the DMH-CIA is currently authorizing including police-artists living next door and working hard everyday to attack me--while being blasted to death with numerous radio frequency and acoustic weapons hidden as "police technologies" and "Public Safety" and operated by these absolute criminal mercenaries from right next door in my own home. Who have armed pickups, minivans, SUVs, sedans parked in their drives and directly opposite my home, issuing forth over 50 Microtesla, one Honda CRV recorded recently as emitting over 120 Microtesla just outside my door: these are pulsed heart congestion frequencies (near 50) and pulsed muscle fatigue, bone destruction, brain damage, overheating and overall health degradation radio frequencies at anything over 50. Note, these are all paid and parked contractors who live and work in their homes all around the block and work collusively to engage in mass swarming, street-theater-acting, noise-harassment,

mold/toxin spraying, cat-killing abuses (Yes, they have killed my family cat, please see my letters to the FCC, QDPH, et al) against those they are themselves being permitted to assault also as "Behavioral Health" minders, these assassins. False psychiatric labels casually pulled out of thin air and affixed to one's name by psychiatric criminals are being used to then run Parallel-Construction provocations by these neighbor assassins in invitation of "self-incrimination" actions; naming me "bipolar" casually and baselessly at Bournewood for instance after 9 days of carceral though congenial engagement with staff, Richard Spiro, MD has ensured that each time I speak inside my home or outside, each time I sing or speak on the phone, each time I raise my voice for whatever reason, by myself, inside my own private home, neighborhood mercenary eavesdroppers rushing to use electronically-beeping bioscanners on their deck and drive rush to inform their bosses--the Police and FBI?--who then increase their fraudulent 90-day NSL investigation periods, interminably, amp up their "Public Safety" Vibrational Technology CIA-NIJ clearly Nazi "Calmativ" radiation attacks on my spine and head to shut me down, and act to keep my family from returning home: my daughter and spouse have thus been kept from returning home by criminals enacting continuation of fraud for over 2 years now, as the DMH's actions continue to socially-isolate, socially-attack, police-attack, and milIntel-attack me.


Hi, Jonathan Fox:
