Letter of Notice of Privacy, September 16, 2024

Dear Amy Sullivan, "Protective Service Advocate":

I am in receipt of your rather extraordinary letter of September 12, 2024, delivered to my mailbox today, on September 16, 2024. I'm quite concerned, both as an Author, Publisher, and Journalist about your rather cavalier note of having "received a Protective Services report of concern for your health and safety" with no further information being given, particularly on who might have made such a "report of concern" to you regarding myself. It's curious also that you believe that your "agency"--which I've never heard of before and certainly do not wish to engage with--"is required to complete an assessment of your situation". Why would you imagine your intervention in my life is needed? And it's beyond hubristic for you to inform me you are "taking the initiative to schedule an in-person home visit on Friday 9/20/2024" at 10 am. No, you're not.

Please permit me to inform you I do not need and will not need your services now or at any time. If you would like to send me information on who exactly might have sent you a "Protective Services report of concern for (my) health and safety" and what exactly your "Protective Services" is all about, for journalistic purposes, please do so, by email only, and I will be glad to publish it for my readers in Massachusetts and the international community, who might be interested in hearing about the form of hubristic Communism you appear to be practicing. Beyond that, I do not wish to hear from you. You are not permitted to make arbitrary visits, scheduled or otherwise, to my home. I am a Writer, Journalist, living American sovereign and Massachusetts state national situated lawfully completely outside the falsehoods, lies, and criminality of Maritime Jurisdiction, living privately on the land and soil of Massachusetts. I will be publishing your letters and this Letter of Notice of Privacy for the edification of all. Kindly be advised we do not have a "in person home visit" scheduled for Friday 9/20/2024 at 10 am nor for any other day and time. You—nor anyone from your presumptuous organization-- are not permitted to come to my home, to walk up the front walk, or to enter my porch or to knock on the door or to ring the doorbell. You are not permitted to call me at any time. You are not permitted to accost me anywhere outside either at my home or elsewhere. This is a Letter of Notice of Privacy in writing, kindly file it away in your records and let your Maritime/Admiralty Jurisdiction colleagues know your "Protective Services" do not and will not ever apply to me. I will be copying this letter to my spouse, and trust it reaches you well in advance of Friday. [If not, be advised, I will not be answering the door—and I will expect that you receive this email and read and understand it fully.]
