FOIA Request for Information on Yet Another Unwarranted Quincy Police Visit to my home on Sunday October 6, 2024

Dear Ms. Crispo, City Clerk and Records Access Officer, Public Records Manager, Quincy Police Department:

In light of the Freedom of Information Act and all public records laws, could you please provide the CAD Incident Report and all correspondence, emails, video and audio footage and recordings associated with the unexpected and unwelcome and disorderly visit by 2 heavily armed Quincy Police Officers to the home of this Author on the morning of Sunday, October 6, 2024, (yesterday) with unruly ringing of the doorbell on and on and massive banging on the front (glass) door?

It is beyond comprehensible to this Author why Quincy Police should keep coming to the home of this Author, particularly after repeat Notice given of her privacy status, as noted in a recent FOIA Request Report at her media site and magazine *The Everyday Concerned Citizen* online.

Quincy Police have been twice unlawfully engaged in false-claim and false-premise Abduction, Kidnap, and Human Trafficking of this Author, in April and December 2022, matters she has written to the previous Chief Paul Keenan previously about, and matters she has apprised the new Chief Mark Kennedy on, matters she is still addressing with various parties including the Department of Mental Health, unlawfully engaged, with Quincy Police and Brewster Ambulance, in collusive Character Assassination, Defamation, and Slander of this Author. This Author is never going to be opening her door to Police who have previously attacked and abducted her unlawfully on false claims to criminally-acting hospitals (Steward Carney Hospital, South Shore Hospital, Bournewood Hospital) and equally criminally-acting, out-of-jurisdiction courts (Quincy District Court) and EMS (Brewster Ambulance, Midwest Medical). Attempts to intimidate and harass this Author with ambush-visits to her home, removal of her metal-shelving barrier placed on her porch, and rude doorbell ringing and door banging are out of place, unwarranted, and must be stopped. This visit comes on top of an extremely grievous attack on this Author and family's healthy 12-year-old cherry tree in her front yard very recently by the Department of Parks, on October 3, an earlier inexplicable attack on the Author and garden by The Department of Public Works, and recent inexplicable attacks by Quincy Fire and Quincy Police, continuously FOIA-queried on, and reported at her media site.

It has become apparent some systematic and plausibly racist harassment has been unleashed here, and it is strongly repudiated. Please provide all records in pdf format, mp3, and mp4 format by email; all records will be used to make a report for all; kindly let me know if any copying fees apply. As Media working hard for humanity, I do ask that all such fees be waived in the public interest. Thanks very much,
