Dear Nicole Crispo, Quincy City Clerk and Records Access Officer, David Murphy, Commissioner of Personnel, Parks, Department of Natural Resources, Captain Mark Kennedy, Chief of Police, Quincy Police Department, Public Records Manager, Quincy Police Department:

Yesterday morning I was once again attacked in Quincy in my own private home by members of the Department of Parks wielding dangerous saws and blast-cutting branches of our cherry tree situated well inside our front yard--our Private front yard and garden--and overhanging no sidewalk. I have described this attack at my website at Notes and Updates, October 3, 2024. This follows on a DPW attack on September 4, 2024, also reported and FOIA-queried about. In light of the Freedom of Information Act and all public records laws, can you please provide me the reason for this attack?--Please provide any Incident Report related to this extreme invasion of privacy and unlawful assault on our private foliage, plantings, space, and tree. Did someone actually call the Department of Parks and request a hatchet job on our tree in broad daylight on October 3, 2024? Who was this person? Why would someone do this? This is Private Property, we live privately in our own home, as does everyone in Quincy and the whole of Massachusetts. Is it customary to send men wielding saws onto people's private homes and attack their beautiful, healthy, completely private cherry trees? I don't think it can be. The men who did this also ripped my Privacy notices from the wall of our front porch, and placed our garden metal shelf with Notices on it at the curb, with Yard Waste cans: What kind of behavior is this? The Department of Parks does not own our home or garden and cannot send their bully terrorists to come wreak mayhem on our front yard or flowering garden tree. We are not living in a Quincy Park. Our cherry tree is my own baby, planted in 2012 as a sapling, blooming beautifully every spring, and bringing beauty every fall with its gorgeous red and yellow foliage. Its leaves and branches sweep down gently over our front walk--our Private front walk--and the other side of our yard--our Private front yard. Quincy Department of Parks personnel are not permitted to enter our Private front yard or garden--or touch our Private wildflower strip in front either. I have posted Notices of Trespass now, and red Private Property signs on both sides of our Private front walk. Am I supposed to expect every Department of Quincy to come and engage in some kind of major mayhem on my yard, side of my house, foliage, trees? How bizarre is that? I assure you, it's Not Normal. The City of Quincy appears to be insanely fixated on harming me and my home: kindly knock it off. It's absurd, and I would appreciate all Incident Reports, Event Reports, however Parks records such carnage, sent by email please; if there is any audio/video footage also associated, kindly send on. I hope to report this shortly. I was unable to post the film I made of this crime--forced to record when terrifying-looking men land at my home, unable to even go out to speak to them, to stop them, after what the DPW man did to me on my front yard on Sep 4 and what Quincy Police reported that falsely as, as "Disorder," when that was Abject Crime, an Attack, a Criminal Attack--I was cyberhacked intensively last night (from next door I suspect, a CIA-DHS stronghold at 150 Pine, or "Data Interception Unit" cars run by Boston FBI on the street outside) when I sought to post the film. I am not here to be terrorized and victimized. I am a Writer, a Poet, a Playwright, past College Faculty, a children's book writer and Creativity Workshop Leader, a Publisher, an Editor, an Author, an Investigative Science and Technology Journalist. My husband is an Attorney, a Tax Law Director at Price Waterhouse. Why are we being terrorized in

this way? Please stop all these attacks on me, my family, my home, my garden, my life, and please send me all records. I cannot be silent, I must report these crimes, as a journalist.

Thank you.
