Letter of Request, November 1, 2024

Dear William Francis Galvin, Secretary of the Commonwealth:

I am writing in relation to the letter of response (enclosed) to a FOIA request I made recently, received from Quincy Police Department on October 27, although dated October 16, 2024.

I have been sending in a few Freedom of Information Act requests lately to the Quincy City Clerk and Quincy Police given numerous intrusive and terrorizing visits to my private home by numerous Quincy Police lately--midsummer and late summer, as well as acts of criminal intrusion by Quincy Public Works and Quincy Works, all it appears in collusion with criminally-behaving mercenaries who appear to have planted themselves close-by in my vicinity, matters I have continuously been reporting, as a journalist, at my print and broadcast media site, *The Everyday Concerned Citizen*. In response, I have been noticing, I am receiving "CAD Incident Reports" recording avid lies and fabrications, a matter I am yet to fully report, but will, shortly. My preliminary reports can usually be found at The ECC-FOIA Request Log at my website.

As you may recall, I have indeed sent on notification of my fully expatriated changed status in my return to Land and Soil, as a living American woman, unincorporated, and Massachusettsan, originally from Virginia and earlier, a live birth from India, who has now adopted Massachusetts as my home, a matter also published in *The Quincy Sun*, and recorded at the Land Recording Office. Quincy Police therefore cannot have any interaction with me, nor can they keep landing at my doorstep demanding to speak to me, nor can they send emissaries to attempt to abduct me off my front lawn--which latter horror occurred on October 8, 2024, as I have reported.

This particular response includes a cover letter and two CAD Incident Reports sent to me by a "Lieutenant Terence McDonnell", both of high concern, with their allusions and allegations which must immediately be set to rest.

1. CAD Incident Report #24052015 alleges a "Serviced" Incident of "Incident Type:509 POL INFO" [Not comprehensible to me, not clarified, not described online as per my research] by a CR1 Tim O' Brien, Personnel Id 9876, and a Y10 J. Ryan, Personnel ID 1604 at 11:36:15 am on September 23, 2024, neither of whom I witnessed or heard or recorded that morning. If this incident relates to an unlawful remote access of unlawfully-implanted RFIDs or other sorts of "medical devices" or any other kind of "devices" implanted in my physical living body by unlawfully-behaving physicians or surgeons, operating either under "Controlled Access Projects" or "Special Access Projects" -- or any kind of alleged "Public Safety" or "Public Health" or "Behavioral Health" project --on the unlawful trafficking of my physical living body to South Shore Hospital, Weymouth and Bournewood Hospital, Brookline by Brewster Ambulance, Midwest Ambulance, Quincy District Court, and Quincy Police on December 20-29 2022, or to Steward Carney Hospital, Dorchester by Brewster Ambulance and Quincy Police on April 14, 2022--as I have publicly reported and testified--then this is most definitely an unlawful, unconsented-to access, touch, and invasion of my physical living body and my privacy, sanctity, and autonomy of body, life, and property, which is herewith strongly repudiated, which kind of access must be completely and absolutely stopped, immediately. "Crisis Unit Officer" Tim O' Brien was in fact unlawfully involved in the wrongful arrest and trafficking of my living body on April 14 2022 to Steward Carney Hospital, Dorchester, on False Claims

from a woman across the street who distinguished herself then and has since distinguished herself further as an Entrap-Attempt screamer, who engages freely in loud false accusations and rampant child abuse of her own, I presume, foster-care children, sadly being used for, it appears, noxious and quite lawless police purposes; I have reported on this matter at length in press releases, interviews, and in my Living Testimonial regarding April 12-19, 2022. "Lieutenant" Terence McDonnell, further, was also involved in that crime, engaging in collusive conspiracy with this woman to unlawfully arrest and force a so-called "Medical" transport, which proved to be as reported, criminal incarceration on False Claim, with False Psych Labeling intended and attendant. All reprehensible, to be condemned forever, and never to be repeated. Also noticed, on this CAD, the "Municipality" of "1 QUINCY": I am not in this Municipality; I am Living, Alive, in Land and Soil Jurisdiction in The United States of America, there are no courts for me in this "Municipality", I have fully expatriated and reconveyed all forms of my name to Land and Soil and no-one in this Municipality can touch my physical living body, or my land, or my property, or approach me on my land, private way, front walk, steps, porch, private home, nor can anyone falsely claim me as "Mentally Ill, Delusional, Acutely Delusional, Bipolar, Schizoid, Schizophrenic, Danger to Self and Others" or any other; All False Psych Labels falsely affixed to my name and held falsely in so-called "health records" "digital health records" "electronic health records" and any kind of record in any kind of database, compendium, system in Massachusetts or the USA, whether Police, Health, Intelligence, or other, have been and are completely and absolutely Invalidated. In no way shape or form can anyone anywhere miscast, misrepresent, accuse or allege this writer is or was of "Declining Mental Health" or associate her with any DSM-invented Psych Label, all of which are strongly repudiated by this writer as Defunct, Obsolete, Meaningless, and Criminal. They are clear attempts to deprive people of all rights, and this writer is in no way permitting anyone to deprive her of any rights, as a living American, living quietly, privately, and peacefully, engaging in meaningful and productive pursuit of journalism and communication, writing, art, scholarship, and poetry, for the benefit of all, at all times. The Department of Mental Health has been apprised, and so has Quincy Police.

2. CAD Incident Report #24052019 alleges a "Unfounded" Incident of Incident Type "524 HPO/VIOL" [Also not comprehensible to me, no information online], described as "Scheduled" with Incident Date 9/23/2024 at 11:55 and Modified Date 7:08:22, alleging a "Reporting Person" "Quincy District Court" and a "Call Taker" noting a "Document No. 202456HPO1182, Exp. 10/2/2024, DEF-RAMOLA DHARMARAJ" -- Nothing that I know of or have ever been apprised of, not a court order from any hearing I was ever a part of, there being no court in the Commonwealth of Massachusetts where I can enter, and Quincy District Court certainly being no court I would ever enter or have anything to do with, given their execrable and criminal behavior to me on December 20, 2022, as reported recently in FOIA Request reports to them and in a Letter recently to Brewster Ambulance CEO, Mark Brewster. In other words, this alleged document here, which I am surmising relates to some sort of "Health Protection Order" perhaps is completely unknown to me, it is False, it is Bogus, it is Fabricated, and it is absolutely shocking and incomprehensible to me how something like this could even transpire, for clearly someone--some group, some party of miscreants--has invented and recorded this Document as if legitimate, as if lawful, and has dared to attach my name to it, as if I were in some way a dangerous and unstable person with a "Health Protection Order" needed and affixed. This is a travesty and must be reported and condemned widely, it must be removed from all association with my name, and it must be invalidated internally as well, by all parties involved--and I presume, from their mention here, Quincy District Court and Quincy Police are two of these parties. Further, this CAD Report alleges that there are two "Persons" apparently involved, one marked Person 1 and (SU) written after it listing my name, one with "Person 2" and (VI) written after it listing "Joseph C. Mazzeo of 150 Pine Street", who (in all this Name's multiple holdings by multiple men) has been involved in many acts of dangerous and criminal behavior against me--including cutting our foliage without permission, summoning an uncouth and criminally-behaving Quincy Public Works man to attack me and our front garden and cherry tree on our front lawn, stalking and harassing and persecuting me for years including with RF HPM and other Spectrum Weaponry from his car and shed, throwing dead rats and birds into our yard, burning our bushes and trees with RF HPM, sending LRADs into our house as well as Neuro-hits and switched-on 5G killing our cat in March of this year, sickening me extremely, sending ELFs from a powerful car engine, kept running nonstop, into our house, spraying noxious smells and gases into our yard and home, including with car exhaust, indicating in many ways he and his cronies are unlawfully running espionage and brain and directed energy experimentation operations against me--as I have Noticed and reported publicly, but with whom I have no interaction, no relationship, no communication, and certainly no knowledge of connection with this False Document noted above. Nor do I follow what "SU" and

"VI" are. Further, on this CAD Incident Report, there are concerning notations of intended escalations as in "777 requests 2-car response for all further attempts." It appears to this writer this criminal and plausibly CIA-DHS-foreign operative "Joseph Mazzeo"--a Name used to hide many men; this writer has witnessed many men step in and out of that house next door, 150 Pine Street, and reported on same--after committing numerous crimes against this writer and family and receiving a Notice of Fine and Trespass from her has sought to criminalize her instead, with False Claims, False Allegations, and apparent Quincy District Court collusion in creating False Documents--which I have never been apprised of, nor participated in hearings to acquire--which are therefore operating as Secret Documents, Secret or Fabricated Court Orders, and Incitements to Quincy Police to falsely pursue, attack, and invade my privacy at my own private home: This is unlawful Secret Behavior and unlawful use and abuse of Police to attack a peaceful living woman who is American, Indian-American, and living and working as a needed writer and journalist, reporting especially on matters of today's science, technology, and ethics, for the benefit of all. Please note, this writer has no criminal record attached to her name, but a whole lot of Lies, Fabrications, and False Allegations instead, from avid criminals, over several years, since 2013, when she was first unlawfully attacked by an unlawfully-acting Military-Police-FBI contingent, unlawfully watchlisting people in order to draw them into unlawful and unacceptable Brain Initiative and other similar projects--all of which are strongly repudiated, never consented to, and which must be stopped immediately and forever, both in this writer's case and in all others' in Massachusetts, and in the entire USA, and in the entire world.

3. The cover letter from "Lieutenant" Terence McDonnell suggests investigations and investigative techniques which need to be kept secret for "effective law enforcement": If this is information being gleaned from this writer's brain and body through unconsented-to implants of any kind or "medical devices" of any kind, implanted in her body and brain at any time, in any hospital, or in her home, by "intelligence" miscreants, or via installation in her vicinity of audio and video bugs, cameras, microphones, recorders, whether inside car parts, hoods, trunks, or garage shed walls, insides, house walls, floors, attics, basements, furniture, lawn implements, deck fixtures, grills, or any other--then it is all information unlawfully acquired, never given, never consented to, never offered, and must be completely and absolutely stepped away from by all such powerfully criminal parties acting in secret, in clear malintent, in denial of all laws and the Constitution, in particular the Fourth Amendment whereby no one living in The United States of America can indeed be so invaded, their home invaded, their privacy invaded, their body invaded, their brain invaded; these activities of supposed law enforcement therefore are highly suspect and must be stopped. This writer gives no-one in "Law Enforcement" any rights whatsoever to touch or access or engage her body in any body part, in any implanted RFID, implant, or device, BCI-CBI, or any other, nor does she give anyone such rights. There is no law that "Law Enforcement" can lay claim to in engaging in any kind of investigation or using any kind of investigative techniques on her, around her, or surrounding her, in collusion with "witnesses or informants." Quincy Police cannot inform this writer she is the subject of a secret investigation, nor that "this matter is currently awaiting action within the Trial Court system" when she has never entered nor will ever enter "the Trial Court system." Nor can Quincy Police inform anyone else in such a manner, implying this writer is seriously deficient in integrity, virtue and lawfulness, which she is not. Suggesting in fact that this writer is a subject of "ongoing investigation" in relation to a matter liable to result in "criminal prosecution" is Character Assassination, Defamation, and Slander. This writer has a reputation to protect, and is protecting it.

I do hope you will kindly inform all in Quincy Police of these facts, and ensure they will no longer come by to attack and terrorize and invade this writer's Privacy in her home, her land, and her body. Kindly inform the CIA as well, and the DHS, and the FBI, and the NSA if need be; this writer has long been investigating and reporting on all matters "emerging" and "innovation" energy- and neuro-bio- and cyber-technology-related from the Military and Justice departments which today have been transferred without consulting the people onto the streets and neighborhoods of our home country, and which should, in this writer's opinion, as a matter of preserving all our human rights and freedoms, be abrogated at once. The intelligence agencies in particular may need to be most insistently advised. And removing harmful devices from the possession of all would be a very good start. "Law Enforcement" in particular may need to be re-educated in better ways of Truth-based, non-technology-assisted peacekeeping.



Response of Records Access Officer

Ms. Dharmaraj,

On October 2, 2024, we received your request pursuant to the Massachusetts Public Records Law for records pertaining to incident # **24053171 (9/29/24)**.

With respect to your request, the Department intends to withhold these records due to the applicability of the following exemption and the reason set forth below:

Exemption (f): This exemption applies to “investigatory materials necessarily compiled out of the public view by law enforcement or other investigatory officials the disclosure of which materials would probably so prejudice the possibility of effective law enforcement that such disclosure would not be in the public interest.” While this exemption is not a blanket exemption, it applies to such information, the disclosure of which would prejudice investigatory efforts. In particular, it applies to information related to ongoing investigations, confidential investigative techniques and information which directly or indirectly identifies witnesses or informants.

Specifically, given that this matter is currently awaiting action within the Trial Court system and may result in criminal prosecution, the release of such sensitive material would constitute an undue risk to successful prosecution in relation to this case.

I have provided all other records in the Department’s possession that relate to your request.
