Description of the Request :

For all US Air Force Directed Energy Bio-Behavioral or Bio-Effects Research (DEBR) or any other counter-personnel Directed Energy contracts in the United States of America—currently ongoing as of today's date, past and renewed, or past and completed, from 1994 until today, or as relevant from inception--using Directed-Energy Weapons (DEWs), Non-Lethal Weapons (NLWs), Limited-Effect Weapons, Less than Lethal Weapons, Intermediate Force Capabilities, or any kind of Electronic Warfare or Homeland Security or Distributed Common Ground Systems Testing/Training involving the use of energy, radiation, or acoustic weaponry, neuroweaponry, sound/light, nano, neuro, BCI, or related technologies of any kind whatsoever on "human subjects," whether to determine the "human effects" or "bio-effects" or "behavioral effects" of such directed energy application, for radio dosimetry purposes, or for any other purpose, please provide:

1. The full USAF contract inclusive of Contract award documents, Request for Proposal, Executive Summary, Statement of Work, and Final Report;

2. Complete Documentation of Informed Consent from all "human subjects" targeted by this contract's Bio-Behavioral Research or Weapons Testing and Training program, including:

(a) The FWA (Federal Wide Assurance) signed off by the Office of Human Research Protections, Department of Health and Human Services;

(b) Any additional internal Air Force Assurance document assuring compliance with the Common Rule signed off by the Air Force Institutional Review Board involved;

(c) Any additional Department of Navy or other US Government or military agency document assuring compliance with "Human Subject Research Protections" such as the Common Rule;

(d) All affirmations of Compliance Oversight from the Office of Human Subject Research Protections; &

(e) All Waivers of Informed Consent from the Secretary of Defense or other authority, if and as applicable, and full reasons for these waivers.

3. Complete Documentation on each contract with precise Details on Location, specific Air Force Base, Region, or geographical Field or Area of Operation where these Directed-Energy weapons are being trained "wittingly" or "unwittingly," overtly or covertly, on "human subjects"--that is, American civilians, veterans, and others—other nations' civilians and veterans--residing in or visiting the USA;

4. Commercial and financial documentation with details of cost/price associated with all aspects of the DEBR/DE-related testing noted above on all human subjects;
