Dear Public Records Managers:

On December 20, 2022, I was unlawfully detained and captured at the premises of the Quincy District Court by EMS personnel from Brewster Ambulance, unlawfully strapped into an ambulance, abducted, kidnapped and trafficked thence to South Shore Hospital by Brewster Ambulance, and, it appears, Quincy District Court and the Quincy Police Department, who were both instrumental in unlawfully abducting me earlier from my home (where in fact that day I was resting quietly, being physically ill), detaining me for an extended period of time in a jail cell at the Quincy District Court where they seem to have unlawfully toxic-gassed/"medicated" me, basically, knocked me out with dangerous and unknown drugs, all for no reason whatsoever, then called Brewster Ambulance who have fabricated and noted lies in a "Patient Care Report" they have written up regarding this event and series of events.

As a reporter I am examining all aspects of this scenario to report it accurately.

In the parking-lot, where I came to after being knocked out (for no reason whatsoever, no incident had occurred to warrant any kind of "need to placidate" as I looked for an exit door and sought to leave the premises of the District Court where I had clearly been brought under duress in a case of mistaken identity, as I verbally informed Quincy District Court officers at the time), presumably by Brewster EMS personnel, I found myself strapped into a stretcher outside where a Norfolk County Sheriff van stood open, and a presumed deputy stood beside it. I spoke to the deputy and told him the Sheriff needed to take me home, upon which he smiled and closed the open back of his van--as if that should have meant something. I was thence loaded under duress and unlawfully into the Brewster Ambulance and trafficked to South Shore Hospital.

In thinking about this incident, I have finally realized that clearly the Norfolk County Sheriff van and this deputy were parked there for a reason, in some way acting as Witness to the crime. I cannot fathom however why or how the Sheriff/deputy would stand by and stand witness without speaking with me further and in fact permitting an ambulance run which was wholly unneeded, as I was verbally stating to him at the time. Please note: That Brewster Ambulance run, the capture, and detainment, were all part of the crime here under investigation. Even if the Norfolk County Sheriff van is generally parked at the Quincy District Court for other purposes, there was no discernible reason for it to be parked there while my physical living body was being unlawfully abducted for the second time that day by a group of strange men.

Can you explain to me therefore what the Norfolk County Sheriff van and deputy were doing there precisely that day and that moment?


Can you please provide all records--incident reports, emails, phone calls, communications, body camera video recordings, any other audio or video recordings--maintained by the Norfolk County Sheriff regarding this event on that day, December 20, 2022?

As a journalist, I was clearly being unlawfully targeted, detained, abducted, defamed, and trafficked under false-claim. Did the Norfolk County Sheriff's office have all the facts that day or were they deceived, and if so, by whom?

I would be glad to receive all information by email and by mail as convenient.
