Dear Nicole L. Crispo, Records Access Officer:

On May 30, 2024, a man living across from my private home at 153/151 Pine Street and driving a black pickup truck which is kept RF-armed--as measured often with Electromagnetic Field Meters when he has parked this truck very close to our home--putatively linked to the Quincy District Court and Quincy Police Department, as revealed by uniformed arrival in a police car before he moved into the house opposite our own in July 2023, was witnessed and recorded speaking with two police men he had called wrongfully with false-claims against me, mentioning some program of putative monitoring. He seemed to suggest he had been engaged in this monitoring program in our neighborhood and that it "was not working out" whereupon the QPD detective or sergeant he was speaking with assured him he would return the next morning and "take her out", apparently referring to me. I have done FOIA requests about this untoward Quincy Police visit on false-claim and received only a CAD incident report filled with false-claims and lies, as I have assessed and reported here earlier: <https://everydayconcerned.net/foia-request-reports/foia-request-report-quincy-police-cad-incident-report-for-may-30-2024-reveals-egregious-and-unlawful-false-claims-by-both-planted-mercenaries-fusion-center-contractors-brianne-and-stanley-starsiak-t/>.

Today, March 25, 2025, this man has once again parked his black pickup truck, armed with pulsing Radio Frequency Technologies--measured today and for the past few days inside my home, and causing significant harm to my health, as well as great inconvenience as I seek to take care of my garden and put out trash and recycles tonight--just outside my front door, as if this were his parking spot and not mine/our family's. He has parked here since Friday night, March 21, 2025, one day after a Quincy Police patrol car pulled up in front of a house adjacent and a QPD man ran after me without cause while I was raking my garden beds--

which I have FOIA-queried about separately now, in a Query resent this morning, March 25, 2025. The license plate on this black Chevy Silverado pickup truck is 65V L42

It appears to me that this man has parked himself here emboldened by some false program in which he has falsely-claimed a need to "monitor" and apparently continually provoke me in this fashion.

Could you please provide all information, in light of the Freedom of Information Act, on what program of "monitoring" and false-claim surveillance and accusation and constant provocation this man--and Quincy District Court and the Quincy Police Department--is embarked on, what kind of contract this is, and with who, or what kind of grant project this is, and granted by who, and what are the parameters of this project? This project is obviously false-premised and dangerous to my health and the health of my family, it needs to be stopped immediately. I would appreciate therefore all information you can provide on this matter, so I can pursue it further with the right bodies.

I request a fee waiver in the interests of informing the people as News Media. I will be glad to receive all documents in PDF or electronic form, any links to online information as listed hyperlinks, and any audio and video information in the form of mp3 and mp4 files. If easier, and if available, I would be glad also to receive print photocopies of all documents. I would be willing to pay up to \$25.00 in photocopying fees should a nominal fee be required. Please let me know if I should clarify further.
