Dear Nicole L. Crispo, Records Access Officer:

On April 13, 2022, Lieutenant-Colonel Terence McDonnell of the Quincy Police Department was witnessed and recorded speaking to my husband, Paul Jeffrey Tanis, Esq. JD, LLM, M.Ed, MA (English), on our front porch, and telling him "We have a Process" supposedly "to get her Treatment". The next day, I was physically forcibly kidnapped by 4 Quincy Police Officers and 2 Brewster Ambulance staff, strapped down, trafficked to Steward Carney Hospital, and held there, in both a freezing Emergency Room and a so-called "4 Southeast" Ward, for 6 days, during which I incessantly sought educated response from the doctors and nurses holding me there and was finally released on April 19, 2022, after which I discovered a second set of false psychiatric labels had been affixed by collusively-acting psychiatrists to the medical records affiliated with the name used to capture my living body. This was clearly criminal, start to finish, since I am neither mentally ill nor have ever been--but am a journalist reporting on government, military, Intelligence, Security, Health, and police matters. But there appears to be a "Process" by which Quincy Police believes it can ambush and kidnap a writer and journalist--as no doubt others--and force "psychiatric evaluations" on them which turn out to be bogus, in order to force psychiatric labels on records associated wrongfully with them, in order, it appears to further tag them and terrorize them with later police visits and ambushes, as I experienced and have reported later in 2022 and in 2024 especially: no one should be targeting anyone under the Law, and nor should Quincy Police. As a reporter and science journalist, I have investigated and reported on 911 calls, the crisis-calling system and emergency medical services in Massachusetts. These systems and services clearly have taken wrong routes and are not serving the people of Massachusetts very well, in fact quite the opposite. In the interests of positive change therefore to benefit all in Massachusetts, I would like very much to learn more about this "Process" which QPD was referring to that day, what exactly it entails, what kind of information the City holds on this subject, who exactly is involved, what

documents, memoranda of understanding, agreements, contracts have been signed and with who, and how exactly the Police have gotten involved with matters of supposed "healthcare" in particular in the realm of Mental Health. I continue to investigate and report on this subject, and will research further myself. But I would appreciate it very much if, in light of the Freedom of Information act, you could kindly provide all past and present Police and Government communications, documents, memoranda of understanding, agreements, contracts, email correspondence with the Departments of Health and Mental Health, Executive Office of Public Safety and Security, the Department of Homeland Security, the Commonwealth Fusion Center, the Boston Regional Intelligence Center, and any other department, hospital, EMS provider, health insurance provider involved which contributes to this "Process" referred to and acted on by the Quincy Police Department.

I request a fee waiver in the interests of informing the people as News Media. I will be glad to receive all documents in PDF or electronic form, any links to online information as listed hyperlinks, and any audio and video information in the form of mp3 and mp4 files. If easier, and if available, I would be glad also to receive print photocopies of all documents. I would be willing to pay up to \$25.00 should a nominal fee be required. Please let me know if I should clarify further.
