Dear Sharola and Nalini and Paul,

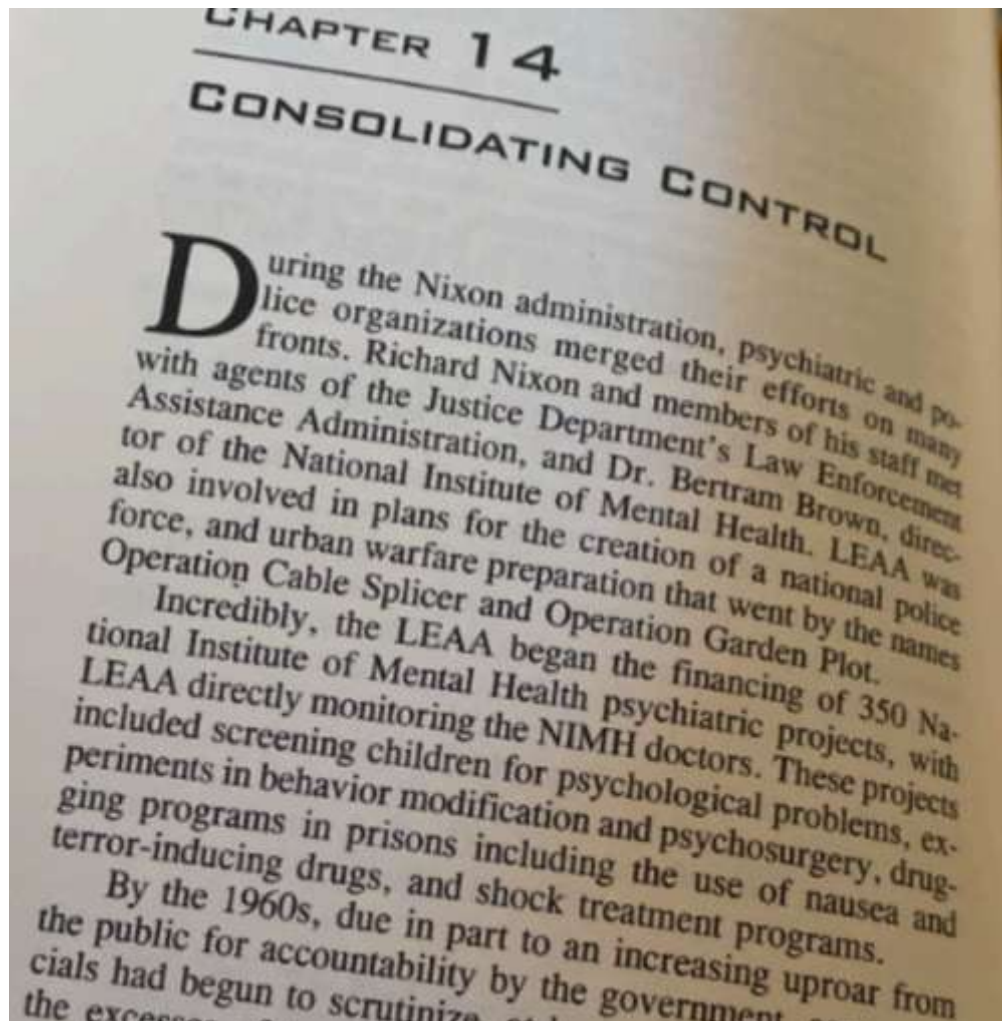
I have written to you both earlier asking you for all details regarding your sudden flying visit to my home in December 2013 during which you worked with a drugdealer, Shubha--a Psychiatrist, flying under the name Dr. Subha Thiagarajan--and Sharola's friend from medical college, then sat about whispering like the 3 witches of Eastwick then coerced Paul into driving me in rush hour for four hours to Shubha witch's office in Lawrence Massachusetts or closeby to apparently Procure for me a False Psychiatric Label of Delusional Disorder at her office, and to further procure for me, at her behest and apparently also at your urging, a Second visit with another crackpot Psychiatrist Dr. Ourania Madias and a Second False Psychiatric Label.

Neither of you has bothered to respond and to provide answers to the questions I need/ed answers to. Nor did Paul.

When Sharola came here--with a version of Reuben, entirely possibly a clone of Reuben, for it appears Reuben, like Paul, may have been cloned as well, as also Melissa and their two children--and a Paul-clone, on December 10 2023, almost exactly 10 years from that day, uninvited, she was clearly laboring under the same delusion of this Loco Label from Shubha and plastered on by her sister-in-crime, Ourania there, having any validity whatsoever. She was witnessed whispering to Shubha on her phone the day of her birthday on December 11, when she ran to the front door to escape my camera recording of her bad behavior (yelling at me, about passports and such) and had a quick consult with Shubha most probably, I suspect, to get some help from her non-sister there about how to deal with a recording sister--as she failed to read my Notice pasted there addressing Doctors in addition to other charlatans informing them that attributing False Psychiatric Labels to anyone and in fact to me was a Crime. She later stole my cellphone on December 12 and was again on the phone with Shubha when I went up to her room and asked her for my phone and she refused to give it to me, outright lying--as is the wont of most Doctors and Police trained in the West--and saying she didn't have it. Note, she has previously stolen my phone, out of my purse, while I was in London at her home in 2016, when she kept it for four years--I discovered this phone in my brother's desk drawer at Spring Valley when I visited in 2020 with Paul and Sophie and stayed for 4 months after being stuck there thanks to the COVID-Lie, which by the way DOCTORS worldwide, brainwashed, indoctrinated in LIES (The "Coronavirus" is a Mega Lie) swallowed and spread, like UnIntelligent Non-Individual Thinking Beings. I then lifted her laptop off the night table and retreated to my room whereupon she chased me around and shouted for Reuben and both attacked me in my room demanding the laptop which I had had time to conceal temporarily. I demanded my phone back in return. Reuben then grabbed my ankle and held it in a steely grip--which is Criminal Harassment--after I had, nursing my then-broken left arm, shouted to him not to touch my arm and threw myself back down on the bed, kicking upward, in fact clutching my own laptop which he mistakenly believed was hers. After being informed this laptop was mine, he did not budge but seemed to think his new role in life was to stand still and clutch my ankle in that extreme overmuscled grip. In any case, Sharola clearly established she was in the throes of a Shubha-inflicted-delusion and a Medical-School-inflicted delusion. She spent some time staring at me, as if to "observe" me, and taking pictures of the house and fridge and myself as if "recording" the sad state I had sunk into, being apparently a Lunatic, as her friend Shubha had suggested via 5-minute "Diagnosis"--to the tune of several thousand dollars, which she extorted from Paul; together they wrote in a False Psychiatric Labeling in the health record associated with the name "Ramola Dharmaraj" which I have used in the past for my passport and driver's licenses while laboring under Maritime--a Jurisdiction I have since left, taking my name and all forms of my name with me, reconveying them to Land and Soil Jurisdiction with specific documentation (as per Judge Anna von Reitz's process, published online at her website, and the correct way forward for every American who believes in American values and general freedom to take: and for everyone worldwide to take: in the face of increasing totalitarianism and tyranny and hubris by an over-empowered Private Sector keen to steal people's brains alleging AI development and alleging "Global Mind Hiving" and "Global Cyborging" down the pike, and worse, pushing new pandemics which are not just Repeat lies but insane Phishing Scams on the populace of the entire world, everyone living needs to step out of the birth certificate system and declare themselves Alive--please see the links I keep posting on this subject--also on my front page currently re. going Private.)



All this despite the extensive journalism at my website and on my video platforms publishing the facts of (criminal and human rights-violative) US military use of radio weaponry and neuroweaponry on Americans and on myself. In 2023! Doesn't she know how to READ?!

Before she left she was overheard speaking to Reuben about a "schizophrenia diagnosis": "She can't be taken out of the house unless she has a schizophrenia diagnosis."

This is further evidence of how far she has sunk into the Medical School Maniacal-Psychiatry-run Delusions she has picked up from Shubha and her own misled and faulty training in the LIES of "Mental Illness." So far she was prepared to PROCURE further Labels for me, running around calling her Psycho friend Shubha for Instructions apparently, on how to "get me out of the house"--most people use cars and bikes but oh no, her own sister "needs a SCHIZOPHRENIA diagnosis!"

As a consequence of Sharola and Nalini's and Paul's actions against me, a host of other crimes have been committed against me by various parties over the past 11 years--as I have publicly reported--and I am taking all steps forward to ensure that all the false Psych Labels placed against a version of my name, on which I have been abducted, kidnapped, and forcibly EKG'd, implanted, BCI'd and nearly snuffed out, several times, are removed and invalidated.

On the day that Sharola and Reuben left our home on December 12, 2023 after their abrupt and stressful and unanticipated visit, in fact at the very moment Sharola was outside my room which I had locked as I took a shower, I was almost killed with a massive heart hit which I saved myself from through sheer luck, fortitude, God's Grace, with a magnet I had kept nearby. The intention of the people--the CIA-Mazzeos and LiMings--who had orchestrated this sudden visit from SD and R, as all else for 3 years now, criminally, was clearly to give me a heart attack while my doctor sister was visiting so she could "call an ambulance" which would have unleashed the Hospital Mayhem on me I have been subjected to before, with that Last Crazy Label of Schizophrenia to be then pasted to my head so I would be Neuro Lobotomized forever and never function again in the world as a Writer or Journalist. [It is my suspicion that our cousin, Nalini's brother, Ranjan, tragically, was felled by just such a heart-hit in Madras, while not knowing that radio frequency weapons are being used, to attack, target, and kill people. This is therefore a form letter formally asking you three to alert Shubha immediately and ensure she removes the False Label she placed in the medical record associated with my name--which becomes a One Health record, given to every Police and Security and Military database, so that anywhere I go--if I ever can leave my house--I will be brutally attacked, strapped down, syringe-shot, knocked unconscious, and near-killed, as Quincy Police and Quincy EMS ensured on April 14, 2022 and December 20, 2022 when they trussed me up and trafficked me the first time to Steward Carney Hospital and the second time to South Shore Hospital thence Bournewood Hospital--"Hospital" the new word here for Police Coven or Dungeon of Crime--while they bleat about the new label they want, to add to the old label they PROCURED (the POLICE, the base criminals here, using and permitting Radio and Neuroweapons on my body and brain and everyone else's), Bipolar! Schizo! Schizophrenia! "Unable to Consent" so we must rough her up here so she can't speak--I have been criminally harassed for 2 years by mercenary soldiers and police and while I have indeed published Notices about the lies in these health records, I must ask you to CONTACT SHUBHA and tell her what I have told you. Send this email to her. She has not answered my letters, which is UNPROFESSIONAL. Is this even remotely normal that a so-called doctor cannot answer a letter from someone she has personally condemned to death at the hands of Gangster Criminal Police?

I am being put to death and I am doing everything I can to stop this crime. EVERY SINGLE LABEL on my so-called medical records--on any so-called record associated with any form of my name, past or present--needs to be removed.

I have written to EVERY DOCTOR who has engaged in this crime, except the South Shore doctors whom I will be writing to shortly. Every single one of them needs to REMOVE THESE LABELS.

There is much else I need to do to further publicize the brutal crimes of the US military, intelligence, security, and police agencies and parties who are using through-wall weaponry to murder people while using their brains non-consensually for AI development; I will continue to do it, and in the absence of Doctors and Psychiatrists like Shubha FAILING to step forward and CORRECT their misled and wrong actions--which have caused GRAVE HARM to me, my family, and my life--I will publish a Notice remarking their Crime. I have many things to do in my life and I am not going to sit around being brutalized by police and local mercenaries thanks to Shubha--and her successors' acts of criminality against me.

The so-called Boards of Medicine and Boards of Psychiatry which permit Labeling for Further Bodily Assault, Abuse, and Murder by DARPA, DOD, Air Force, Navy, Marine Corps, Army, CIA, DIA, NSF, DOE, Police, EMS, ERs, Psych Wards and other criminals are also criminal bodies and will be Noticed, in as much as they are connected to such parties--as proved in all the cases of the Doctors and Hospitals I have written to, copying letters to such Boards, and received no response for.

I am writing once again to you together because this is your Last Chance to set right this wrong. Beyond this, I will be publishing Notices. I cannot wait ages for any response and will look for positive responses over the next week. If not, please know I will continue to invalidate all these Labels of Lies myself. As a Journalist being physically abused with deadly radio weaponry which is gravely harming my health and neuroweaponry which is attacking my brain, I must publish all so the whole world knows what has been done here. What has been done to me has been done to millions of others. This is the only way forward, for all humanity, to inform all. The deadly criminals in military, intelligence, covert and overt groups who have permitted themselves the latitude to silently and in stealth use and abuse and murder people seem to believe they can go on forever, abusing us: they CANNOT. As a journalist, I am making my case prominent so these crimes against all of us, present and intended future--for our own children and grandchildren, which is their insane plan--can be brought to a crashing and immediate stop. Further, you are both Health professionals and Paul is a Law professional--I believe it is your duty to set right this historic Wrong and ensure that your own sister and cousin is not Murdered thanks to False Lying Labels. You both need to make public statements. Doctors and Public Health MPHs and Lawyers are not the Last Authority here. However unprecedented, Shubha needs to completely remove all labels and lies associated with all forms of my name on any and all electronic, digital, and paper health records. Please share this letter with all family. I am copying all here whose email ids have been readily available--I am still being insanely cyberhacked by the CIA next door.
