Dear All,

I have already come back to Canada. Thanks to all TIs, who worried about me.Oral presentation took place in the UN on the 10th of March. I had to make it a bit shorter than a version that I emailed you, since there were a lot of groups from Canada at this hearing - 20! I do not believe in any coincidences and am absolutely sure that all these groups were organized and sent to Geneva by Canadian Government just not to let our group speak for enough time. Our report was taken seriously, and one man, who organized all oral submissions at the UN hearing, told me that we have to start a new lawsuit and exhaust all venues in Canada, including the Supreme Court in Ottawa, before we can request an investigation in UN. The point is that I already filed lawsuits against Canadian government, Toronto police, RCMP and psychiatrists, and they were dismissed everywhere in Canada, including the Supreme Court, many years ago. I am not sure that I will have enough energy and money (money is a more important question) to repeat this ordeal one more time.
