Notice to One is Notice to All

1. Just was downstairs briefly and looking out the back deck and front windows I noticed the fence panels I had put up this morning have all been removed, down the entire length of the Mazzeo drive. It must have been done when I was writing my emails here earlier, and the 2 Quincy Police men and the Paul-impersonator, spouse-impersonator must have accompanied this criminal removal of these decorative panels I had put up to protect our shrubbery on that side, our hydrangea, our cherry tree and the front garden. 2. The man posing as my spouse and daring to speak for me and against me actually, maintaining a lie with the many interchangeable, changing-out Mazzeo men and Quincy Police, had no right to touch my panels nor,

obviously, to pretend to be my spouse, to exchange Lies with the Mazzeo men--witnessed earlier around Christmas Day 2024 as well talking to one of the Mazzeo men--another one, taller, pointy-bearded, not this shorter blond one.

3. The panels were completely in our garden space and hurting no-one.

4. The metal edging I had put up earlier around the garden areas, very low, has been trampled on, twisted, and destroyed by the Mazzeos, who have also it appears attacked the Native Plant garden sign I had put up last fall. This edging is so twisted it cannot be untwisted and was clearly stomped on by a very malicious man in an act of active malice. All CRIMES.

5. One of the panels had some of the metal flowers twisted out, something I noticed and reported in my logs a few days ago. CRIME.

6. The low metal semicircle metal holder to hold the heavy hydrangea heads I had put up around the hydrangea on the right behind the cherry tree was also attacked and twisted, something I noticed a couple days ago, removing it. I suspect the Mazzeos for they have stomped on the edging and attacked the fence panels by one of the 2 arborvitae on that side.

7. Further, the Mazzeos have brought very large SUVs and crossover SUVs into this drive and people from these have stepped into our trees as if they could--that is our garden area, our arborvitae, and they cannot open their SUV doors into our trees. CRIMINAL behavior.

8. Further, the Mazzeos have used radiation weaponry and completely blitzed our ferns underneath the barberry tree by the side, something I noticed and took pictures and reported last fall. I have put up Notices--and in fact sent them Notices--about not touching our trees, plants, or foliage and noting the fines for attacking any. These are now all on my Notices page at ECC. CRIME. [This is not the only irradiation-attack they have run on our trees and plants; one of our arborvitae in the back yard has been Completely burned down by them through this means, of irradiation and drying out.]

9. The Mazzeos cut and attacked our trees on the side: the walnut, the hawthorn, the Rose of Sharon, the redbud, the wild Northeast cherry. I reported this last year, Notice'd them, to no avail. No apology was forthcoming, as no permission was asked either. That is CRIMINAL, to simply take implements and attack someone's trees and flowering bushes.

10. Further, as reported extensively at my web site, the Mazzeos have been found to be the ones calling Quincy Police multiple times, and Quincy Parks, and their local goonda friends from Public Works or Parks, the one who almost rammed his rototiller into my feet as I stood in my own front yard, to literally attack me and our cherry tree and our flowering plants, which they did. We do not have "bushes" abutting the Mazzeo property. They literally called Parks to come and raze our wildflowers. This is the report I filmed and published online. That was a major attack, on me, on my life--this guy literally pushed his implements into me, walked into me, and thrust his fingers into my face and almost into my eyes: he had been asked, it appears, to physically rile and provoke me. This was dangerous and insane, and the Mazzeos, Quincy Parks or Public Works--I had thought it was the latter--and Quincy Police who came by later and recorded their impressions in an incident report which revealed the lies told to them by both the Mazzeo man and the Parks/PW man as if it were true are all accountable for these crimes; I received this incident report in a FOIA query and reported the wrongfulness of this. It seems the Mazzeos can simply lie and

Quincy Police comes running, Quincy Parks comes running and all with intent to attack me physically--in which they succeeded that day, which was September 4, 2024--followed by Quincy Parks coming here with a big tree cutting truck and saws and sawing off a whole limb of our cherry tree--which was trailing ENTIRELY over our own front garden right in front only and in no way on the street or sidewalk--which is our private way--and then came up to the door with a power saw in his hand. That was October 3, and I have reported this as well. The Mazzeos' behavior in lying, summoning armed men from Quincy, and arranging attacks on me and our garden and trees is CRIMINAL.

11. Note also that these men have thrown dead rats and parts of birds in our yard last year, again reported in my Reporter's Notes. They constantly throw trash from their drive into our yard as well--half on the drive half in our yard.

12. Since they arrived, I have measured and recorded very high pulsed radiation coming into our house from their car, shed and house and now also their roof. I have reported this matter extensively, as part of my reportage on the RF HPM, EMF, Neuro, Nano weaponry being unlawfully used on people in numerous projects which are enacting Crimes Against Humanity on Americans.

13. The Mazzeos are criminals who freely call on local police to protect them and to take action against me, a writer and journalist working for the People: all living Americans and people worldwide.

14. No spouse of mine is permitted to align themselves with the Mazzeos and take action against me, as has happened today: Of course, this was not a spouse of mine. The man here this midday--around 1:30 pm is when those police cars showed up--is not Paul. This man is playing Paul, is impersonating Paul, and is attempting to maintain the CIA-QPD lie that has been played here, since 2022, that no clones exist, these are not clones, this is Paul. Paul is not likely to behave in this bizarre and criminal and clueless way, he is an Attorney, and I would think, would know better. I have previously Notice'd the circle of false Pauls--or Paul clone-brothers--in order to state clearly and emphatically they are not permitted to further gaslight me. I have, last year and the year before, taken photographs of the men and the children here, who have been cloned, and I have sent them privately to family earlier and friends, as well as published a few of the men here: <https://everydayconcerned.net/notice-of-cloning-gm-cloning/>

I have refrained from publishing photos of the children, to keep their privacy. I am not sure if this is the right thing to do, but I wouldn't want in any way for their school lives and home lives to be unsettled.

The men I have published photos of to share the information; over quite some time in 2023 and 2024 and many many clues, it became clear to me they were clones of Paul, many younger, one or two pretty close in age. The guy who has shown up here at Christmas, when the cars were removed by a tow truck later, and now today is one of these older ones.

Cloning has not been confessed to by the CIA--but judging from how it was done in our case--my placenta and cord with stem cells was stolen at our home birth--I can only conclude it was the CIA. It might also have been the US Air Force, US Navy, US Army involved. I recognize this is major information for all. I have published the facts as I have found them. I am reporting Cloning, of both spouse and daughter. And, I must also say, some of the children and

men have been to London and to India and to Michigan over the past couple summers, and met our family and cousins, and I have seen those photographs--so others have met them.

In light of all of which, the spouse-impersonator is once again advised he cannot pretend to be Paul and he cannot come here and pretend to speak for me and then act against me as he has today.

15. I have called and left a message on Paul's phone number--which has now been co-opted by the Mazzeo-CIA clan--and asked him to put the fence panels back up--considering the time and energy I have spent getting and putting these up. I haven't heard back.

16. The reason these panels were put up is not one reason actually but several: The low edging clearly was not working to protect our garden, the Mazzeos were stomping on them. The Mazzeos have attacked the vegetation on that side numerous times, numerous ways. There is an airconditioning unit on that side as well and I do suspect the Mazzeos of tampering with it and sending toxic gases, smells, and cold air into our house--I have noticed this several times and noted it in my logs. These are all CRIMES.

17. The Mazzeos are not permitted to step in our garden space, to cut our foliage, to open their doors into our trees--which are well up the slight slope around the house and not in their drive--nor to cut our trees, nor to irradiate our trees, nor to irradiate our ferns. They are not permitted to call Quincy Police on lies, nor to spread lies and slander, baseless and false, about me to anyone. Yet they have. Hence, they are operating as Terrorists, and Quincy Police is protecting them by responding to their lies.

18. All clones of Paul are once again advised they cannot maintain this farce one minute longer, they cannot bully and gaslight me in this way, they cannot team up with the CIA and the Quincy Police to keep maintaining these spouse-impersonator and rubbish "Mentally Ill" lies with them--that is Defamation and Slander--and they cannot obligingly come over and attack my garden and my work in this way. That was hard work, putting up those panels--which are light, slight, but anchored firmly in the ground with being pushed into the earth and which weathered the recent wind storms very well.
