Dear Nicole Crispo, Records Access Officer:

In light of the Freedom of Information Act, please provide the following records:

1. All reports, notes, information, audio and video footage and text, email and a/v communications, from body cameras and microphones, police car cameras, any other cameras in relation to the Quincy Police visit to this author and journalist's private home at 154 Pine Street on March 20, 2025, around 6 pm in the evening. Who summoned Quincy Police to this Writer and Journalist's home, and for what reason? This writer was raking leaves for spring cleaning from her garden beds in her front yard when a Quincy Police car drew up at high speed past her drive and parked at the house next door at 156 Pine Street and a man--presumably the Police man driving that car--leapt out and ran after her as she was entering her back yard and closing the door, calling out for her name. Quincy Police cannot accost women working in their front yards, drives, private ways (bit of sidewalk and earth strip abutting the curb and front yard), especially living American women living privately, and ask them for their names. Nor can they ambush anyone in this fashion—as this writer has been twice ambushed earlier and abducted—kidnapped—by Quincy Police from her home on false-claims and false-accusations from lying residents parked next door and

playing neighbor while in fact enacting contracts of cruelty and crime with military and justice bodies using "emerging technologies" on others: matters this writer has addressed continuously in her journalism since 2014. As you may know, I am an independent investigative science and technology journalist, college faculty at a well-known University, and a college-student's mother, cast wrongfully as "Mentally Itl" by Quincy Police and Boston FBI since late 2013 when false psychiatric labels were first placed wrongfully--by Quincy Police, the Boston FBI, and collusively-acting psychiatrists making false claims, essentially for private monetary gain and defaming of Writers with underlying intent to control, a doomed enterprise--on medical records affiliated with the name associated with my previous US Citizen status arrived at through naturalization in the State of Virginiawhich "name" has since been fully expatriated to Land and Soil Jurisdiction and has no legal person, vehicle, individual, or subfranchise corporation currently affiliated with that name anywhere in the USA or the world succeeding my expatriation from the US Inc. corporation and sojourn to Land and Soil of The United States of America, adopting the beautiful country and state of Massachusetts as my new home, a native of India now standing with the natives of Massachusetts, as indeed declared and published in the Quincy Sun in the spring or summer of 2022. As an American State National and Massachusetts state national and living American woman living in the Land and Soil jurisdiction of the USA and standing with all the tribes, indigenous and diaspora of every ethnicity in Massachusetts therefore, I do not wish to avail of Quincy Police services anytime, given their extremely disrespectful actions against me for quite some time now, since 2013 in fact; as a journalist I continue to look into and research and investigate police crime for this reason; the Boston FBI in fact alerted me to the abuses being run on people all over Quincy and Boston and Massachusetts under the lawless verbiage of the Patriot Act back in 2013, and they too, as the DHS and the DOD and CIA and DMH are under investigation at my desk. I hope all in Quincy are keeping up with the reportage at The Everyday Concerned Citizen, which continues to publish on these matters. Meanwhile, Quincy Police cannot keep lawlessly appearing at my doorstep, with apparent intent to capture my living body, as they have done in 2022. I must therefore report fully and accurately on this matter and therefore request that all reports and information, print and audio and video, be provided to me, under the aegis of the Freedom of Information Act, related to this sudden flying visit on March 20, 2025 from a questing Quincy Police man, who, sadly, is not permitted to approach me or my home, porch, private way, drive, front walk, front yard, side yard, back yard, curtilage, fences, roof, private parking area at any time, ever--as indeed Notice'd at The Everyday Concerned Citizen earlier.
