Dear Nicole Crispo, Records Access Officer:

In light of the Freedom of Information Act, I would be obliged if you could kindly provide the following records, related to the occurrences described below:

1) Yesterday morning while putting my Trash and Recycle Cans out, I noticed my Yard Waste can filled with leaves and a bag with leaves on top had disappeared. I had left it on the curb just above our private drive and in our private parking spot space, at 154 Pine Street. Looking both up and down the street I could not see it. Could you please provide all records therefore relating to this Yard Waste can being removed from our property? I suspect the QDC/QPD people living opposite at 153/151 Pine who have vandalized quite a few items from our garden, and the Chen Limings at 156 Pine who have frequently broken in, littered, and stolen items, and cut our foliage and trees without our permission, or the Mazzeos at 150 Pine who have frequently called the police on false claims and attacked our yard, including cutting tree limbs, getting

Quincy Parks to attack our yard and myself and our cherry tree and wildflowers, twice, and pulling out our fence panels with QPD on March 11, 2025, all matters I have reported, as a journalist. Given their history of lying calls and summons of Quincy Police, I am wondering if one of them did the same yesterday and decided to grab our Yard Waste can out of sheer malice. I am seeking therefore all public records of "complaints", incident reports, audio and video footage from QPD cameras if they came by here yesterday to remove our can--for no reason I can discern, it was on our property. Another 2 cans have been previously disappeared, just 2 or 3 weeks ago, from our private parking spot by, it is entirely possible, these vandals, or the ones resident currently at 159 Pine, the Murphy house across the street. So yes, maybe all public records relating to these 3 Yard Waste cans from our home and yard and private parking spot at 154 Pine Street would be good to have, since I am wondering if these people here have once again "called the police" needlessly to attack our property and remove it, while spreading false-claims in my name with malintent against me--thanks. As a journalist, I hope to report on this matter for all to read.

2. Perusing a Incident Report received from the Quincy Police Department recently, I see notice of a CAD Incident report mentioned in reference to a QPD intrusion on my property at 154 Pine Street on October 6, 2024: CAD # 24054646, which appears to imply relationship to same, as well as concerning mention of a "restraining order and warrant service" which Quincy Police is out of line in attempting to impute to me in any way, and has done so here, I suspect, in collusion with lying reports from nearby police-affiliated contractors, as noted above. Investigating this matter further however, I would like to examine all reports and false-allegations made against me. Could you kindly send me all information that Quincy Police can provide regarding CAD #24054646, Incident/report 24054646/1 and that "restraining order and warrant service" which is mentioned: What and why was this attempted to be served, on what false-premise and false-narrative, and what does (903) Suspicious Incident mean--who called Quincy Police that day, why did they come to my private home at all, and what was the alleged claim made and by whom? [My name and all forms of my name are Private and on Land and Soil and cannot be used in Defamation and Smearing against me.] Thank you.

ALSO: This CAD Incident Report was one of the concerning ones I immediately wrote to the Chief Public Records Officer and Secretary of the Commonwealth about, in November 2024, asking him to kindly address this matter and stop Quincy Police from trying to accost and kidnap me again alleging need for "arrest" which I read as "Section 12 arrest"—but I am seeking more information currently; I enclose this letter here for your information.

EXCERPT FROM QPD INCIDENT/REPORT #24054646/1:

## NARRATIVE

On Sunday, October 6, 2024, I (Officer Waters) was assigned in full uniform t in the Bravo 2 area, in marked cruiser 778. At approximately 0928 hours, the (Officer P. Le) and I responded to 154 Pine Street (CAD#24054646) on an att serve a restraining order and warrant service.

3. In light of the many Quincy Police intrusions onto our property made, apparently on numerous false reports—from people who it appears are or have been conspiring to deprive this Author and Journalist of all rights, impugning her as Mentally III and putatively "a danger to herself or others, including but not limited to her neighbors", a serious charge which I am seeking to address in full, may I please be provided all Police reports, CAD Incident Reports, camera footage, audio files and other documentation whether text, email, fax, form or any other related to any and every Quincy Police intrusion onto our property—from 2011 to the present date, April 16, 2025, to any attempt to contact this Writer, and any alleged attempt to "serve a restraining order and warrant service"--which cannot be served for several reasons, it would be on False Report and False Premise, first of all, and two, cannot be served to anyone such as myself living privately and calmly in Land and Soil Jurisdiction. No one is permitted to call, impugn, smear or say this Author is Mentally III and a "danger to self or others" which she has never been and is not now—this is Defamation and Slander and as a Writer and Journalist and College Faculty I do have a name to protect. Quincy Police has previously wrongfully engaged in two Section 12 Forced-Kidnappings of this Author from her

home in April 2022 and December 2022 on false-claims and lies, using complicit ER Physicians and Psychiatrists at Boston area hospitals and complicit Medical Service personnel from Quincy EMS/Brewster Ambulance to procure False Psychiatric Labels for this Journalist and Author who has been and is fully addressing this unlawful Slander and Defamation currently; I am intent that this will never happen again. Any record naming "Ramola Dharmaraj" as "suffering mental health issues" with "mental health declining" is false and needs to be addressed correctly in publication; anyone naming a "history of reports" such as this Patrolman T Waters at QPD needs to correct their language, these are false-claim and false-narrative reports; those acting in malice against this Author and seeking to disappear her as Mentally III while using Police and Court forms wrongfully to make false claims of harassment, such as the parties at 153 and 151 Pine--who have done this many times before, running inexplicable "set-ups" as baseless Police protocol in apparent (unlawful) "Parallel Construction" provocation actions--inclusive of massive harassment, sound harassment, private property trespass, defacement of garden, vandalism, littering, threat, intimidation, 24/7, then jotting down lies and false-claims-- are acting against the Law and need to be stopped; I would like therefore to receive all public records related to all claims made against any form of my name, so I can report these records and clear my name once and for all. I am neither Mentally III, a criminal, or a terrorist--as all these people, who seem to be protected by QPD are, and who apparently are seeking to target me as. Quincy Police should not be needlessly listening to false reports and coming with intent to "Section 12" me again and again as these many CAD Incident Reports received recently suggest, taking their word for gospel and seeking to "arrest" me or "serve a restraining order and warrant"—this would be criminal. [All previous Psych Labels they have unlawfully procured and placed wrongfully against my name have been invalidated.]

EXCERPT FROM QPD INCIDENT/REPORT 24054646/1 [This is Defamation and Slander]:

Photographs were taken of the signage with my department issued cell phone and will be forwarded to CR1 Tim O'Brien as I am unable to attach them to this report. It appears based of the history of reports involving Ramola she suffers mental health issues and has gone to great lengths to attempt to avoid contact with service providers. I am requesting CSU follow-up to determine if Ramola is a danger to herself or others, including but not limited to her neighbors.
