Dear Nicole Crispo, Records Access Officer:

In light of the Freedom of Information Act, can you please provide the following:

1) Information, with all print, audio, and video reports as well as Body Camera and Patrol Car footage on the uninvited intrusion onto this writer's private home and property this morning around 7:20 to 7:25 am, or thereabouts, when 2 Quincy Police cars were witnessed parked in front of our house. This was directly after I was outside doing some very brief gardening, watering some of our plants and trees, noticing the radiation damage on our rhododendron from directly across the house, 153/151 Pine where QDC/QPD people live. A man walked past me, surprising me as I stood by the side of our house, watering a hydrangea. This man was a stranger I had never seen before, bearded, with blond hair. He turned and stared at me as he walked swiftly past and entered the back of the house next door, the house marked as owned by a Joseph and Samantha Mazzeo, 150 Pine Street, No. words were exchanged. He stared and went inside. I finished my watering [literally in two minutes after that moment] and closed the faucet and went inside myself, closing my porch gate behind me. A few minutes ago--it is 7:51 am now--I was downstairs and noticed the porch gate hanging open. I went out onto the porch and closed it. Has this man called Quincy Police on a Lie? There was no interaction between us, nor was there anyone else outside on the street. As you know, I have recently published, as a journalist, the Facts on the ground here: There are Malicious Actors in this neighborhood who have frequently made calls to Quincy Police against me on absolute Lies, making false claims and false accusations. I have therefore made a FOIA request recently for all Incident Reports of all Quincy Police intrusions here: My home and land are Private, I am very firmly in Land and Soil Jurisdiction, and I keep the Law. There is no reason whatsoever for anyone to be calling Quincy Police and making false reports about me. I would like therefore to clear this matter up and publish the Facts on the matter, at The Everyday Concerned Citizen and also at The Quincy Beat. Quincy Police are not permitted to come onto our private parking spot or enter our front yard and open our porch gate or enter our porch: They have twice unlawfully kidnapped me in April and December 2022, matters I have reported, and they are not permitted to unlawfully defame me nor attempt to once more kidnap me. I cannot be detained. I am an Author, a Journalist, and a Teacher, and my Name cannot be defamed or smeared in this fashion. Nor can I be considered by Quincy Police or by anyone else as "Mentally III" needing frequent "Wellbeing Checks" from the Police or "Arrests" which are Kidnaps for Trauma and Terror at Hospitals which do not provide medical care, medical evaluations, or anything else, as I have

fully reported, in journalism, and in Letters of Notification to many parties including The City of Quincy and the Chief of Quincy Police. I have also written recently to the Secretary of the Commonwealth, Chief Public Records Officer, on this matter of repeat police visits, which are both defaming and terrorizing. Please provide all information as you can on this unexpected and clearly lied-about intrusion of Quincy Police onto my private parking spot and garden and home. Thanks very much.
