Dear Commissioner Brook Doyle:

In the matter of the April 12-19, 2022 incidents of harm recorded in my Living Testimony in the Form of an Affidavit and Statement of Fact (enclosed), wherein I was sadly and stressfully subjected to the many crimes of unlawful conversion, personage, trespass, coopting of estranged spouse, threats, harassment, intimidation, manhandling, unlawful restraint, false-arrest on false-claim, kidnapping, trafficking, false-detainment, deprivation of freedom, conspiracy to deprive rights, and incarceration in grievous conditions of harm for six days in a hospital for no cause, under further threat of a forced civil committal on false mental health grounds, while giving notice of my status as a living woman, American State National and Massachusetts national, standing on the Land and Soil jurisdiction of the true united States of America, with my God-given rights protected by the original Constitution for the united States of America, and being in no state of medical crisis whatsoever, while it emerges now false-claims of gravely harmful nature were made against me, I seek the following in rightful compensation for the 6 days and 7 months (to the present day) of injury, damage, and continuing harm caused to my health, my family, my life, my career, my profession, my reputation and Good Name, a primary aspect of which, the false diagnoses conferred by Steward Carney Hospital doctors, I am still working on addressing:

1) The modest monetary compensation and lowest possible rounding as required by the lesser of my published Fee Schedules (enclosed) of \$75,000,000.00.

- 2) Correction of all false diagnoses (and all "diagnoses" and claims made are false) made by QPD and DMH wrongfully impersonating the copyrighted name "Ramola Dharmaraj" in the medical records made using that name, in all extended records relying on these records, in all notifications made using these records, and inclusion of all letters (with testimony and evidence) including this one sent to you in any records using that name.
- 3) Correction of all notifications made on the basis of these false diagnoses and false assertions to:
- 1. Any Community Care Co-ordination Programs;
- 2. The Department of Mental Health, Commonwealth of Massachusetts;
- 3. Any Law Enforcement or DOJ or DOD or DHS or US/Massachusetts Government agency;
- 4. Any Department of Health and Human Services or similar.

As the Public Records office of the Department of Mental Health (DMH) is aware, I sought several times via FOIA-request to gain more information and answers on DMH practices and protocols in the case of recourse to Section 12/Massachusetts-Code-related Psychiatric Grabs of living women and state nationals as well as to ascertain the "mental health" qualifications of Quincy Police Department Tim O' Brien who utilized the DMH false-instrument of an "Application for Authorization of Involuntary Hospitalization" on false-claims, false grounds, false allegations, and false assertions to unlawfully arrest, detain, kidnap, traffick, incarcerate, force-medicate, false-diagnose my living, and fully mentally-competent, perfectly mentally-normal, sane, and non-psychotic, non-paranoid, non-delusional, non-bipolar, non-grandiose, non-any-DSM-symptom-of-disorder-syndrome-inadequacy-incompetency, living self, committing also the grave crime of personage, compounding the grave crimes of state committed here--and I was denied all such information.

As noted in my Testimony, conspiracy to deprive rights partaken in by whole crews of medical staff and physicians and psychiatrists at the Carney ER and Psychiatry Ward have become evident, surfacing the extensive "black operation" committed against me here.

As a powerfully persistent human-rights-focused investigative writer and journalist, I have come under the most singularly persecutory scrutiny of and punitive abuse from local and State Law Enforcement, Intelligence, Security, and Military agencies who are currently engaging in grave crimes of atrocity using Spectrum directed-energy and Neurotechnologies on the bodies and brains of Americans – matters I seek to research and report on for the amelioration and upliftment of living circumstances and lives of all mankind – and their primary form of reprisal, discrediting, and abject persecution is to stick labels of "Delusional Disorder" "Acute Psychosis" "Paranoia" and "Grandiose ideation" to disappear the journalism and journalist, as has occurred in this case, and in the 2 previous occasions of my forced and

false encounters with equally complicit, ignorant, and pernicious psychiatrists, Dr. Ourania Madias on 12/31/2013 and Dr. Subha Thiagarajan on 12/16/2013.

In those matters as well – false "diagnoses" of whose import I have only currently understood the extensive ramificatory harms, I am currently addressing the matter directly with both psychiatrists and their institutions. Please be advised I will send in a final statement to your offices to address these harms definitively – since all such harms of profoundly false-diagnoses based on profoundly false claims have been executed on me in Massachusetts. The entire roster of harms accruing from all these 3 false-diagnoses, the 2 in 2013 and now 1 in 2022, needs to be completely and absolutely erased from any medical records maintained in the name of "Ramola Dharmaraj." All these diagnoses are false, all arise from medical malpractice, and all the psychiatrists involved in the assigning of these false-diagnoses are being reported to the DMH and the Board of Registration in Medicine.

In relation to this subject, I have also reported to the Board one Dr. Leslie-Ann Alexander, an Internal Medicine practitioner who has wrongfully notated "Paranoia" in her notes on my one visit to her on 12/21/2021—after my mention to her of my work in researching the accounts of biomedical research victims of Military and Intelligence experiments; this is a complete subject in itself and I will be fully furnishing all details to you along with the information mentioned above shortly.

Please be aware that I am a journalist reporting extreme human rights violations by an out-of-control network of police, military, Intelligence, and Security operatives in US Government—and their private-partner contractors; my work is public—please see The Everyday Concerned Citizen and Ramola D Reports video channels, and my reports and conferences can be found easily online. Note also that I am a published author and continuing writer, publishing in the genres of Fiction, Poetry, Personal Essay/Memoir, and Journalism, with over 25 years of experience in teaching freshmen to seniors at the college level, to continuing-education adults, and to children, work that I continue—and not a debilitated subject of uncontrollable "psychosis" or mental disorder, as these fraudulent physicians have sought to establish, in direct challenge of my name, reputation, and public work in the world.

I would like to reiterate to you however that the symptoms of Mental Illness can today be induced by energy and neurotechnologies; I ask you to get up to speed immediately on the ab/use of Spectrum DEW/Neurotechnologies wrongfully creating the symptoms of mental illness in many, who are being doubly abused and re-victimized by physicians and psychiatrists falsely labeling them mentally ill/delusional, and thereby protecting the grave crimes and atrocities being committed by the miscreant military, intelligence, security divisions, in contravention of all protections afforded by the Geneva Conventions, Nuremberg Code, Rome Statute, or any other international protection of rights, and certainly in contravention of the supreme Law of the Land, the original US Constitution and Bill of Rights.

I can assure you that my intent in sending you this letter and Notice of harm and claim is honorable, and that my hope always as a writer and journalist in exposing crime is to pave the way forward for a better world, in which all of us can exist in harmonious, thriving, and vibrant community, and each of us is able to fully express our God-given opportunity for a brilliant, fulfilling, creative, and productive life, to the fullest extent of our innate organic potential – and not some of us selected to be eternal victims of miscreants running military projects on our bodies, destined for destruction, as currently appears to be the case.

I have claimed my reversionary trust Interest and recorded and published all documents claiming, privately trademarking, re-venuing and permanently domiciling my name to Land and Soil of Massachusetts, renouncing and expatriating from US citizenship, repatriating as a Massachusetts national, providing Mandatory Notice under the Foreign Sovereign Immunities Act; I have sent Notice to the US Secretary of State, recording all on the public record at Hampden County, Massachusetts and the International Land Recording System. As per the Law of Peace AR 27-161-1 and the terms of my second, lesser Fee Schedule (enclosed)—which also notates the laws guaranteeing my safety and immunity as an American state national on Land and Soil jurisdiction, in particular the Foreign Sovereign Immunities Act, Title 28, Sections 1602-1611, which also guarantees my safety and immunity as a living woman and suv'eran on Land and Soil as recorded prior with the Purple Thumb Community—I look forward to receiving the payment noted here in (1) within 15 days.
