### Letter of Notification and Request

Dear Dr. Allen L. Smith, President and CEO of South Shore Hospital, Weymouth, Antony Sheehan and Susan Coakley, President and CEO of South Shore Mental Health/Aspire Health Alliance, Dr. Booker T. Bush & George Zakos, Director, Massachusetts DPH, Secretary of Health and Human Services, US DHHS, Robert F. Kennedy Jr. & Director, Office for Civil Rights, US DHHS:

With reference to my earlier letters from January 9, 2023 and January 19, 2023 previously sent to the CEO of Bournewood Hospital, Brookline, to which hospital I was unlawfully trafficked from South Shore Hospital, Weymouth, and incarcerated at for 9 days [December 21-29, 2022], I am writing to notify you more fully of the crimes committed against me by both hospitals, 2 EMS Service companies, Brewster Ambulance and Midwest Medical Transport, the Quincy Police Department, and the Quincy District Court, and to request that you act immediately to remove all false narratives and labels—purporting to be accurate and “diagnoses”—noted in all medical records and database entries affiliated with the name “Ramola Dharmaraj.”

I am an author and journalist and living American woman—all forms of whose name have been long expatriated and reclaimed on Land and Soil Jurisdiction of the United States of America, occupying no name or identity whatsoever in the Maritime/Admiralty jurisdiction in which South Shore Hospital Inc. and all other corporations named here reside, who was unlawfully physically abducted, kidnapped, and trafficked to South Shore Hospital on December 20, 2022, on false-claims and allegations and on a false name and address, by Quincy Police first from my private home, and thence on false-claims from Quincy District Court staff—specifically a “Licensed Social Worker” named Chelsea Lloyd, as noted in Optum/South Shore records—and Brewster Ambulance Services, who have recorded lies and fabrications on a “Patient Care Report”, which they have been notified about and requested to change. My letters to each of these parties, some of them repeated queries for medical records and public records under the Freedom of Information Act have been published and are being maintained online for public edification and viewing at my media website, The Everyday Concerned Citizen, at [Additional Information With Letters, 2013-2023: False Psychiatric Profiling](#). I made several requests, verbal over the telephone and in writing, to South Shore Hospital for all medical records associated with that traumatic occurrence, and further requests for the **correct** medical records—which were never sent--succeeding the eventual sending to me in PDF form the excruciatingly inaccurate and clearly fabricated so-called records of the entire time period of my incarceration at the South Shore Emergency Department and the South Shore Mental Health wing, from the time of my forced-trafficking there by Brewster Ambulance and forced-intake at the Emergency Department at 4:43 pm on December 20<sup>th</sup>, 2022 to the time of my second, traumatizing South Shore trafficking to Bournewood Hospital, using a state ambulance service, Midwest Ambulance Service, a little past midnight in the early hours of December 21<sup>st</sup>, 2022. Records sent to me by South Shore Hospital appear to include notes regarding some one else, in addition to notes—alleging lies—being attributed to the false name under which I was held.

1. First, Brewster Ambulance brought me there on lies. There was no court order nor “Section 12 form” associated with

their kidnap and trafficking of my living body to South Shore Hospital that day; I queried both Quincy Police and the Quincy District Court for any such and received nothing. The false-allegations of "behavior abnormal, suicide, psychiatric" they wrote down on their forms along with a false-narrative of capture are false allegations. I was knocked unconscious by Brewster Ambulance staff and strapped down by them while unconscious. There was no cause for Brewster to attack me, I was physically sick that day, and there was no reason for Quincy District Court to hold me for six hours that day in a "Courthouse Lock-up" as I later learned that jail cell was—also knocked out then--nor for Quincy Police to capture me off my couch in my own private home that morning when I was physically sick with a sinus infection and radiation sickness, and take me to a "courthouse lock-up" and shackle me there and leave me there, no explanations given, for six hours—and drug me as well there so I would be held, unconscious.

2. Second, there was no cause for anyone at the front desk of South Shore Emergency Department to hold me at all, to admit me, or treat me as mentally incompetent—which I was not and am not. I informed the front desk I was there under duress and needed to be home. No one listened or heard. I was wheeled away inside to a second Emergency Department area—which, looking at the information in the medical records provided—seems to have been a Mental Health wing of the ER. I was left there to suffer for quite some hours, without attention. A "clinical nursing assistant" who told me that was her designation and her name was Nelsa showed up after a while and sat beside me and made peculiar conversation, at one point getting up and twisting about and inviting me to "dance for (her)". Another woman being held behind a glass door in a small room made pretend-deranged sounds and smiled and told the ward generally she "liked this one." I informed Nelsa I was a journalist working in a dangerous war zone, this was a case of political persecution, and that was the reason I had been unlawfully brought there under duress. Later in the records from Bournewood Hospital—also filled with lies and fabrications—notations on my being supposedly "unemployed" for years [which I was not and am not] stated "Chief complaint": "I'm a journalist and protected by international laws" while the Aspire Health Alliance notes record a whole covey of fabrications and lies including "developed delusions" "hearing satanic voices" "believes energy beams from the government are hurting her" "stays up talking to herself" "is not able to hold friendships" "reports she is "afraid"" and other inventions which appear to have been written up by a particularly deluded, dense, or malicious party. None of these are or were true, and I had no conversations with anyone there on any of these subjects, none whatsoever.
3. Third, I was knocked out several times while being held in that Mental Health wing or corridor, I came to once after drinking some water from a water fountain at a corner, finding myself on an operating table with the man, suspectedly working for the CIA, who was playing Spouse-Impersonator that day, sitting opposite, freely telling lies—as if my real spouse, which he was not—to a woman who came into the room and announced herself as "Dr. Wen." This Doctor either was an anesthetist, as noted on the South Shore website, or some one else apparently permitted to knock people out from behind their heads for the second South Shore knocking-out happened then—after she maneuvered herself behind me. This time when I came to, seeing the supposed spouse absent, I stepped out to find him, in order to catch a ride back home—to my own private home, from where I had been abducted, by this clutch of conspirators seeking to deprive me of all my basic human rights—and was instantly pursued by perhaps the entire block of "observers" at the desk, who had not bothered to introduce themselves to me but came urgently over and grabbed me at once, men and women both, one clutching me at my elbow, and knocking me out again. Knocking women unconscious at the ER at South Shore Hospital is apparently a constant pursuit, and one which the Knockers are quite adept in—using just the right kind of drug to wipe out consciousness and memory both, for, it appears, pre-decided periods of time.
4. Fourth, I was apparently knocked out with a peculiar kind of drug which delivers an odd neuro-tunnelling kind of effect for I was then re-planted on the stretcher pushed up against the desk and left there it appeared for an extended period of time yet could not quite grasp the full details of the scene around me, but seemed to have been pushed into a kind of comatose, dangerous state--when certainly I could have died, for I have many allergies to drugs, and certainly do not and have never taken any kind of neurotoxic medications in my entire life. Example once again of dangerous, deadly behavior by so-called nurses and doctors in a hospital setting--with no thought for actual healthcare, common sense, or critical thinking--or care for one's actual health history. After what seemed like hours,

while seated on that stretcher, a short man in a white coat rushed toward me and announced he was Dr. Chen and had I heard any voices or seen any images? I assured him I had not. He seemed to disappear and a tall African-American man in casual clothing said to me That's Dr. Chen, he's the top doctor here, after which I was swarmed all of a sudden by a bunch of men, security guards and nurses, I surmise, some in all-black, some in motley clothing who literally flipped me over onto my back and wheeled me into a separate room on the side, trussing me down at speed on that table by the ankles and one arm twisted over my head and bound down. Shocked, I asked them what they were doing and what they wanted, was it Blood? Three of them, one a woman I think, had large horse syringes in their hands. I was clearly knocked out then again for I came to briefly to find myself being partially sat up, arms lifted over my head, while my shirt and sweatshirt were being pulled off me. I was knocked out then again, seemingly from behind my head, so anything could have happened--gang rape, attempted murder, strangling, drugging, breaking my head open. My family was not there beside me to safeguard my life and well-being. Every South Shore staff encountered so far had turned out to be a maniac.

5. Fifth, when I came to the next time I found myself still bound, with a man standing in front of me with what looked like a generator of some kind, lifting what seemed to be a hospital top over my chest and sticking tags under my breasts. Horrified I asked him what he was doing and he said he was doing an EKG. I asked for a woman to speak to. He looked at me for a moment then left. A young woman came into the room and stood by me for a minute. Then she went behind my head and I was knocked out again. In the brief moments of my being left alone I noticed it was dark in the ward, I was in a separate glassed room outside the main corridor, and a large man sat by a computer just outside this cubicle, looking at his screen with absorption. Being knocked out again, I recall nothing else. This was a forced EKG, ordered by no-one--not by me, and not by anyone in my family: who ordered this EKG to be done on me? Who ordered that I be swarmed and thrown down and attacked with syringes with God Knows What inside them? Was it the CIA? Are we all in Black Ops Special Access world now and I am supposed to accept this can actually happen to a grown woman--who is moreover Private, a Living woman, on Land and Soil, a Journalist, and sure as heck "mentally competent" with her own Powers of Attorney? How often does South Shore do this to women the police capture and bring in for their Drugging pleasure?
6. Sixth, several things did occur, I have learned, when I was held unconscious for further hours at South Shore's incredibly traumatizing Emergency Department. Since that traumatic forced-incarceration, frequently drugged, both at South Shore's Emergency Department and at the Mental Health Emergency Department, on the night of December 20th, 2022, I have been accessed painfully continuously and vibrated painfully with remote-access military electrical neuroweaponry and at the back of my left shoulder, on my left upper arm, down the length of my spine, at the top of my spine, and at my heart, in fact at several spots on my chest including the location of my heart at the left of my chest, the center of my chest, and under my left and right breasts; I have been painfully vibrated at sites on my back and spine, and beeping bar code scanners being used by UPS men and USPS men and Fed Ex men have indicated they are sending signals deep into implant sites: clearly I have been unlawfully, non-consensually implanted: This is obviously a crime, a massive crime, to add to the list above.
7. Seventh, reading the rubbish noted on the record by Dr. Wayne Andrew Chin, who ordered several dangerous drugs to be pumped into my body while already knocked unconscious, Jaime Hayes MSW who has written up absolute lies and inventions on the Aspire forms, Dr. Olga Novikov-King who apparently filled out a Section 12 form for another Section 12--emergency hospitalization--while I was right there--unconscious--at the South Shore Emergency Department on a supposed Section 12 (for which Quincy Police and the Quincy District Court could produce no Section 12 forms) alleging all kinds of lies in her checkmarking on that form, and each one of these allege complete concoction like "psychosis" and "danger to self" and other lies, all to justify their own criminal behavior in strapping me down and violently attacking me to strap me down--when I was in fact physically sick and silent or speaking calmly--it is clear this entire lot of doctors and nurses has acted as if by rote, falsely attributing "psychosis" and "danger" to me as if often to others as well, and rushing to legitimize it with false-allegations and claims noted down in the record.

8. Eighth, further criminality is evident in Dr. Chin advising an inpatient placement--for no reason at all--while I was knocked out at his neurotoxic drug order, and South Shore and Aspire deciding to despatch me to another unknown hospital, almost sending me to one called Taravista and then sending me to Bournewood Hospital--which I knew nothing about then, not even which town it was in, another traumatic trip prefaced by men in black grabbing me in the lobby of the "Annexe" by the parking lot and knocking me out yet again for another strapping-into-stretcher ride where I came to only to find myself once again trussed and bound and being fed into the back of a large white van, an unmarked ambulance.
9. Further anomalies and lies on those records: Receiving-parties "Andrea Terenzio" and "Richard Spiro" named on the forms from Dr. Wayne Andrew Chin and Dr. Novikov-King did not do any receiving at Bournewood when the van pulled in; an RN Christopher Napolitano was the lone receiver, who also lied on forms and note pages, no evaluations of any kind were conducted, lies were noted as to date of arrival, and whole narratives of lies sprinkle all the way through on the Bournewood records, also received only after much asking and re-asking. As a consequence of South Shore Hospital's extended crime against me, I was then put through an extended 8 days of incarceration and harm at Bournewood Hospital, where I was held without hope of reprieve, and where I suspect I was once more implanted.

Further information on all that I was put through in that time period by unlawfully-acting physicians and psychiatrists can be found in my letters to Bournewood and all other parties named here.

You are hereby requested to correct all the lies, fabrications, inventions, inaccuracies and narratives noted in all medical records you have affiliated with any form of the name "Ramola Dharmaraj", to remove all "diagnoses" from any of the physicians at South Shore Hospital or Aspire Health Alliance alleging "unspecified psychosis" or "delusional disorder" and notation of needed admission as "Acute Inpatient", to correct all the time-stamps for the entire time period I was held there, remove the lies regarding a hold beyond midnight on the 20th of December 2022, and correct the nature of the record to address only what was done to me and not to some other fictitious person with a weight problem thrown in as well, as evinced on the South Shore records.

As a journalist exposing the crimes of the military-intelligence-academic-private sector complex in developing and using deadly anti-personnel directed energy weapons on people, I have been wrongfully cast as "Mentally Ill" by the very parties who seek to hide this military weaponry which has been brought into the DOJ, FBI, and local Police Departments, as well as placed in the hands of innumerable so-called researchers and operators; I am addressing and invalidating this lawless and false psychiatric profiling. All labels and lies placed on any record associated with the name "Ramola Dharmaraj" are hereby invalidated. Doctors are not gods, your hospital has wallowed in lies and actions of harm against me, and your word does not stand. The so-called "diagnoses" of lies and fabrication affiliated with the name "Ramola Dharmaraj"--called up on demand by the Boston FBI, the Boston CIA, and the miscreants at DARPA, DOD, DOJ for reasons of unlawful and torturous human experimentation for all kinds of projects including Brain Projects--are hereby invalidated. You are required to terminate all lies, so-called diagnoses, and labels associated with the name "Ramola Dharmaraj", to return all funds received in payment from any member of my family or pretending member of my family for the time-period of my incarceration at South Shore Hospital, to ensure the removal of all such lies and labels from all agency databases, to remove this name from any and all "Continuing Care" or "Care Coordination" projects and cease all attempts if any to engage in any kind of interference with my affairs. All inaction on this matter is Defamation and Smearing of my name for apparent further procurement purposes, and will be addressed as such.

Kindly return mail in three days to let me know you have done so. I reserve the right to freely publicize the crimes committed by South Shore Hospital and Aspire Health Alliance against me, to publish news reports on this matter, to take further action as needed to protect my reputation as an author and journalist, to issue notices, and to widely inform all in Massachusetts of the great harms enacted by your hospital against an author and journalist whose life you had no right to touch, let alone attack, as you have.

This letter is being copied to the Board of Registration in Medicine, the Office of Civil Rights at the US Department of

Health and Human Services, to Secretary, HHS, Robert F. Kennedy Jr., and to the licensing department of the Massachusetts Department of Public Health. South Shore Hospital needs to change its ways, not attack journalists reporting facts, reporting crimes against humanity, and working for the true health and well-being of the people of the United States of America and the world.
