Dear Manager:

Please send me the following medical records for the name "Ramola Dharmaraj" or the misspelling "RAMOLA DHARMARA" or any form of this name for the dates December 20, 2022 and December 21, 2022, and for the dates succeeding referenced below :

- 1) **The Patient Care Report, Medical Records, and Medical Necessity Certification Statement for Ambulance Services for MMT/Midwest Medical Transport Company (named on my health insurance records)** and any other form or information regarding this ambulance which brought my physical living body to Bournewood Hospital the night of December 20, 2022 or early in the predawn hours of December 21, 2022, with exact Time of Arrival, exact Intake records, and information on the need for South Shore Hospital to send me there to Bournewood on a supposed Medical Transfer of my physical living body—which was ambushed and knocked unconscious with a neurotoxic drug at the South Shore Hospital Annexe lobby near the back parking-lot by black-uniform-clad people, after which I was strapped down, unconscious, and loaded into their ambulance and driven to Bournewood Hospital for no reason that I was told whatsoever, where I was met at the door by Psych RN "Chris Napolitano" who had no "Intake" conversations with me but who was told (by me) I was there under duress, was a journalist and an Internationally Protected Person, and needed to go home, which was ignored, as I was held there that night and further incarcerated for 9 days, being able to leave only on December 29, 2022;
- 2) Any **"Application for Emergency Restraint and Involuntary Hospitalization" Section 12a or Section 12b or any other Section Application and Authorization forms** in relation to this Capture and Transport by **Midwest Medical Transport Co.**, and reason for Bournewood to capture my living physical body in this fashion, essentially procuring it unlawfully for an extended stay, while recording lies and hearsay on medical records affiliated with the name "Ramola Dharmaraj" or the false "RAMOLA DHARMARA";
- 3) Any and all **"Application for Emergency Restraint and Involuntary Hospitalization" Section 12a and 12b Application and Authorization forms using the name "Ramola Dharmaraj" or "RAMOLA DHARMARA"** or any form of these names from any party whatsoever, whether **Quincy District Court, Quincy Police, Brewster Ambulance, South Shore Hospital, South Shore Mental Health/Aspire** or any other party;
- 4) All **information provided by Brewster Ambulance staff to South Shore Hospital staff** carrying the name "Ramola Dharmaraj" including **all Section 12a and Section 12b Application and Authorization Forms, Patient Care Reports, and the "minimal records" and "booklet of journal posts and claims she has made"** notated on the Brewster Ambulance Patient Care Report for that day, December 20, 2022, if also provided and made available to Bournewood Hospital at time of my incarceration there or after or before;
- 5) All physician and RN notes, directives and reasoning for **the reason I was 1) received by Chris Napolitano, RN and then held incarcerated at Bournewood for 9 days for no reason whatsoever; 2) held by Dr. Richard Spiro, MD who showed up minimally and for the first time on December 22 and should have let me go immediately, but didn't, and by Dr. Raphael Weinstein, MD who showed up on December 26 and should have let me go immediately but didn't; 3) signed into a supposed Section 10 on Friday December 23, 2022 by Samantha Bayuk, LSW** who was asked about the fastest way to get out of Bournewood and who then signed me in as a voluntary inmate in this Maximum Security Prison—in obvious Malice and Fraud—and then **also signed me in to a 3-day Notice on my mention of same, after which she disappeared and did not speak to me nor seek to secure my release** from Bournewood's Mental Asylum for a further 6 days, apparently intending to secure new Psychiatric Labels. All false, and every RN and OT and Psychiatrist at Bournewood has to have known it, since they all had perfectly Normal conversations with me—yet appear to be running a whole "Mental Health" Construct of Lies. Please note: I do not use signatures and did not sign myself into Bournewood at any time. I was wrongfully admitted then held without reprieve for 9 days, with Medical Malpractice from various parties as noted above, each behaving unlawfully.

I am the sole authorized agent for the name "Ramola Dharmaraj" and for any form of this name thereof, all forms of this name have been expatriated and reclaimed by myself, the living American woman, on the Land and Soil of the United States of America.
