**:Second Letter of Notice Regarding False Information, False Claims, and Invalid "Diagnosis" in
relation to the appellate "Ramola Dharmaraj"**

Dear Margo Etcher-Reyes and Marcie Fowler,

This is a second Letter of Notice to follow my letter of January 9, 2023 (Letter of Notice Regarding False Name, Mistaken Identity, Impersonation Fraud and False Diagnoses Associated With This Appellate and My Living Self; Request for further clarifying information)--for which I have not received a response as yet--to establish the following, and to apprise the Department of Mental Health in the Commonwealth of Massachusetts of the following:

1.) As a **real, living woman and Massachusetts state citizen who has returned to the land and soil of The United States of America, Unincorporated, and is an Internationally Protected Person, I was press-ganged out of jurisdiction and brought under duress on a Section 12 on a false name in a case of mistaken identity and impersonation fraud to your facility** (from South Shore Hospital via Brewster Ambulance and Quincy Police Department) apparently on 12/21/2022 (I had initially thought it was 12/20/2022, the day I was kidnapped from my home by Quincy Police and brought to South Shore Hospital, from where I was transported to Bournewood, but your Discharge Instruction sheet says otherwise) ; although I repeatedly notified staff of this situation I was not released. (My letter of January 9 included my Declaration of Political Status and my letters sent to William Frances Galvin, Massachusetts Secretary of State and to Antony Blinken, US Secretary of State informing them of my International Protected Person status.)

2) The term "**Unspecified psychosis**" used as "Admission Diagnosis" on your Discharge Instruction sheet dated 12/29/2022 **is inaccurate and blatantly false**: I was in no state of psychosis whatsoever when I was brought into your facility, and calmly informing the reception party (Chris) of my state citizen, International Protected Person, and out--of-jurisdiction status cannot be construed as an "unspecified psychosis." Kindly correct your records accordingly.

3) The term "**Bipolar disorder, current episode manic severe with psychotic features**" used as "Discharge Diagnosis" **is inaccurate and blatantly false**: during my entire, forced stay at Bournewood Hospital, I was in no way in the throes of, nor evinced at any time any kind of disorder whatsoever, let alone a "bipolar disorder" with an "episode" that could possibly be termed "manic severe with psychotic features." The doctor associated with this notation, Dr. Richard Spiro, has committed a grave crime of defamation and slander here and is being reported to the Board of Registration in Medicine, the Consumer Protection Bureau, and the Commissioner of Mental Health, Massachusetts. My entire stay at Bournewood was calm and peaceful, as your own security cameras and staff will attest to.

4) The terms "**risk to harm to self, Acute deterioration in functioning**" used as "Reason for admission of care" under MD/LIP on Page 2 are **inaccurate and blatantly false**: I was wrongfully detained on a Section 12 on false claims on 12-20-2022, when I was physically ill with sinus congestion, and not engaging in actions of harm to self in any way, nor was I "acutely deteriorated in mental functioning" in any way; I was merely physically under the weather and resting quietly in my home.

5) As I explained in my letter of January 9 (which I will enclose in copy for the Commissioner of Mental Health), the false Section 12 was run on me by my husband in **misled and mischaracterizing actions linked to his inability to accept my religious practices in Christianity**, my religion, which he was not raised in and has little understanding of; this is a private matter between us and we are now addressing it privately. As a consequence of his misled actions I was not merely falsely identified and press-ganged out of jurisdiction--a crime of personage and barratry--I was **manhandled by Quincy Police and abusively attacked by security guards at South Shore Hospital, plus unlawfully held for over 24 hours there, under duress, without consent**, prior to my being unlawfully brought, again under duress, without consent to Bournewood Hospital: this is unacceptable, and I will be writing separately to the Commissioner of Mental Health as well as the Attorney-General in Massachusetts about this criminal offense.

6) The reason I chose to **open a channel of diplomacy, still as a state citizen and Internationally Protected Person and diplomat, and autograph myself** into your facility on 12/23/2022 on a 3-day-notice and thereby avail of your services for an extra 3 days is because of my husband's inability to see eye to eye with me on the matter of my religion and my desire to take control of what was clearly an abusive and disrespectful situation. The warmth, kindness, hospitality, and congeniality of all your staff and your protocols of protective care made it the correct decision for me then, and, as I noted in my previous letter, I am appreciative of and grateful for all the efforts made to make me feel completely at ease in your facility, for the entire time period that I was there.

7) I have fully **revoked all tacit, presumed, or other consent of continuing or follow-up care** post 12/29/2022 when I left, as noted on any of your paperwork and computer forms, as discussed with either Madison or Samantha, your social workers, and as requested earlier, am once again requesting from you written confirmation of such revocation, within 7 days of receiving this letter. If any third parties were involved in "After care" or "Continuing care" I am fully revoking all consent to same and asking that you kindly take steps to ensure the ending of same, and provide me written confirmation of all such termination and revocation, within 7 days of receiving this letter.

8) As noted earlier, I have become the **target of whistleblower retaliation as an investigative science and technology and human rights journalist, with False Mental Health Diagnoses** being laid against me since 2013, when I began researching and reporting on matters of harm to civilians from abusive Surveillance practices, new and emerging technologies--such as directed energy technologies, neurotechnologies, and Artificial Intelligence nanotechnologies--used unfortunately in non-consensual military and intelligence experimentation on people. The work that I have done, as a writer and journalist, and the work that I continue to do is in particular being targeted for disappearance and discrediting by these actions of repeated false-diagnoses being laid against my name and living self: dismissing me as mentally unstable, mentally ill, and mentally questionable would obviously be greatly deleterious to the worldwide cause of human rights and protection for all citizens in our country and internationally. I am presenting this information to you therefore and to the Department of Mental Health to openly invite your awareness, recognition, and inclusion of these facts in the conclusion of this situation. My website The Everyday Concerned Citizen (everydayconcerned.net) offers much information on these subjects; I invite you to peruse my articles and video interviews linked there, and to follow my human-rights-focused work in journalism which has always been intended to bring respect, caring, compassion, and human rights back into government and Law Enforcement, Military, and Intelligence, for everyone.

My purpose in writing this letter is merely to inform and Notice you all of these facts, and to correct the record as linked to any form of my name. As I noted earlier, I have expatriated and reclaimed all forms of my name, and no form of my name can be used against me nor used to capture my living self by police, courts, or EMS operating in the sea jurisdiction; I hold my own power of attorney and no-one, not even my husband, can move to force actions of psychiatric evaluation or civil committal on me; I will enclose my expatriation documents for your understanding. What was done to me--including by him--was done in error, fraud, mistaken identity, and criminal trespass. Further: As should have been evident at your facility the entire time I was there, I am not in any way mentally ill (as you know, while I was there, I was exploring ways to work as a creativity consultant with the truly mentally challenged, and this is still an interest of mine), and it is important for me to establish this fact for the sake of my work as a human rights defender and journalist. Hence my interest as well in clearing this matter up entirely with the Department of Mental Health, Massachusetts, and the entire train of false psychiatric labels used on me since 2013 when my journalism and reportage began, all only in Massachusetts. I am very keen to ensure that no further harmful medical records are made in (any form of) my name and against me anywhere, based on these very harmful actions and labels executed on me in Massachusetts, the "records" of which I am hereby correcting and invalidating; I am giving Notice to all parties to remove me from any of their wrongful programs of non-consensual scrutiny,

surveillance, research, detainment being hidden even as "aftercare" "community care" and "public safety."

Once again, I thank you for your gracious hospitality to me while I stayed at Emerson 1 at Bournewood, and look forward to receiving confirmation of termination of all "follow-up care" and "after-care" as noted by anyone there, within 7 days of receiving this letter.

Please retain this letter as also my previous letter for information in your records, with all and any forms of the name "Ramola" used in your records -- as noted earlier, the name "RAMOLA DHARMARA" on which I was held unlawfully there (as also at the previous place South Shore Hospital) is false. For purposes of clarification, "Ramola" as I stated at Bournewood throughout is my given name, and "Dharmaraj" is merely my family name and not my "last name," which is a convention to denote a "legal person" or "legal fiction" used only in Maritime/Admiralty/Sea jurisdiction, of which I am not a part.
