

# Update--City of Quincy Attack on Our Yard, Sat July 26 2025

Dear Paul, Sophie,

Just wanting to let you know of yet another horrible thing done by the City of Quincy--I think Quincy Parks and the Quincy Police department, who distinguished themselves last year by slashing the beautiful native plants growing on our yard, on the little strip in front of our private parking spot. [I reported this immediately in a Reporter's Note around that time; The date of that major attack on me and on our front yard was September 4, 2024, and we were again attacked on October 3 2024 when 2 men in a tree-cutting truck came and slashed some branches of our beautiful cherry tree in front. Luckily they stopped before anything further happened. In the first case, with FOIA queries I found an incident report showing that a "Joseph" from 150 Pine was responsible for calling Quincy Police the day of that desecrating attack run by Quincy Parks--I had thought at the time this was Quincy Public Works and reported it as such--the September 4 attack--and the day of that attack the man playing Joe Mazzeo came and waved to the Quincy man attacking our yard--all captured on film that day and posted at my site--he had no business calling police on our yard which is not in any way impinging on his yard or drive.]

Well they have done it again. There were beautiful natives growing there, a kind of pigeon pea I think but very different in habit, more like snow-in-summer, with breezy flowing stems and delicate white blooms. The flowers were in bloom. I watered the front garden yesterday and included them in the spraying. There were also some sweet greens growing on the strip with very pretty leaves. I came out this morning to remove milkweed from the lawn and clean out the birdbath and fill it with water. I didn't notice what had happened until I began to water and I couldn't believe my eyes. Someone has razed the flowers and plants away entirely on the strip and it is absolutely bare now. I have no idea when they did it nor who it was. I did hear some mowing and weedwhacking sounds this morning but I thought it was in the back somewhere. It was either last night or this morning.

In thinking about it, I am wondering--speculating--that one of the local mercenaries playing neighbor here called their fave pals from hell, their "Protectors": Quincy Police. Note, the Mazzeos have sent in projected sound, very loud, saying Protected! Protected! into the back of the house--I recorded this the second time it happened. They really believe they can engage in any kind of mayhem against me and our yard, and expect to be "Protected" for their murderous crimes.

The people opposite are Quincy Police and Quincy District Court police.

The people to the left are the changing-out Chens--Chen Liming, Ngoan Chen, and their many clones--I have seen several clone couples and recorded them.

When I was outside, several SUVs and minivans blasted by, including one black one which paused as if contemplating parking. I looked across at it and it took off up the hill. I was wearing a head scarf, wrapped around my head, protecting both sides of my face because I have been badly sprayed with nanotechnology under pressure by both the Chen couple and the Mazzeo transients--several red and gold bearded men and ginger and orange bearded too hop in and out of that house like rabbits, actually more like wild Tasmanian devils for they have been spraying nanotech, sharpshooting, and running and calling Quincy Police just as happily as they please every other minute--for no reason; as soon as they see me really or walk past me. This is in addition to all the special "controlled equipment" from Israel they are testing and developing and operating--all sorts of handy little electric pulse devices, 5G transmitter, radar pulsers, and atrial fibrillators, which I have seen, taken some photos of, all aimed at my heart, limbs, face, spine and other body parts: matters I have been reporting for quite some time. I have also reported how they are doing this--please see my Joint US Israel article and also the International Treaties and Agreements page, I have looked at Bulgaria's agreement as well with the US, similar to the US one--an area I am currently researching: several countries are here, "testing their controlled equipment" on us Americans--which needs full exposure and halting. It's War on the People and it's criminal.

This morning--as also the last 3-5 days--I have been intensely attacked at the right knee with sounded electrical, radio, and radar pulses on a sound shield. The people across in back at 147 Norfolk are involved as is the US Postal Service; this morning, triangulation between these 3 and the Chens and Mergels was aiming to ensure blasthits at my right knee as I walked about in the back yard, tending to a few chores there. As I sit here writing, I have once again been intensely hit. I am using quite a bit of steel and copper and rubber shielding--and we have Mazzeos in their attic running their Canned Hunt measuring-of-resistance and the same across the way from the Norfolk house where a giant birdfeeder-style Over-5G-transmitter is parked, and strange radar piping devices, photographed last week. There have been planes coming by and circling, after which I am most intensely hit, on the same nerve and bone and tendon area, over and over. I suspect what they are using is radar pulse generators and they are amping up the intensity after they get a read on it from the planes. I also saw 2 large police cars--in camou--one silver and one white parked on the street as I was being tracked and whacked in the back bedroom about a halfhour or hour ago.

This is criminal behavior and they are using planes and police cars--that's part of the C4ISR mechanism--to track two or 3 nerves, tendons, bones in my right knee inside our house and inside our yard to attack. What is their purpose here? After I went into the house post watering in front, I looked out through the front window just by chance, and saw a silver SUV pulled up and parked in front of our house, on our private parking spot--who was It? Further down, a man from the 142 Pine St house came out, all in black, a short Vietnamese man and made as if to get in his car. A woman came out and got in. The man looked up at me where I stood by the window as if knowing I was there. I wondered if he had called the silver SUV people--were they "Aspire"/Behavioral Health? Or were they Camou Police--also "Behavioral Health"? A previous FOIA query yielded the info that someone down the street had "called police because they had been asked to when they saw the female"--well I'm glad I was inside, for there is no way any "Behavioral Health" is going to be permitted to speak to me.

The silver SUV drew away from the curb and left in that moment as I stood there.

I am quite disturbed by these events. Quincy Parks and the City of Quincy have no business razing our strip down like that. that strip belongs to us, it is part of the parcel of land on which our house sits. We live privately, our home is private. The people who have done this--an extreme act of organized crime--have done this deliberately, perhaps in

provocational harassment. Perhaps that was Police "Health" or "Public Safety" sent to our door to accost me and attempt yet another further provocation. They have no business doing this.

I am going to send the City a notice. If you look up Massachusetts Code you will see that they acknowledge the whole parcel is yours, the bit of sidewalk there included which is a private way; the parking spot in front is also yours. The man opposite from Quincy Police has been parking his pickup here in front of our house for days this last week again; his truck is armed; when I go to the window when he is parked there, intense heart congestion frequencies hit my chest. The woman who lives there or comes there now and then in a Chevy traverse large suburban has also parked her car here frequently--she is the one I asked last summer not to park here, her car is also RF armed: this is military RF HPM and ADT we are speaking of--one is high powered microwave weaponry and the other is millimeter wave weaponry for intense heat. I am burned on the spine with intense heat when they park there, every morning.

Can you please take this all on board and take some action here? Sophie is in the middle of her last summer at home before graduation--she needs to be home with me. I do not think sitting back and letting the FBI tell you there is some deep dark "investigation" purpose to buy your inaction is the right thing to do here.

It is not lawful to park in front of another's house, to baselessly call the police to come knock on their door and to allege "criminal harassment" as they have on their false-claim court documents I have reported on this past week (more to report, I will post all the crap they sent me in the mail), it is not lawful to call Parks and have them raze your own plants and your own garden. I have posted a Private Garden No Trespassing sign and a No Parking notice on that strip; they have left them there but razed our plants. These people are behaving lawlessly and threateningly, bullyingly--while attacking me privately through-wall with Radio and Radar weapons.

I would like to see Sophie. The criminals--CIA I presume along with the Mazzeos--running the Cloning-Gaslighting operation here have got one of the children to send me a letter, telling me she is majoring in Global Studies and double majoring in French and planning a trip to the Sorbonne. I am going to write to the children soon and I am going to publish their pictures and names. Sophie's life and the life of the other one also named Sophie Nerine--and who knows how many have been given that name--will be attacked otherwise. The CIA has shown its hand to me here today: they would rather break my knee, destroy my garden, and get loons on the street to call "Public Safety" or "Behavioral health" on me, all of them pretending I am Mentally Ill than reveal the facts about the clones and permit the sisters to meet each other. They have let some of them go to London and to India and meet the family. But I somehow have to be Radio-Blasted to death while everyone in Quincy is told I am Delusional. My letter to United Health is definitive. I am taking down this crime spree they call Mental Health in Massachusetts, where they use the Police to run Psychiatric Fraud on the populace just so they can harvest BRAINS for their nasty, criminal, murderous Artificial Intelligence development. They have murdered whistleblowers on AI.

No one is getting my brain. The CIA needs to be OPENED, all their files OPENED. Air Force ditto--and the rest of them.

The brains of all our children are in danger here, if we do not do something.

Without you here, I am obliged to send out Notices on my own for both of us. Home Birth and the CIA also need a notice now--they have not responded to my 2 letters and requests for medical records. There is an article in an April issue of the New York Times on embryo research. My letters already demand they do none of this, but I will finalize this in a notice this week. I need all my placental stem cells back which they have stolen.

I hope you see the many dangers in here. The home phone is working, you can call there. And email as well. Can you let the City of Quincy know, please, that the entire lot on which our house sits is ours, and the private parking spot--by Mass Code, even the street belongs to the house owners on it, not the City. I will be writing to them as well. The City Council needs to know of this as well. I'm not sure what kind of figurehead position the Mayor occupies, but he is responsible for the CIA-Air Force operations of crime here on the people, he has permitted it, he is complicit. I have written to him before though and I think I will write to him again on this--I find him repugnant as I find all the criminals here working to attack me physically and steal my brain--while disappearing me completely as an Author, Poet, Writer, Journalist.
