Dear Tulsi Gabbard, Director of National Intelligence, Senator Tom Cotton, Chair and Senator Mark Warner, Vice-Chair, Senate Select Committee on Intelligence, Senator Elizabeth Warren, Senator Edward Markey:

This is Ramola D, a writer and journalist who has been unlawfully targeted by the Boston FBI since late 2013. Letters and requests to them have gone unanswered, as also letters to Governors and Presidents. Without my consent the FBI appears to have entered me in various programs run by the US Air Force, the CIA, and other entities who have used counter-personnel directed energy weapons, neuroweapons, and nanoweapons on me for 12 years now. I have repeatedly exposed this matter and repeatedly sought to bring human rights attention to the entire subject of Military Weapons Testing and Intelligence Brain Experimentation on Americans. Please peruse my compendious reportage at my website everydayconcerned.net. Please know also I am a living American woman, standing on Land and Soil, and living privately; my paperwork is complete and my documents recorded at the Land Recording Office.

This Notice was published last week to notify all agencies and governments they do not have my consent in using and abusing my body and brain in any kind of experimentation or/and operation: [Notice to All Agencies, Militaries, Governments, Private Corporations, Universities, Laboratories, Research Institutions Regarding Brain/AI/Weapons/Psych/Any Experimentation/Operation on People and Animals: You Have No Choice But to Halt Immediately--There is No Consent | The Everyday Concerned Citizen](#),

I must be removed from any and all programs and projects of experimentation, operation, research, testing, development, or evaluation of any kind of technology, weapon, methodology, process run by any Intelligence agency or military division, any country such as Israel which collaborates with the US on such projects. any entity whatsoever, and from any and all "Public Safety" projects run by any Law Enforcement Agency purporting to safeguard Public Health, Behavioral Health, and Community Safety, falsely imputing Mental Illness--as local police here, the Quincy Police Department, and complicit Massachusetts psychiatrists have done, attacking my Name, Reputation, and Life, since October-November 2013.

I am still working on fully reporting and lawfully addressing the unlawful Police, EMS, Hospital, and Doctor attacks on me in April 2022 and December 2022; my letters and Notices so far on this matter are being published at my website at [False Psychiatric Profiling Being Ended: Additional Information, With Letters | 2013-2025 | The Everyday Concerned Citizen](#). I have been subjected to extensive Police Harassment since December 29, 2022 when I managed to escape from Bournewood Hospital--being discharged finally, after many unlawful and illegal actions by Bournewood staff and psychiatrists Dr. Richard Spiro, Dr. Raphael Weinstein, Samantha Bayuk, LSW, Madison Allred, LSW, Michelle Prophet, RN, Christopher Napolitano, RN, and others. I have written to the City of Quincy, to the Mayor and the City Council, the Office of the City Clerk, the Massachusetts Attorney-General (Maura Healey and Bessie Dewar), the US Attorney-General, the Secretary of State Francis Galvin, the Governor (Charles Baker), Presidents Trump and Biden, Senators Elizabeth Warren and Ed Markey, and the Senate Intelligence Committee and many others over the years to report the military, intelligence, and police persecution I have suffered, for no reason whatsoever--and which has not been stopped, but continues, as if my body and my soul can withstand such insane torture, for years and years and years forever.

My life is continuously in danger, and it appears the criminals running Artificial Intelligence and other forms of criminal Brain experimentation are keen on damaging my brain in addition to sending in lying reports and false claims to local police which has resulted in intensive police harassment since April 2022, and perhaps earlier, from December 2021 when I visited a local doctor Dr. Leslie Alexander after the locals had almost dislocated my arm and subjected me to intense arm and shoulder attack with RF HPM weaponry--Radio Frequency High Powered Microwave Weaponry, which is inhumane and which must be banned. I am writing today because I was massively electroshocked on my Brain yesterday and attacked with a Left Brain Neurostrike this morning. I was also electroshocked with long-range electrical pulse weaponry--akin to nsEP, nanosecond Electric Pulse--at lower intensity while I lay sleeping this morning, striving to rise as I was spinally heat-hit and brain-shocked.

Excerpts from my private print logs for today, June 29, 2025:

*9:30 pm and 11:20 pm, June 28, 2025: Extremely intense electroshocks sent to the top of my head despite damping rubber shielding worn in a cap plus Reflectix and some counter-EMF fabric in hat.*

*This morning, before I woke, harassed and attacked continuously in bed on top of head, neck, and feet with electroshocks which went down my head, spine, and made my feet jerk. It was 7:25 am when I got up, and I had been attacked--shielding each time with rubber, stone, my hands--for about an hour or slightly more.*

The military radiation weaponry that has been used on me is inhumane in my opinion, it sends a message to the world that the US Government is engaging in inhumane actions and profound human rights and civil rights violations against Americans. It must be stopped in its usage and any further development.

Let me also make a point here about Brain Interface Technology. Clearly I have been unlawfully stealth-implanted, I suspect once at Virginia Hospital, Arlington, unwittingly, in 2005 when I had gone to the ER after a sudden 5-hour major kidney hit with what I recognize now must have been a Directed Energy Weapon such as RF HPM, and once at South Shore Hospital, Weymouth in December 2022, the latter where I was taken as an unconsenting captive by Brewster Ambulance, a EMS contractor with the City of Quincy, engaging in a second act of crime against me, despite my letters of notification and claim to them after their first kidnapping crime in April 2022. It is this Brain Interface technology now, unconsented-to, which is being used to send electroshocks to my Brain and Body to, in order to apparently brain-damage and neuro-retard me. BCI Tech therefore is both a means for miscreants to attack people in stealth thus and to call it "Electro Convulsive Therapy" that's supposedly needed for "the Seriously Mentally Ill" without their consent, because they are "unable to consent" and must be medically-kidnapped, as involuntary patients, and "treated" by Law, by Statute, and by Court Order--methodologies being used nationwide now to capture, knock out, strap down, and brain-implant hundreds of thousands of people, in a massive Crime Spree which needs immediate halting. Please see my reportage especially on Massachusetts crisis-system captures (Mental Health Coverage and Mass Coverage at my website) addressing this subject. Brilliant, outstanding, highly educated Americans, youth and children with great potential and much vibrancy are being attacked in this fashion in every State, a horrific modern-day crime run by a collusion of medical, court, and law enforcement professionals all in aid of the health insurance and military neuroscience industries.

I hope I don't have to state I am not Mentally Ill. I never have been, and Mental Illness does not exist. As a science and technology journalist investigating this subject, I will be reporting more extensively on this matter. The entire cult of Psychiatry run by DSM-obsessed doctors can and must be seen for the charlatan private cult that it is; unknown to many, the History of Psychiatry clearly reveals that "Mental Illness" has been developed as a field over time, primarily to extend Authoritarianism into home, family, social, and work life, and obtain Chemical and Pharmacological Power over people's brains. This is a profoundly serious matter which we need as Americans today and as people worldwide keen on Evolution and Consciousness to address comprehensively and intellectually--for there are Medical and Military Miscreants here who want to lower the IQ, Brain Capacity, and Brain Functioning of all People, which is forbidden both by Civil Rights Law, Human Rights Law, and International Law.

I am writing also on another matter. Since I returned home from Bournewood in December 2022, I have been subjected to much which has informed me definitively that my husband, Paul Jeffrey Tanis, a Director of Tax Law for Exempt Organizations working for Price Waterhouse, copied here, has been Cloned, and that his clones include genetically modified clones. I have published on this matter at Notices at my website. Please see [Notice of Cloning & GM Cloning.](#) [The Everyday Concerned Citizen.](#) Since then, I have also been subjected to much gaslighting and attack by a network comprising the clones and the local mercenaries here at 150 Pine Street and 156 Pine Street as well as 153 and 151 Pine Street--and many other houses closeby, but especially the named owners of these houses and their numerous tenants, Joseph and Samantha Mazzeo of 150 Pine, Chen Liming and Ngoan Chen of 156 Pine, and (tenants of) Breanne Higson-Starsiak and Stanley Starsiak of 153 and 151 Pine--who are the ones submitting false reports and lies to local police, inviting continuous police harassment, in what they imagine is "Sequential Intercept Model" protocol--which does not and cannot apply to anyone such as myself, perfectly sane, lawful, and peacefully and calmly living on the Land and Soil in my own private home, taking care never to communicate unless necessary with the manic mercenaries here practicing Brain and AP DEW experimentation.

I must also inform you that while I was discovering my husband had been cloned, I was also discovering my daughter had been cloned, and the several father-daughter duos who had come by here for 2-3 weeks at a time, some for shorter times, since April 2022, I have now established--thinking through all--included some clones of Paul and some non-clones of Paul, all wearing camouflage mustaches and beards, just like CIA spies (I suspect some or all are in fact CIA spies).

My daughter Sophie Marguerite Nerine graduated high school in June 2022, but I was not invited to her high school graduation. The Boston FBI and CIA both, in collusion with the Quincy Police Department, have, it appears from the evidence--including a recorded police visit for 1.5 hours on April 15, 2022 when I was unlawfully being kept incarcerated in a Boston hospital, Steward Carney Hospital, having been unlawfully kidnapped and taken there by Brewster Ambulance and Quincy Police--removed them from our home, possibly with a false-claim "National Security Letter" purporting need for some kind of extended investigation of myself. [There is nothing to investigate about me, my work and words are quite fully online and have been since 2014 when I have been working as a journalist, exploring matters relevant to National Security. My books however, published both before and after 2013, have been disappeared online by the CIA--I am presuming the CIA is involved although I would love to hear a confession--and certainly they will therefore become a matter for investigation, I suspect, by all literarily inclined.]

In any case, while several father-daughter Clone and Near Clone sets traipsed in and out of our home right up to late 2024 when I put my foot down and published my dissent to this crazed scheme of Eternal Gaslighting, my real daughter and husband have been kept removed and incommunicado--exactly as if we were all starring in The Bourne Identity or some other convoluted Hollywood thriller screenwritten by an ex-CIA agent. The CIA, which has had a firm hold on my life--I believe--since then, running Scripts and Skits for the locals to enact with gusto, has also overlaid all my email ids and phone ids, set up Voice Morphs and Deep Fakes--two visited last weekend and engaged in persistent harassment for 4 days, pretending to be my cousin and my sister, using inadequately practiced Voices however, giving themselves away as charlatans, and engaging in conspiratorial conversation revealing they had an interest in stealing my credit card--and probably other essential items--resulting in my refusing to acknowledge or let them in. Obviously another Heist was being planned, by the Cabal who run the Cloning, the Family Separation, and the Gaslighting; again, I suspect the CIA but the FBI may be involved as well, I am sure you can find out who exactly and how they have done this.

My life therefore has suddenly been plunged into Twilight Zone. Since March 2023 when one of the Paul clones stole my car keys, I have been unable to drive. Since July 2023 when they all left, I have been unable to leave my house, since the local mercenaries--CIA or CIA-affiliated, possibly also QPD, China, and Israel-affiliated, respectively--take pleasure in vandalizing and breaking in and stealing our things. They have also attacked our garden and foliage, which I have Noticed them on, and which they continue to do: I will again be Notice'ing on this matter so their misdeeds may be known to all. My family address books have all been stolen, I cannot reach anyone in my family in the USA or India. I cannot use my phone to contact my family, I reach voice morphs and CIA pretenders. My phone has recently been massively attacked, it is not usable. Photos and videos clog the thing and I cannot download and clean them out. I cannot use the Camera on it, WhatsApp has disappeared and cannot be reloaded, the EMF apps do not work anymore. Meanwhile SUVs filled with Bluetooth, EMP tech, and RF HPM, ADT, nsEP and other weapons park in the Mazzeo drive nonstop and in front of my house, like I have permitted them. [The QPD man across the street in main, and women park in front; they keep parking to intimidate or harass, they also litter my front garden. and I have taken high readings of pulsed Radio Frequency coming from their pick-up trucks and vans and assaulting my heart, face, and knees; I have asked one of them to move her van and not park there, she keeps doing it.]



I am being subjected to Enforced Prolonged Isolation--a feature of Torture.

My daughter is being kept from communicating with me on phone or email. The CIA set up the Clone father-daughter Gaslighting Scenario to play pretend daughter, pretend spouse for quite some time; I refuse anymore to communicate with the clones--and yes I believe I would recognize my real daughter and spouse.

My daughter is entering her final year of her undergraduate degree this fall. I do not know which school she is at. She has spent none of her summers with me or in her own home. My husband and I are not divorced. We are not separated. He has been removed from here, and so has she. She needs to be returned home immediately, as does he. We need to be in communication with each other and we need to get back to our own private lives. Yes we also need to address this matter of many clone brothers and clone sisters here--but I don't think I should be treated as some kind of Primate in a zoo here for the CIA and Israel and China to be "testing their equipment" on and examining our mother-child bonds. Frankly, it is clear to me that the DARPA-CIA cabal--which needs to be exposed, investigated, and stopped--stealing Brains has gotten fixated on my Brain and my family's and is seeking to continue these ghastly experiments, pretending it's all "Minimal Risk." Well it's not Minimal Risk, I am being Brain Damaged here, and struggling every single day to safeguard my physical health, I am literally being blasted every day with RF HPM, pulse-wave and continuous-wave, Millimeter Wave weaponry, nsEP, and much else.

I am writing to you to ask that you terminate these programs completely both in my case and in the case of all in my family--including our now extended family of the clone brothers of Paul and clone sisters of Sophie; each one of them also needs to be freed from this inhumane experimentation--and in the case of all Americans and people worldwide who may be similarly being experimented on. These are unlawful and unethical operations which need to be shut down.

I continue to report on attacks on me and on the larger subjects of military, intelligence, homeland security, NATO, and non-NATO experiments and activities at my website and video platforms. I am writing to the children (the Sophie sisters) using my daughter's email id--which has in the last few years been answered occasionally by one of the sisters, and will publish some of their pictures soon; some of them have been given the exact same name as my daughter and they all need to meet and know each other as well as make decisions on names for themselves. As their biological mother, I have assured them I am there for them all--obviously however I need to be removed from all these Brain and Body Blast projects so I can have my life back again and actually be able to function as a mother.

Please do the needful to return Sophie and Paul to their family home with me this summer and to address this issue of the clones openly so the children and brothers can be reunited and know each other. Please also step forward to end the AI and Brain projects using people--we are all being attacked and tortured unto death here--and animals: the inhumane treatment of animals is not American either.

I look forward to your positive response. Thank you very much for your attention.
