Additional-Information = Ramola D/Dharmaraj Publisher, Editor, Reporter: The Everyday Concerned Citizen, Ramola D Reports c/o 154 Pine Street Quincy, MA [02170] October 16, 2023 To Whom It May Concern: I request the following records as a Freedom of Information Act and Massachusetts Public Records request: In relation to the sudden kidnapping, pressganging out of jurisdiction, and trafficking of this living American woman on land and soil jurisdiction, writer and journalist, and Massachusetts state national/citizen living privately to a "courtroom lock up" at Quincy District Court on the morning of December 20, 2022, subsequent captivity in a jailroom there, and second kidnapping and trafficking using Brewster Ambulance to a hospital without information or cause given, on clear false-claim, please provide: 1) A copy of any relevant Section 12 Involuntary Hospitalization warrant, or Application for Warrant used that day, December 20, 2022, purporting to pertain to this Writer and Journalist-- in whatever form of the name was used to capture her that day, 2) A copy of any "Complaint" supposedly filed in the Quincy District Court and all communications between any party and Quincy Police warranting Quincy Police breaking into this peacefully-private Writer's home, terrorizing, and physically capturing and dragging her out of her home when she was sick and resting quietly on her couch, without information or cause, written or verbal provided to her, without any time for her to ask questions, get her cell phone, purse, shoes or any other, 3) The names of the two Quincy Police officers (two tall and hefty men) who kidnapped this writer from her home and the names of the two Quincy Police officers (one woman, one man) at Quincy District Court who refused to listen to her, shackled her and put her in a jail cell, again, without information or cause provided, 4) All audio and print communications and audio and video and print record of this Capture and Transport to a Court of this Writer and Journalist, prior to, during, and after forced transport, 5) The full name and reason for involvement of the man naming himself "Chris" who spoke to this writer that day and stated he would represent her in a claimed "court hearing" despite her verbal stated rejections of his offer, and her subsequent non-appearance thereof on stated non-jurisdiction, 6) A copy of any "Court Order" or "Court Judgment" or second "Section 12 Application for Involuntary Hospitalization" issued at Quincy District Court at that claimed hearing to any party claiming responsibility for the second kidnapping

that day, pressganging out of jurisdiction, and trafficking of this writer via Brewster Ambulance to South Shore Hospital, whether that was Quincy Police, Quincy District Court, Brewster Ambulance, or any other, including any other party impersonating any member of this writer's family, again without information or cause provided in any way to this Writer and Journalist,7) Audio, video, and print record of any calls made to Brewster Ambulance from Quincy District Court by anyone in Quincy Police or Quincy District Police prior to, during, and after forced unauthorized transport to South Shore Hospital, 8) The reason for a Norfolk County Sheriff van and staffperson in uniform witnessing yet not assisting this writer's predicament as requested by her during the second kidnapping, strapping into ambulance at the District Court, and subsequent transport,9) The reason for apparent police escort of the Brewster Ambulance in which this writer was trapped to South Shore Hospital,10) All "Police Incident Reports" associated with these two forced kidnappings and imprisonment,11) The reason for these major actions of Terror conducted against this Writer and Journalist especially after the unlawful incidents of April 13, 2022 and April 14, 2022 by Quincy Police against this Writer when clear notification of private status and all relevant information surrounding the initiating encounter with the neighbor at that time was provided to Chief of Police, Paul Keenan,12) The reason for apparent arrival of Quincy Police to the house next door—to occupy the same house with the same woman neighbor issuing false-claims preceding the Forced Kidnapping and Capture of this Writer and Journalist on a bogus Section 12 in April 14, 2022—whose name was then kept protected and undisclosed by QPD-- and the reason for frequent police presence and police car presence on the street on which this Writer and Journalist lives in the past few months.This is a media request made in the public interest, all information will be reported publicly at journalistic outlets, and I request all fees be waived.In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request be filled electronically, by e-mail attachment if available or CD-ROM if not, to ramolad@everydayconcerned.net.Thank you in advance for your anticipated cooperation in this matter.
