Dear William Francis Galvin, Secretary of State, and Andrea Joy Campbell, Attorney-General, Commonwealth of Massachusetts:

I am writing to call your attention to the repeated Quincy Police harassment I have been attacked with again, both in recent weeks and months and several times last year, 2024, and prior, in 2022 in particular--and request that you take every action within your power to curb this harassment and definitively end these crimes against me as also against tens of thousands of other peaceful civilian and veteran Americans in Quincy and hundreds of thousands if not millions in Massachusetts similarly attacked by Police, Security, Intelligence, and Military parties--who have no business attacking anyone.

A Quincy Police car was parked in front of my private home yesterday evening, the evening of October 25, 2025, Saturday for over 1.5 hours until 6:20 pm. This occurred directly after an intense Radio Frequency Microwave Weapon (RF HPM) attack on my face, inner right knee, and chest, inducing inability to breathe, extreme pain and congestion tightness at my chest when I was inside, standing at my kitchen sink, directly across from the house next door, 156 Pine, recorded as owned by a couple by the name Chen Liming--who have been sending such RF HPM energy into my home and body and brain since they moved in here; they are obviously running "covert experimentation" for and protected by the CIA, and I have previously reported this and Notice'd this publicly in order

to bring an end to this crime. These DARPA-CIA Mad-Scientist Brain and Artificial Intelligence development programs are being run using Torture as a mechanism to deliberately induce Pain in order to permit criminally-acting military neuroscientists and their third-party contractors to map the human brain, attack people's neural networks, and steal Intellectual Property. As an investigative Science and Technology journalist and college faculty, I have researched and reported extensively on this subject, including, fairly recently, to the Massachusetts Attorney-General Andrea Joy Campbell, Director of the Federal Bureau of Investigation, Kash Patel, and the Director of National Intelligence, Tulsi Gabbard. I have reported nationally and internationally on the unacceptable US Air Force Non Lethal and Directed Energy Weapons Testing operations inside the United States of America involving both testing on human subjects and animal subjects inside laboratories and in field testing programs. I have written to and obtained responses from the Federal Aviation Authority and the US Air Force on this subject, and have published all correspondence. The facts of the existence, development, and usage of Counter-Personnel or Anti-Personnel Directed Energy Weapons on Americans by both the Department of Defense and the Department of Justice cannot be denied. Military journalists have long been publishing on this subject. The Department of Justice via the National Institute of Justice has released into the public domain notice of numerous grants soliciting the further development and testing of different kinds of directed energy technologies, inclusive of Long range Electrical Weapons as in Human Electromuscular Incapacitation (HEMI) electroshocking, paralysis, and cramping weapons, and thermal Through-Wall Millimeter Wave "Active Denial" technologies; they have also published reports of various Less Lethal and Non Lethal Technologies also called "Emerging Technologies" and "Innovative Technologies"--all of which, in this journalist's view, are profoundly inhumane and should be banned and stopped from development and production.

I have also recently surfaced to various human rights bodies including the United Nations the facts of these Human Experimentation and Brain Research Torture Programs which combine the Military Weapons-Testing, Justice Weapons-Testing, various Justice and "Public Safety" operations such as the "Sequential Intercept Model" or "Community Justice Programs"--as it is named in Massachusetts--because they have been reported to me by numerous Americans as involving Sadism and Torture, and because I too have been attacked--for 12 years now!--by these programs which are executed using Sadism and Torture.

As you know I have long changed my political status to living privately, as always non-combatively and harmoniously on the Land and Soil, standing with all American State Nationals, Native Americans, and the First Nations of the Americas in doing so. I have published Notice of my status, and I have sent Notice of my status to your Secretary of State Offices and to the US Secretary of State's office. I cannot therefore be attacked in any way, I cannot be "used" by the CIA or DARPA or the US Air Force, Army, Navy, Marine Corps or any other agency in any kind of "human subject experimentation" "Artificial Intelligence Development" "Brain Project Research" "eMAPS Project" or any other project. Indeed, as a living American who does not consent and has not consented and has never consented to such experimentation on my body and brain, as an Author, Writer, Journalist, I cannot be attacked either, nor can I be used and abused as if I were a Slave living in the time of Slavery in this country--a time which should never have occurred, and which does not Set Precedent for Modern Slavery and Abuse by Military, Intelligence, Police, And Security agencies; Slavery has been Abolished and is a Crime. So is Torture and so is Through-Wall Privacy-Intrusion with any kind of Radio, Radar, or Acoustic Technology. Torture is Criminal, a Profound Act of Trespass on the Human Body and Brain which should be held sacrosanct always and forever or our life in communities, in civil society is meaningless. Disfigurement and Mutilation of another is likewise criminal, attacking people's faces and bodies with sprayed synthetic biology and polymers, and using precision-radiation wands and RF HPM to bloat up faces, create radiation darkening of skin in places and carve lumps and lines in others, destroying jawlines, cheekbones, cheeks, necks, bellies, et al and attacking people's appearance and health is Execrable Crime.

I cannot be subjected to Radio Frequency Attack and Torture, Enslavement, Disfigurement, Mutilation, Burning, I cannot be murdered with the DOD's and DOJ's Directed Energy Weapons and Neuroweapons--nor can any other American. I cannot be attacked or tortured either by foreign nationals living in the United States of America and apparently Permitted to use "controlled equipment" on Americans, an egregious project of inexplicable collusion with other nations to run Research attacks on Americans, which should be scrapped. I have reported on some of these unlawful Science and Technology International Agreements in articles and reports at my media website and magazine, The Everyday Concerned Citizen, and I continue to expose this matter.

I cannot be mischaracterized as Mentally Ill either, in my reportage of the Crimes of Torture in my Quincy and Boston neighborhood, as has been attempted since 2013 via false reports and fraudulent watchlisting, as I have extensively addressed in public reportage. All unlawfully applied False Psychiatric Labels--including, twice, in 2022, with the criminal involvement of Quincy Police, Brewster Ambulance, Midwest Ambulance, and the Quincy District Court and Norfolk County Sheriff in Procurement, Kidnapping, Trafficking, and Mistaken Identity actions to Prisons playing Emergency Departments and Psych Wards in Boston and the South Shore--have been addressed by me in correspondence with the named parties here and all Hospital parties involved, and will continue to be addressed until fully resolved. Police, Hospital, EMS, and Homeland Security databases in Massachusetts or anywhere else cannot list me as Mentally Ill, Delusional, Acutely Delusional, or Bipolar--which labels have arisen by way of reportage of the Facts on the existence and usage of Anti-Personnel Directed Energy Weapons and Neuroweapons, and by Fraud, as in the case of the December 20, 2022 Multiple Kidnapping and Incarceration Action on false grounds--which I have reported earlier to the Attorney-General's office.

This October--as this whole year, and last year, since in fact May 30, 2024--I have frequently been subjected to lies and false-reports by several of the clearly-paid mercenaries working for Justice, DOD, and the CIA as well as plausibly foreign nations such as China and Israel parked around our house bringing Quincy Police to my door, querying whom has in the past occasionally surfaced CAD Incident Reports revealing such false-report yet blithely recording such atrocities as "WARR/SERV" and "CT ORDR" when there were none, a matter I previously wrote to the Secretary of State about, last November, 2024. All three closest parties living next to our home, the Mazzeos at 150 Pine, Tenants of the Starsiaks--a Police operation at 153 and 151 Pine, and the Chen Limings at 156 Pine have repeatedly summoned Quincy Police on lies, which is profound Defamation and Slander and in fact Domestic Terrorism.

I cannot be repeatedly harassed, threatened, and intimidated by Quincy Police in this fashion.

I cannot be ignored as a journalist either, nor as an Author. My reportage of DARPA-CIA Crimes of Torture, Physical Abuse, Slavery, Slavebinding, Disfigurement, Mutilation, Neighborhood Terrorism in conjunction with Police-run Mental Health Fraud cannot be ignored. My voice cannot be ignored. I cannot be elided from public discourse as if I do not exist. My history of publications cannot be ignored. My history of Teaching and Journalism cannot be ignored. I cannot be written up in police and hospital and health insurance databases fraudulently as "unemployed for 9 years or 10 years or 11 years or 12 years" and "delusional" and "paranoid" and "unable to care for self", as I have been; these are criminal acts of Fraud run by the CIA and their minions living next door to me, the Mazzeos, seeking to Enslave me as a Dungeon Victim for their Sadistic Brain and AI Torture Programs. That atrocity in fact is precisely what is happening and I demand that it be stopped at once.

Yesterday afternoon, when attacked by the Chen Limings, standing on my side-porch, I made a verbal report

immediately to report their crimes of unlawful attack on my body with Radio Frequency High Powered Microwave Weaponry--weaponry that is declassified, that has been reported publicly--and the 2 Chen Liming Attackers and Radio Weapon-Wielders made it a point to suddenly emerge and walk into the field of view of my camera while it was recording and while I was speaking into it, with their 2 under-5 or under-6 kids--a ploy which is being used here in this neighborhood by the Planted Mercenaries Using Children to suggest criminally that I have an interest in recording their kids for nefarious purposes, a means to hide their Radio Torture and Attack Activities here by hiding behind their children; the DOD-CIA and DOJ-CIA have in fact installed people to work full-time in American neighborhoods using radio, electrical and neuro weaponry on their bodies and brains with cover stories flagrant, and a popular one they have used and are using is that of the young couple with very young kids, sometimes babies, being raised at home by the pious stay-at-home couple, to legitimize the perpetual presence of these weapon-wielders, all day, 24/7, at home, working out of basement, ground floor, second floor, attic, back yard, front yard (on My Body and Brain, with weaponry).

Let me also note that in addition to walking directly into my camera field of view, the man, Chen Liming positioned himself to my oblique right while the woman, Ngoan Chen, moved about to my left, both visible primarily because they have once again slashed the tree-foliage at our fence, destroying our privacy screen, with intent it appears to engage in just such visible harassment. Their intent became clearer when I later discovered I had been sharpshot by both with sprayed subdermal nanotech--the expanding syn bio mentioned above--on both cheeks and behind my right ear, causing inordinate swelling and inflammation overnight, disfiguring my face.

I was standing on our own private porch, making a verbal report, I was not speaking to them.

I have a right to verbally report on the crimes committed against me by criminals using radio weapons and neuro weapons. I have a right to use my voice, in private and in public, inside my house and inside my yard. I would also like to make a note here about both the Chen Liming family and the Starsiak-QPD-Tenant families: they have distinguished themselves over the past 3 years with very loud speech, yelling, calling, chatting with their kids and abusively verbally attacking them on the street, in their backyard, and 3 houses over--these are criminal mercenaries who do anything for money, it appears. The various men at the Mazzeo house meanwhile use Their loud voices to shout "You're Crazy!" and "You're fucking crazy!" and other such, when encountering a camera directed at them--while dozens adorn their own property--this is all part of the DARPA-CIA Mental Health Fraud which is seeking to cast ALL "human experimentation subjects", obtained fraudulently and criminally from the FBI as Baseless Watchlistees whom they are unlawfully attacking, torturing, and murdering as Unreliable Reporters, Delusional, and Mentally Ill: this is criminal behavior and should be stopped: Yes, the CIA and DARPA should be stopped at once.

Soon after the man moved back to the middle and back of his yard, the woman came into view and I continued making my report, my camera simply directed at their yard. Had they not cut the leaves overhanging the fence, a wonderful privacy screen would have mutually obscured us from each other's view. As it happened the woman also came to stand beside a child, exposing the child through her shameless activities of radio attack on her neighbor to an environment and moment hardly conducive to the child's content and security in his home neighborhood.

As I made my verbal report, the woman ran and got a cell phone and pointed it at me. I concluded my report and took a few pics of her as well then went inside.

Barely a couple minutes after, a police car came zooming down and parked in front of our house. Clearly this

woman and man had summoned Quincy Police at speed, on whatever lie they had used to call them--they have summoned Quincy Police on lies earlier. The whole of this incident is spelled out further in my letter to my husband below, sent while the police were still here, one and a half hours later, around 6:20 pm--and being further reported with photos for now in Reporter's Note 199 at my website.

Interrupted from my afternoon task of making my lunch--or dinner--and outraged that Quincy Police was once again at my doorstep, ignoring all Notices, Letters, and Privacy Notices I have sent them earlier, responding to false calls from the Radio Weapon Wielding Chen Limings (who had just attacked me with Radio Pulse Weaponry in my Face, Heart, and Knee, impelling my video report) I went upstairs and embarked on other housekeeping tasks, physically attacked further upstairs by the Mazzeos at 150 Pine, also CIA Torture-Bees it appears, sending precision radio blast pulses to my liver area. These two parties, along with the Starsiak tenants at 153 Pine and 151 Pine frequently work together.

Most egregiously, this past month the Mazzeos have collusively worked with Quincy Police to procure and haphazardly fill out a "Harassment Prevention Order" with no information on what kind of harassment, yet using a form of my name on it, and mentioning court hearings in the foreign jurisdiction of the Quincy District Court, thereby running a Smear, Defamation and Slander operation using this form, and spuriously setting up a False History for "Harassment Prevention" when all the Harassment here for 5 years since they moved in here next-door has come from them (extensively reported and Notice'd); I am not the one Harassing anyone on this street, these people engage in all manner of Harassment on a daily basis. Further, there is no name for any of them to use: All forms of my name have been expatriated from Maritime and Admiralty and reconveyed to Land and Soil jurisdiction; this means I do not exist in Maritime or Admiralty jurisdiction but on the Land and Soil of the country of Massachusetts; all should make a note of this.

I am writing because once again I have been cruelly defamed and slandered, directly after being almost pulsed to death. Quincy Police is maintaining an unhealthy, discriminative, and inexplicable alliance with the neighborhood terrorists here who are all working in some way with the CIA and using the Air Force drones, helicopters, low flying planes, and military planes as well to collusively attack me 24/7, literally with all manner of radio frequency technologies, both very high and very low frequency, electrical pulse technologies, radar, nanotechnology, and neurotechnology. I am in fact being used and abused as if I were an inanimate object which can be pointlessly pounded with weaponry of this kind, day after day, night after night, over and over. Well I am not made of modeling clay. I am a living woman who is being abused. My body has come to a point where things have started to break: my shoulders and upper arms and knees are broken, my heart is daily being pulsed and pulverized by these criminals to develop a "heart condition": "Heart Failure" is what the woman, Ngoan Chen, whispered into her microphone and speaker system parked near my kitchen sink two nights ago, a promise apparently, a threat she believes she can casually sling at me--because she can call Quincy Police anytime, on any lie, and have them run Police Terror on me anytime just for her CIA-Affiliated self: all of this is unacceptable. I cannot be attacked, mutilated, and tortured to death by these people or by anyone, using Stealth Weaponry while Quincy Police runs Mental Health Fraud operations on me, and refuses to read and absorb my Letters of Correction and Notice to them.

I have addressed this matter interminably in letters earlier sent to numerous people in local and state government and in Congress. These letters and testimonials can be found posted at my website at Ramola D, Letters and Personal Reports. They spell out the carnage here, over and over.

Please remove all forms of my name from all databases used for watchlisting or other listing purposes.

Please inform Quincy Police they cannot simply roll up on false-report from any of these named mercenaries, which is always false report, and then sit around in front of my house and run Psych Terror Operations on me. Quincy Police cannot keep coming to my house as they have been, frequently, this past month and indeed all of this year. Quincy Police cannot maintain lies and defamations about me in their databases, suggesting I am mentally ill, unemployed, or mentally disabled in any way, shape, or form whatsoever. Quincy Police needs to read my definitive letter on all False Psychiatric Labels placed lawlessly and criminally on medical records affiliated with forms of my name, sent to United Healthcare CEOs. Quincy Police needs to recognize who I am: an Author, Writer, Teacher, Journalist, Artist, Poet, Playwright, Editor, Publisher, Mother, who is keen to get back to her literary and teaching and journalistic and writing life and Family, without attack and interruption from the CIA, DARPA, US Air Force, Police or anyone else.

Please stop the people here in this neighborhood from using radio weapons and neuroweapons on me night and day, trying to kill me--as they killed our cat in March 2024. I cannot be killed, murdered, disfigured and tortured by them, meaning, obviously, I should not be.

Please stop the DARPA-CIA, Air Force, Navy, Army, Marine Corps and other Military, Intelligence, and Justice groups from testing weapons or running their operations of crime hidden in informed consent waivers at the revised Common Rule as "normative activities" of Intelligence and Justice on Americans and on people worldwide. There is No Consent for these criminal activities causing Torture, they are neither normal nor normative, and they should be definitively and comprehensively stopped.

The people in this neighborhood employed and contracted to attack, torture, and kill others using Radio, Radar, Electrical, Nano and Neuro weaponry as well as numerous harassive activities and criminal activities (vandalism, theft, gaslighting are Crimes) need to be removed from here, preferably to a prison block.

If they are permitted to keep on operating here and keep on renewing their unlawful and inhumane contracts on people, corpses--created by them and their deadly radio and electrical neuroweapons--are going to turn up soon. I am afraid none of us will like that.

Hi Paul,

Here to report yet another unwarranted police visit closeby, parking in front of our house despite the fact of our No Parking sign planted on our native plant strip for quite some time--removed last week I suspect by the woman opposite at 153 Pine.

I am going to once more have to report this series of crimes to the Attorney-General and the Secretary of State. The couple next door seem to have both installations and portable devices as do the people in the house behind them, the Mergels. As you know this couple is responsible for the breaking of our furnace, our dishwasher, our oven last year, and have engaged in numerous acts of vandalism, stealing plants, seedlings, both this year and last, and breaking into our house to steal food items, play gaslighting games replacing our silverware with theirs, and numerous other trespasses such as cutting our foliage. They did this again this year, and I have found a lock for the

side-gate to keep them from entering our backyard and attacking the plants.

In any case, this afternoon, I was making dinner and doing some dishes by the sink--directly opposite them--and I was being RF pulsed in the face again with RF HPM, sounded on my sound shield and making me unable to breathe. I was also suddenly hit --Radio Frequency hit--at my right inner knee, on a nerve there. My heart was being attacked with congestive radio frequencies and I moved a small shield over my chest, so I could breathe. These are criminal attacks through-wall with through-wall weaponry. I opened the side door and saw the man there walk toward me and then back to the backyard. Both of them were there with their 2 kids, and after a minute the woman came out as well. I made a verbal report into my camera reporting what had happened. The woman went and got a cell and took some pics or video of me. I completed my report and took a couple pics of her. Then I went inside. I have been reporting these crimes--and reporting ON this weaponry as a science journalist, for quite some time. As a journalist, I am not going to stay silent. None of our police or security agencies have any right to permit such crime, to permit anyone to operate radio and radar, microwave and millimeter wave weapons on anyone inside the USA. As you know I have especially reported on the Air Force weapons-testing operations inside the USA, and written frequently on this subject, including, most recently to the ODNI, the Massachusetts Attorney-General, and the Director of the FBI. I have listened to many reports from Americans reporting identical crimes, and interviewed whistleblowers from the NSA, FBI, CIA, Police, and spoken with many officials in the government about the use of these so-called "Non Lethal Weapons" and "Intermediate Force Technologies" without cause and to great detriment, on many. I believe--as do many human rights advocates like myself--that the use of these weapons in any kind of operation, whether a military testing operation or an Intelligence testing operation or a Police or Fusion Center "deterrence" or "crime prevention" operation should be stopped. I continue to research and report on these operations and have turned my attention to human rights law, which I think could be applied, as could commonsense and diplomacy, to engage people in meaningful conversation and end the use of these weapons inside the USA and indeed in any kind of war situation as well.

Well this lady has called the police it appears--and they have come and parked here for quite some time. They should not be here, and they should not be parking in front of our house, they should not be listening to the reports of the people at 156 Pine, 153 Pine or 150 Pine, all of whom have been working to bring the police here on false reports. I have published the facts on these false reports, and I have written both to the Chief of Police, the City, and to the Attorney-General on this matter.

No one should be supporting the CIA --and other mil/intel groups--in their programs of human subject experimentation on people; as I have reported, these are programs that use Torture and essentially seem to be murdering people. There are published reports--I mean journalistic--of people having been attacked to the death with these programs.

Kindly step forward and let Quincy Police know I am a journalist, and I have the right to speak and publish my reports. In the past, Quincy Police has twice kidnapped me and forced me into a hospital on false reports, for purposes of affixing false psychiatric labels on the Journalist. I have spent about 3 years now addressing the falsity of these labels and publishing openly on this matter. I continue to publish in this space.

When are you coming home? If someone in the Police or FBI has given you a false letter of "notice of investigation" that has been renewed interminably here, know that that is on fraudulent grounds. I have been harassed by Quincy Police and the people practicing Crime here for 3 years now and obviously I should not be. I am looking forward to having Sophie home for her 21st birthday soon. I hope all are doing well and I would like this weird scenario to be

ended as quickly as possible. If you need to, you should send a letter as a lawyer to Quincy Police and the Boston FBI or whoever has kept you out of here, notifying them you are returning home. But you should plan to return home at your earliest instead of letting this drag on, waiting for Them to do something. Be aware many crimes have been committed here--and QPD and the CIA and FBI need to clean up their act.

It is 6:18 pm now and there is a police car here still parked in front of our house. That's criminal defamation and criminal trespass not to mention Threat and intimidation. they have been here for more than one hour. The last time I noticed they were here it was 5:25 pm.

Ok, It is 6:20 pm and they have just moved their car and parked in front of 153 Pine. There are kids playing outside, and it has gotten dark. I will go back to completing my dinner-making (dinner cum lunch) and I am going to write to the Attorney-General and the Secretary of State once more. As a journalist, it is my duty to inform them that radio weaponry is being used unlawfully on people and to request that the people operating them--this neighborhood--be stopped in their projects of Extreme Harm to the people. And myself.

You have the house phone number. Call and leave a message. I will publish this letter shortly to make sure you get it. Thanks--Ramola
