Dear Nicole Crispo, Records Access Officer:

This is a Freedom of Information Act request for all records and reports, email, phone, audio, video, print related to the trespassing by two Quincy Police patrol cars and police drivers into my private space on September 17, 2025, today, between 10:56 am and 11:20 am, when they drove in and parked in front of my family's home, in my private parking space, ignoring my No Parking signs and my Private Property, No Trespassing signs, then proceeded to have a public conversation with one of the many men playing "Joseph Mazzeo" at 150 Pine Street, next door to us--men found guilty of many crimes against me, our home, yard, trees, and foliage, previously reported, over the past 3 years--where they were both overheard conspiring to "Section" myself, freely naming me "Mentally Disabled" and "escalated" in Mental Disability, both matters of Defamation and

Slander and Conspiracy to Deprive me of rights.

The many FOIA requests I have made regarding sudden police car arrivals at my home, summoned by people working nearby--who have been reported previously--who have been using Lies, Fabrications, Creative Storytelling and Mythologies should assure everyone of the unmitigated Crime ongoing on this street, where Lie-Telling apparently scores brownie points with the Police Department. It is inexplicable to me why Quincy Police would keep on and on responding to the lies and false reports from the Mazzeos, the Chen Limings, and the Starsiak tenants all parked nearby with their "Programs" and "Projects" involving "Controlled Equipment" and quotas and funding it seems from Justice, or Israel, or China or just the CIA or some private corporation with a contract with a police or security entity, despite my repeated reportage of the Facts, which are indisputable--because proved.

Today it appears the Mazzeo man of the day told a few lies regarding my watering my garden, which he tried to break in on, stalking me outside while I was watering, then running into his house and calling Quincy Police on a lie. This lie appears to have been building on the lie he--or a pal of his playing himself, their usual MO here--used two weeks ago, regarding a few drops of water falling on his car. The QPD officer standing outside and chatting with him in fact made reference to a "report" made two weeks ago by this man--a Lie Report, which, despite my FOIA request of September 5, 2025, has not been handed to me. The police guy also made a remark of "2 years of reports"--Lies and False Claims, he should have said, but QPD seems to like Lies and holding on to them--and the Mazzeo man waxed eloquent on a made-up "Mental Disability" which has "escalated in recent months", he said. This is a man, note, who is never spoken to by me--given the mayhem conducted by himself and friends--and who was not spoken to today either. Nor did a single drop of water from my watering touch his precious self or his car, as the video recording I made then shows (published at my website, at Reporter's Note 166). The two video recordings I made of these Conversers plotting to cart me off in another pressganged "Section 12" in fact show rather clearly that nothing happened, and that further, the man walking past as I watered my garden and the man running with his puppy to issue forth lies regarding this non-encounter and non-spraying of himself or car are two different men (photos and videos at my website at RN 166). In addition the Mazzeo man made mention of a spouse supposedly working on a divorce from me, mention really again of the Spouse-Impersonator I have previously reported, and on whom a Notice is posted at my site.

I am not sure why the Quincy Police Department is failing to comprehend that I am most emphatically not "mentally disabled" and that they cannot keep coming by here, conspiring to get me fresh Psychiatric Labels and a new stay in some Boston psych ward or asylum--as if they were conspiring to hand my Brain over to Brain Experimenters from the CIA or DARPA or MIT, which they cannot do, that is Criminal.

I would like therefore to report this matter further. It is possible Quincy Police will change their ways once they see it is perfectly obvious--from their own conversation, recorded--they are actually conspiring again to label women Mentally Ill and Mentally Disabled when they are nothing of the sort, False Claims which are Crime. Women who write and report and paint and teach cannot be termed Mentally Disabled; this isn't 1859 and we are not in Nazi Germany either.

Let me also once again make a note here that I am living privately, I am not in Maritime Jurisdiction, I am on Land and Soil, and no one is permitted to park in front of my private home or enter my private front yard and porch or driveway, just as no one is permitted to run around defaming me night and day and call police on lies and false reports and conspire to get me "committed". Thanks very much.

Please therefore send me all reports related to this matter. I am requesting a Media Waiver of fees for photocopying and mailing. All records may be emailed to me in PDF form and sent on as well in a CD or print on paper by mail. .

Dear Nicole Crispo, Records Access Officer.

This is a Freedom of Information Act request for all records, email, phone, audio, video, print related to the apparent visit of two Quincy Police Officers to my private home this afternoon, September 5, 2025, around 4:30 to 4:45 pm. Overheard conversation between one of them and the lying, hostile man parked at 150 Pine Street who doesn't speak to me but who apparently got some water from my garden--watering this afternoon on his car suggests this man was embellishing on this occurrence and making an Event out of nothing whatsoever. No one calls the police on water splashing on their car, they might speak to their neighbor instead. I had no conversation with this man--several men cycle in and out of that house which is listed as being owned by a Joseph and Samantha Mazzeo--and this was a non-event. But how is it that this man, playing Joseph Mazzeo, can frequently call Quincy Police with lies against me and have Quincy Police respond? I believe they were here for about 15 minutes, knocking on my door--which they have no right to do--and shouting, which they also have no right to do.

As I have reported earlier, Quincy Police have physically kidnapped me twice in 2022, on false reports, subjecting me to grievous harm, which I am still addressing. Quincy Police is not permitted to approach me or enter my front yard or step onto

my front walk or climb up my front steps or enter my porch, which has a gate which is locked against all visitors except those I permit. Quincy Police is not permitted either to park in front of my private home nor in my private drive.

May I remind the City of Quincy I am living Privately--please consult the many letters I have sent describing what this means. I am NOT in Maritime Jurisdiction. Quincy Police are NOT my police. Who I am is NONE of their business. They are absolutely FORBIDDEN to come anywhere near me or my house or yard, after their criminal actions of harassment, kidnapping, trafficking and incarceration in sickening schemes of Procurement for Hospitals and Health Insurance and Ambulance services in April and December 2022, and their incredible Harassment Spree all year in 2024 and earlier this spring in 2025--which I have reported extensively on. Notably, Quincy Police has run these operations of Procurement to Procure False Psychiatric Labels for me, so I could become a goose that keeps on giving apparently, a falsely Labeled "Mentally Ill" person they repeatedly have to CHECK up on--in repeated Procurement for Profit activities, to pump up their quotas, and to legitimize their existence and expansion, as their rather gigantic Public Safety HQ building suggests. But I have Corrected this matter in PRINT and on VIDEO and on my WEBSITE: Does Quincy Police not keep tabs on my writing, speaking, and broadcasting online? Why exactly is Quincy Police maintaining lies and false reports about me when I have corrected them, and the City on this matter?

Neither Quincy Police nor The City of Quincy, nor anyone in Quincy is permitted to write lies down against my name as Mentally Ill, needing Well-Being Checks, or a Hospital Visit courtesy themselves. I am a Writer and Journalist who is reporting on Police technologies and Military Weaponry as well as the False Claims of Psychiatry, among other subjects; harassing me in this fashion and trying hard to scuttle my journalism and my Voice with Mental Health Fraud is Communist, KGB-style behavior, which has no place in America or in Massachusetts. There can be no conspiracies to disappear journalists into mental asylums in Massachusetts.

Please send on all reports and records associated with this wrongful police visit this afternoon. I will report the information at my media site and magazine, The Everyday Concerned Citizen. Should there be any fees, I hope you will waive them in light of my work and position in Media, for the benefit of all people. Thank you.

Dear Nicole Crispo, Records Access Officer:

In light of the Freedom of Information Act, I would appreciate if you could kindly provide me all records relating to the unexpected visit of two strange men driving a large black, seemingly camouflage Quincy Police vehicle--parked further down the street--and coming up to my private home and knocking on the mailbox as well as coming round to my private drive and looking up at my house with apparent interest in seeking entry or "contact" with me, at 2:45 pm, directly after I was outside cutting hydrangeas in front and watering our plants and cherry tree. I live in a neighborhood invaded by military-Intelligence-fusion-center-police-foreign-Brain Experimenting mercenaries, as you may know, since I have reported this matter before. The CIA has, it seems, been permitted lawlessly to run Black Operations in my neighborhood, and so has Israel and China it seems, and a bunch of criminals from the Quincy District Court/Quincy Police Department parked opposite us and using Through-Wall Millimeter Wave ADT or Active Denial Technologies, Radio Frequency High Powered Microwave, and Nanosecond Electric Pulse Generator technologies lawlessly and abusively on my person, a matter I have been reporting widely for 3 years now, since they moved in here--while changing out frequently, different men and women occupying that house but driving similar vehicles and behaving similarly harassively--in June 2021.

Part of the Modus Operandi of all of these collusively-acting mercenaries is to make false accusations and call the police department, making false claims. I have seen this played out several times, and I have spent quite some time writing to various officials in efforts to have these parties halt their crimes of social, neighborhood, and life harassment on me. I am an author, writer, playwright, teacher, mother, artist, poet, actor, and journalist--and I cannot be characterized as anything else by anybody at any time. Apparently I cannot spend 5 or 10 minutes gardening in my yard in front without these nasty, lying, abusive mercenaries running out to Quincy Police with some lie to summon them here. I could not have been in the front yard for longer than 10 minutes. While I was standing by my cherry tree, I noticed a woman opposite at 153 Pine, a Breanne Starsiak tenant pointing a phone at me, two kids beside her. I continued and completed my watering. Later, probably 5 minutes later, I was on my porch, still watering on the other side and picking up my mail, when the woman next

door, previously known as Ngoan Chen--a Mrs. Chen Liming I presume, from the House Owner name--came out on her porch and pointed a cell phone at me from her door. I recorded this on my cell. I have no idea why she did that, perhaps it was to record the head-scarf I was wearing, which I am compelled to wear around her since she and her husband as well as Joseph and Samantha Mazzeo and their many guests from 150 Pine on the other side have become notorious here for their pressure-spraying of nasty nanotechnology on my face, causing facial inflammation, painful swelling, lumps in fact and large flaps and pouches--which as you can imagine I am not a fan of. Plus, I am a Broadcast Journalist, in addition to being a print reporter and writer, and I am afraid it would frighten my audience, to see me inflamed and puffed-up like that (for poisons do that). Wearing a scarf filled with shielding to protect my face from Facial Pressure Spraying has become my lot in life, forced to cover my head like a Woman in Burkah on my quick trips outside to put the trash out or wheel the cans back to the side or fill the birdbath with water. I guess being outside for 10 minutes was just too much for the Sprayers and the Pulsers and Whackers with RF HPM here, they "called the police." Note, this large black van and the two men clad in blue shirts that I saw took off directly after they knocked on my mailbox and received no answer--proving they had made a special visit from Sea Street or perhaps that new edifice titled "Public Safety Headquarters" primarily to "check on" me, apparently. Was it a "Well-being check" perhaps? Well, how dare they come here for a "CHECK"!

May I remind the City of Quincy I am living Privately--please consult the many letters I have sent describing what this means. I am NOT in Maritime Jurisdiction. Quincy Police are NOT my police. Who I am is NONE of their business. They are absolutely FORBIDDEN to come anywhere near me or my house or yard, after their criminal actions of harassment, kidnapping, trafficking and incarceration in sickening schemes of Procurement for Hospitals and Health Insurance and Ambulance services in April and December 2022, and their incredible Harassment Spree all year in 2024 and earlier this spring in 2025--which I have reported extensively on. But I have Corrected this matter in PRINT and on VIDEO and on my WEBSITE: Does Quincy Police not keep tabs on my writing, speaking, and broadcasting online? Why exactly is Quincy Police maintaining lies and false reports about me when I have corrected them, and the City on this matter?

I am afraid I am going to have to report Quincy Police--and their many minions parked here--for the Criminal Acts of Procurement for Hospital and Health Insurance and Ambulance profits they have previously engaged in, for their continuing actions of Provocation Parking--which I have previously queried the City of Quincy on, receiving no answer--and for their Repeat Defamation Campaigns here against me, in actions of Select Discrimination. Please provide all records related to this visit--camouflage or plainclothes or not, Police Officers or "Community Police" need to announce themselves as such, and have no business responding to false summons, false claims, and maintaining continuous Defamation here of this writer through such ready response to criminals, completely ignoring my own letters to them, to the Secretary of State, to the Mayor and City Council, and to the Office of the City Clerk--so I can be informed on why exactly I am being treated in this manner, and what I can do about it, to make it stop--for no one should be thus targeted, attacked, and mistreated. Over and Over, I may add.

All information will be reported in the Press to all members of the reading and viewing public. As such, I request a media waiver for photocopying or PDF'ing and would be glad to receive all emails, texts, phone calls, audio/video print records and reports related--especially all communications related to those who called in to Quincy Police to summon those men to my door unlawfully. This cannot keep happening, it is CRIMINAL.
